Friis Formula

Friis transmission formula: $Pd = (Pout \cdot G) / (4 \cdot \pi \cdot R^2)$

Where

Pd = power density in mW/cm²

Pout = output power to antenna in mW

G = gain of antenna in linear scale

Pi = 3.1416

R = distance between observation point and center of the radiator in cm

Pd is the limit of MPE, 1 mW/cm². If we know the maximum gain of the antenna and the total power input to the antenna, through the calculation, we will know the distance r where the MPE limit is reached.

The distancer (4th column) calculated from the Fries transmission formula is far greater than 80 cm separation requirement.

So the limit of Band 929 - 930MHz= $929/1500 = 0.6193\text{mW/cm}^2$;

930 - 931 MHz= $930/1500 = 0.6200\text{mW/cm}^2$;

931 - 932MHz= $931/1500 = 0.6207\text{mW/cm}^2$;

932 - 935MHz= $932/1500 = 0.6213\text{mW/cm}^2$;

935 - 940MHz= $935/1500 = 0.6233\text{mW/cm}^2$;

940 - 941MHz= $940/1500 = 0.6267\text{mW/cm}^2$;

The EUT can be transmitted simultaneously with 6 band, so the MPE = $0.0988/0.6193 + 0.0988/0.6200 + 0.0988/0.6207 + 0.0988/0.6213 + 0.0988/0.6233 + 0.0988/0.6267 = 0.9529 < 1$.

To satisfy RF exposure requirements, a separation distance of 80 cm or more should be maintained between this device and persons during device operation. To ensure compliance, operations at closer than this distance is not recommended.
