I have a few comments on this Application.

- 1. Please note that while a request for confidentiality letter was mentioned in the cover letter provided, a request for confidentiality listing the specific exhibits to be held confidential does not appear to have been actually provided. In order to hold exhibits confidential once they are on the FCC server a letter requesting confidentiality for specific exhibits must be provided. As this is a base station certain exhibits can be held confidential but a request letter for these exhibits must be provided by Ericsson. The following exhibits may be confidential: Theory of operation, Schematics, Parts list, Tune up procedure, Installation manual, internal photos, Block diagrams. All other exhibits are not confidential material. Please provide a confidentiality request letter for those items above which you desire to be held confidential.
- 2. Please note that the external photos include some of the internal photos. Please note that while internal photos of this system may be confidential, external photos of the system may not. Please provide an external photo exhibit of the system that do not include the internal photos (the photos shown on pages 10 and 11 of the EMC report may be sufficient for external photos).
- 3. Please note that the FCC ID label shows the self declaration label for a Class B device for Home or Office Use. Please note that this system does not fall under the self declaration approach of part 15 for Home or Office Use and the EMC report provided shows the device to be only 3dB under that Class A limit. As this device is only 3dB under the Class A limit and because it does not meet the Class B limit, please remove the DoC label information from the label.
- 4. Please note that for licensed devices a parts list of the active parts is required. Please provide the parts list for this device.
- 5. Please note that as yet I have not received the manual disk. Please provide at least the FCC regulatory pages of the manual. As the manual is said to be over 20Meg in file size the rest can be presented as available upon request.
- 6. Please note that the spurious emission of section 4.5 on page 25 of report "030925-721.pdf" appear to be radiated field strength measurements. Please note that part 24 licensed device radiated spurious emission are antenna substitution power measurements. Please explain (i.e. is the purpose of this report strictly for part 15?).
