Dear Sir or Madam:

Qualcomm, Inc. Wireless Infrastructure Division was purchased by Ericsson Wireless Communications, Inc. effective May 24, 1999. I was Qualcomm's infrastructure regulatory manager and I have transferred to Ericsson. We are requesting a change in the FCC ID for the former Qualcomm 800MHz and 1900MHz base stations and pilot beacons. The 3 character prefix is being changed from J9C (Qualcomm) to OJY (Ericsson).

This request is for FCC ID OJYKAG4, an 1900MHz 3 Sector compact cellular base station. The design of the base stations and pilot beacons are unchanged. In addition, the manufacturing location, equipment, processes, and personal remain unchanged. However, we will be changing the branding, trade dress, and model numbers to Ericsson's corporate standards.
