TEST PROCEDURE

GENERAL: This report shall NOT be reproduced except in full without the written approval of TIMCO ENGINEERING, INC.

RADIATION INTERFERENCE: The test procedure used was ANSI standard C63.4-2003 using a spectrum analyzer with a pre-selector. The bandwidth of the spectrum analyzer was 100 kHz with an appropriate sweep speed. The analyzer was calibrated in dB above a microvolt at the output of the antenna. The resolution bandwidth was 100 kHz and the video bandwidth was 300 kHz. The ambient temperature of the UUT was 80°C with a humidity of 76%.

FORMULA OF CONVERSION FACTORS: The Field Strength at 3m was established by adding the meter reading of the spectrum analyzer (which is set to read in units of dBuV) to the antenna correction factor supplied by the antenna manufacturer. The antenna correction factors are stated in terms of dB. The gain of the Pre-selector was accounted for in the Spectrum Analyzer Meter Reading.

Example:

Freq (MHz) METER READING + ACF = FS
33 20 dBuV + 10.36 dB = 30.36 dBuV/m @ 3m

ANSI STANDARD C63.4-2003 10.1.7 MEASUREMENT PROCEDURES: The unit under test was placed on a table 80 cm high and with dimensions of 1m by 1.5m. The table used for radiated measurements is capable of continuous rotation.

When an emission was found, the table was rotated to produce the maximum signal strength. At this point, the antenna was raised and lowered from 1m to 4m. The antenna was placed in both the horizontal and vertical planes.

SAMPLE CALCULATION: FSdBuV/m = MR (dBuV) + ACFdB.

All measurements below 30 MHz were taken using an EMC Test Systems Passive Loop Antenna.

TEST PROCEDURE: The procedure used was ANSI standard C63.4-2003. The spectrum was scanned from 30 MHz to 1000 MHz. When an emission was found, the table was rotated to produce the maximum signal strength. A Loop Antenna was used for measurements below 30 MHz. The antenna was placed in both the horizontal and vertical planes and the worse case emissions were reported. The UUT was tested in 3 orthogonal planes.

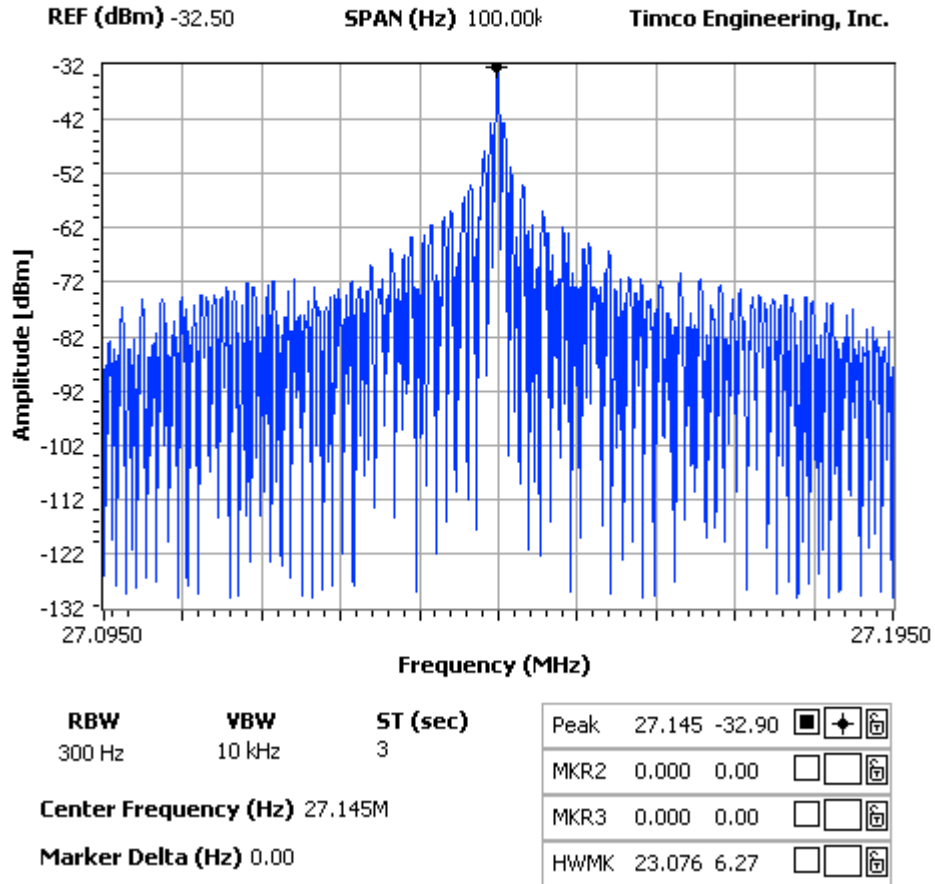
