5. Do not use this apparatus near water

Do not use the product near water and noisture, for example: near a bathtub, washbowl, kithen sink or laundry tub; in a wet basement; or near a swimming pool.

6. Clean only with dry cloth


18. Object and liquid entry

POWER SOURCE

- 1. Insert the plug from the supplied AC/DC Adapter to the DC IN Jack on top of the unit.
- 2. Insert the AC Plug from the supplied AC/DC Adapter to the wall outlet with AC 100-240V~; 50/60Hz.





INSTALLATION

1. Placing on the table


When placing the Sound Bar on an entertainment center, bookshelf, or any type of enclosed space, be sure to allow at least 2-3 inches of space around the Sound Bar for ventilation. If the Sound Bar is enclosed in a tight space, without ventilation, heat generated from the Sound Bar could produce a potential heat hazard.



2. Mounting the Speaker Bar onto a wall


We recommend having this speaker professionally mounted. By using the included wall mounting accessories, the sound bar can be mounted onto a wall.

Mounting to a wall


2.1 Mounting to a wooden wall



2 pieces screws (Included)

- A. Mark the position of the mounting screws on the wall using a pencil.
- B. Drill the supplied screws directly into the marks that you have made on the wall and leave approx. 0.3 inch length to hook the sound bar.
- C. Put the sound bar onto the mounting screws. Make sure they are firm and stable.


2.2 Mounting to a brick wall




- A. Mark the position of the mounting screws on the wall using a pencil.
- B. Drill 2 holes on wall with a powerful electric drill.
- C. Insert the supplied fixing plug and hammer into the holes.
- D. Secure the supplied screws into the fixing plugs and leave approx. 0.3 inch length to hook the sound bar.
- E. Put the sound bar onto the mounting screws. Make sure they are firm and stable.





BATTERIES INSTALLATION (REMOTE CONTROL)

FIRST TIME USE

- •Remove and discard the insulation tab as figure on the right.
- •Replacing Batteries For Remote Control
- 1. Push and slide out the battery holder as figure 1 below.
- 2. Replace the battery with a new CR2025 button cell as the polarity markings on the rear of the Remote Control.
- 3. Close the battery holder.





BATTERY PRECAUTIONS

Follow these precautions when using a battery in this device:

- 1. Use only the size and type of battery specified.
- 2. Be sure to follow the correct polarity when installing the battery as indicated in the battery compartment, a reserved battery may cause damage to the device.
- 3. Do not mix different types of batteries together (e.g. Alkaline and Carbon-zinc) or old batteries with fresh ones.
- 4. If the batteries in the device are consumed or the device is not to be used for a long period of time, remove the batteries to prevent damage or injury from possible leakage.
- 5. Do not try to recharge the battery not intended to be recharged; it can overheat and rupture. (Follow battery manufacturer's instructions.)
- 6. The batteries shall not be exposed to excessive heat such as sunshine, fire or the like.
- 7. Clean the battery contacts and also those of the device prior to battery installation.
- 8. The remote control supplied with a coin/button cell battery. If the coin button cell battery is swallowed, it can cause severe internal burns in just 2 hours and can lead to death. Keep new and used battery away from children. If the Battery compartment does not close securely, stop using the product and keep it away from children. 

EFFECTIVE DISTANCE OF REMOTE TRANSMITTER



• When direct sunlight, an incandescent lamp, fluorescent lamp or any other strong light shines on the REMOTE SENSOR of the unit, the operation of the remote may be unstable.

GENERAL OPERATIONS

- Connect the AC/DC adapter to the unit and wall outlet. The red indicator will light but unit is OFF and in standby mode. Press and hold the POWER/SOURCE button to turn on the unit.
- 2. Press the POWER/SOURCE button on the unit or the SOURCE button on the Remote Control repeatedly to switch to Bluetooth, OPTICAL IN, AUX IN 1 or AUX IN 2 mode. The color of the indicator will turn to correspondent with your selection (see list below).

Blue	Bluetooth
Indigo	OPTICAL IN
Violet	AUX IN 1
Orange	AUX IN 2

- 3. During Playback
 - ~ Press the VOL (Volume) + or buttons on the unit or Remote Control to adjust volume level as desired.
 - ~ Press the **⋈**(Mute) button on the Remote Control to turn off the sound. Press again to resume.
- 4. When finished listening, press and hold the POWER/SOURCE button on the unit or press the $\ ^{\circ}$ button on the Remote Control to power OFF the unit and put in standby mode.

BLUETOOTH PAIRING AND PLAYBACK

Bluetooth

In first time use or re-pairing to new BT Device, pairing the unit to the external BT Device as follows:

- 1. Power on the unit as previous procedures.
- 2. Press the POWER/SOURCE Button on unit or press the SOURCE Button on remote control repeatedly until the indicator turns Blue and blinks.
- Power on the external BT Device and enter to searching mode. Start pairing as the on screen instructions on the external BT Device. After paired, the indicator will stop blinking.

(For details pairing procedures, please refer to the user's manual of your BT Device.)

Notes:

When the external BT device searched the unit, our model "CHT981O" will appear on the display of external BT device.


Normal operation after paired:

- 1. Power on the unit and select the playback source to BT as previous procedures.
- 2. Turn on the BT function of the external BT Device.
- 3. Wait a few seconds until the unit paied to the external BT device automatically. The indicator will stop blinking.
- 4. Play the music in the paired BT Device as usual.
- 5. During playback:

 - Press the ►II (Play/Pause) button on the unit or Remote Control to pause.
 Press again to resume normal playback.


CONNECTION THROUGH OPTICAL

 Connect the Optical out jack from the external audio Player (such like TV, DVD Player,BD Player ...etc.) to the OPTICAL IN jack on the unit by the Optical Connection cable (not supplied) as the figure below: (For PCM format only)



Optical Connection Cable (not supplied)


- 2. Power on the unit as previous procedures.
- 3. Press the POWER/SOURCE button on the unit or press the SOURCE button on the Remote Control repeatedly until the color of the Indicator turns to Indigo.
- 4. Power on the connected external player and start playback the Music as usual. Turn on the digital audio output and set it to PCM (Plus Code Modulation) type similar to the follows figure:



AUX IN 1: LISTEN TO EXTERNAL AUDIO DEVICES

An external (Auxiliary) audio source (ie.,mobile phone, personal CD player or MP3 player) can be connected to this unit and heard through the speakers.

- 1. Plug one end of the Aux In cable into Aux In 1 jack of unit.
- 2. Plug the other end of the Aux In cable into headphone or line out socket of the external audio source.




- 3. Power on the unit as previously explained.
- 4. Press the POWER/SOURCE button on the unit or press the SOURCE button on the Remote Control repeatedly until the color of the Indicator turns to **Violet**.
- 5. Power on the connected external player and start playback as usual.

AUX IN 2: LISTEN TO TV/DVD/VCR/DVR

An external Video/Audio player (such as TV, DVD player, VCR, etc.) can be connected to this unit and heard through the speakers.

- 1. Plug one side of RCA White and Red cable (included) into the AUX IN 2 jacks on the top of unit.
- 2. Plug the other side of cable into Audio Out R & L jacks of the TV or external device as the illustration below.

NOTE: Make sure to connect to AUDIO OUT. If you connect it into AUDIO IN of external device, you will not hear the sound.



- 3. Power ON the unit as previously explained.
- 4. Press the POWER/SOURCE button on the unit or press the SOURCE button on the Remote Control repeatedly until the color of Indicator turns to Orange.
- 5. Power ON the connected external player and start playback as usual.
