## 1. RF EXPOSURE

### 1.1.The Requirement

### 1.3.MPE Calculation Method

Predication of MPE limit at a given distance
Equation from page 18 of OET Bulletin 65, Edition 97-01

\mathrm{S}=\mathrm{PG} / 4 \pi \mathrm{R}^{2}

Where: $S=$ power density
$\mathrm{P}=$ power input to antenna
$\mathrm{G}=$ power gain of the antenna in the direction of interest relative to an isotropic radiator
$\mathrm{R}=$ distance to the center of radiation of the antenna

From the peak EUT RF output power, the minimum mobile separation distance, $\mathrm{d}=0.2 \mathrm{~m}$, as well as the gain of the antenna is 0 dBi , the RF power density can be obtained.
