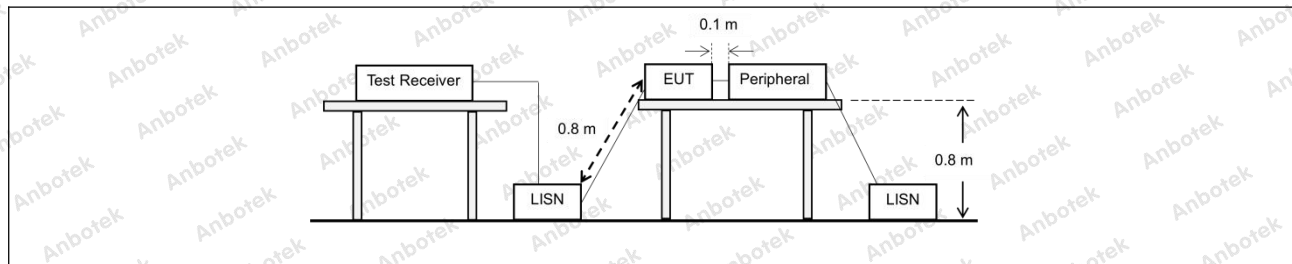

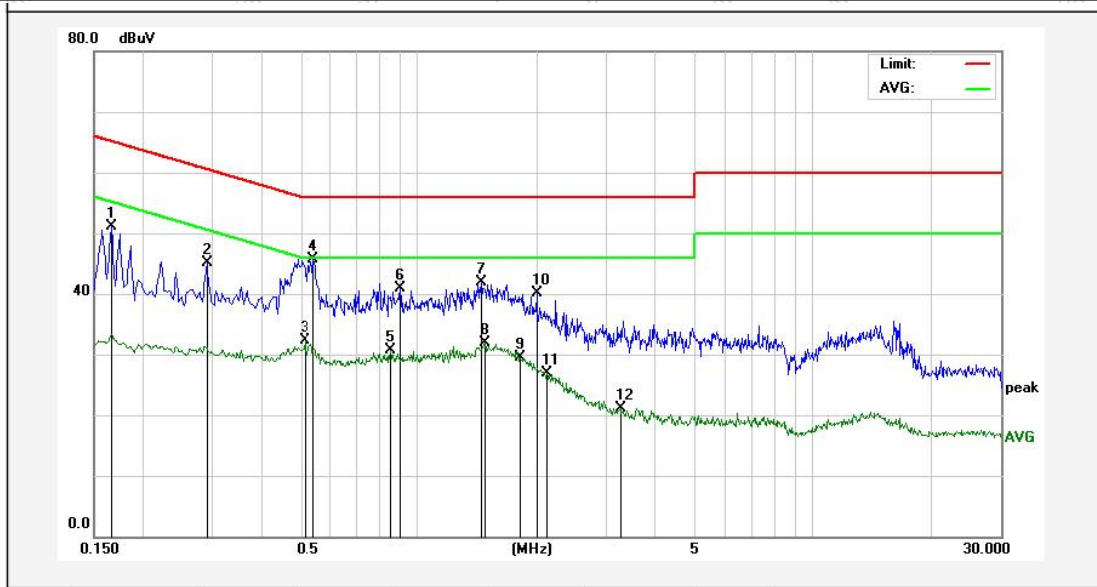

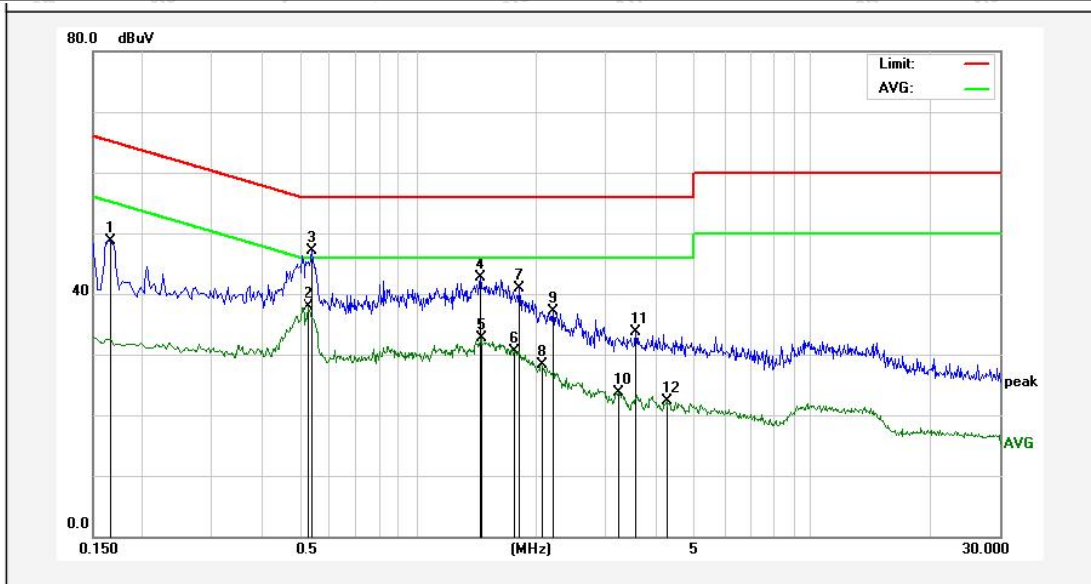

4. Occupied Bandwidth

Test Requirement:	47 CFR 15.215(c)

The frequency span for the spectrum analyzer shall be between 1.5 times and 5.0 times the OBW.
