


Short-press the "SYNC" button on the receiver, then the "SYNC" icon illuminates and the channel number flashes



Turn on the transmitter, put transmitter IR window close to receiver IR window. The sync operation is complete when the channel number stops flashing and RF signal indicator remains lit.


