3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4 and FCC CFR 47 Part 15 Subpart C.

3.1 EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

3.2 EUT EXERCISE

The calibrated antennas used to sample the radiated field strength are mounted on a non-conductive, motorized antenna mast 10 meters from the leading edge of the turntable.

3.3 GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4-1992. Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-Peak detector mode.

Radiated Emissions

The EUT is a placed on as turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.

5.2 EQUIPMENT

Radiated emissions are measured with one or more of the following types of linearly polarized antennas: tuned dipole, biconical, log periodic, bi-log, and/or ridged waveguide, horn. Spectrum analyzers with preselectors and quasi-peak detectors are used to perform radiated measurements.

Conducted emissions are measured with Line Impedance Stabilization Networks and EMI Test Receivers.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.

All receiving equipment conforms to CISPR Publication 16-1, "Radio Interference Measuring Apparatus and Measurement Methods."

5.3 LABORATORY ACCREDITATIONS AND LISTINGS

The test facilities used to perform radiated and conducted emissions tests are accredited by National Voluntary Laboratory Accreditation Program for the specific scope of accreditation under Lab Code: 200617-0 to perform Electromagnetic Interference tests according to FCC PART 15 AND CISPR 22/EN 55022 requirements. 

- 2. Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.
- 3. Set the spectrum analyzer as RBW=10kHz, VBW = RBW, Span = 200kHz, Sweep = auto.
- 4. Mark the peak frequency and 26dB (upper and lower) frequency.
- 5. Repeat until all the rest channels are investigated.



7.2 RADIATED EMISSIONS

LIMIT




Test Configuration

- 2. The turntable was rotated for 360 degrees to determine the position of maximum emission level.
- 3. EUT was set at 3m away from the receiving antenna, which was varied from 1m to 4m to find out the highest emissions.
- 4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 5. And also, each emission was maximized by changing the polarization of receiving antenna, both horizontal and vertical.
- 6. Repeated above procedures until the measurements for all frequencies are completed.
