#### 1 General Information

#### 1.1 General Description

The equipment under test (EUT) is a transceiver for TVG Swing Zone Sports Motion. It operates at  $2404 MHz \sim 2481 MHz$  and the oscillation of MCU is generated by a crystal. The EUT is powered by 4 x 1.5V AA size batteries. There are a synchronization button and an ON/OFF button on the console unit. When the console unit is synchronized with the controller, the player can play the sport games.

The antenna terminal is permanently attached in EUT and the radio output power is unable to adjust.

The brief circuit description is listed as follows:

- SPRF2402 and associated circuit act as a transceiver.
- SPAC400 and associated circuit act as a video console processor.

### 2 Description of the radiated emission test

#### 2.1 Test Procedure

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 - 2003.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5m x 1m and 0.8m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

For below 30MHz, a loop antenna with its vertical plane is placed 3m from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. And the centre of the loop shall be 1 m above the ground.

The device was rotated through three orthogonal axes to determine which attitude and configuration produce the highest emission during measurement.

#### 2.2 Test Result

Both Average and Peak Detector data were measured unless otherwise stated.

"#" means emissions appearing within the restricted bands shall follow the requirement of section 15.205.

The frequencies from fundamental up to the tenth harmonics were investigated. The emissions which lower than the radiated ambiance were not reported. Thus, those highest emissions were presented in next pages.

It was found that the EUT meet the FCC requirement.
