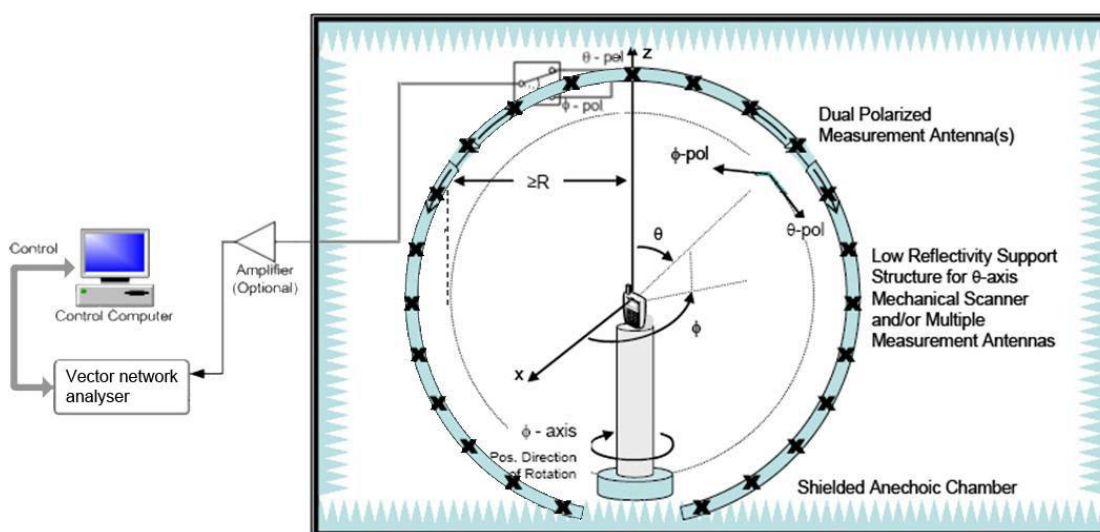

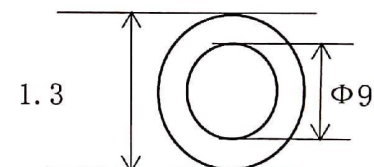

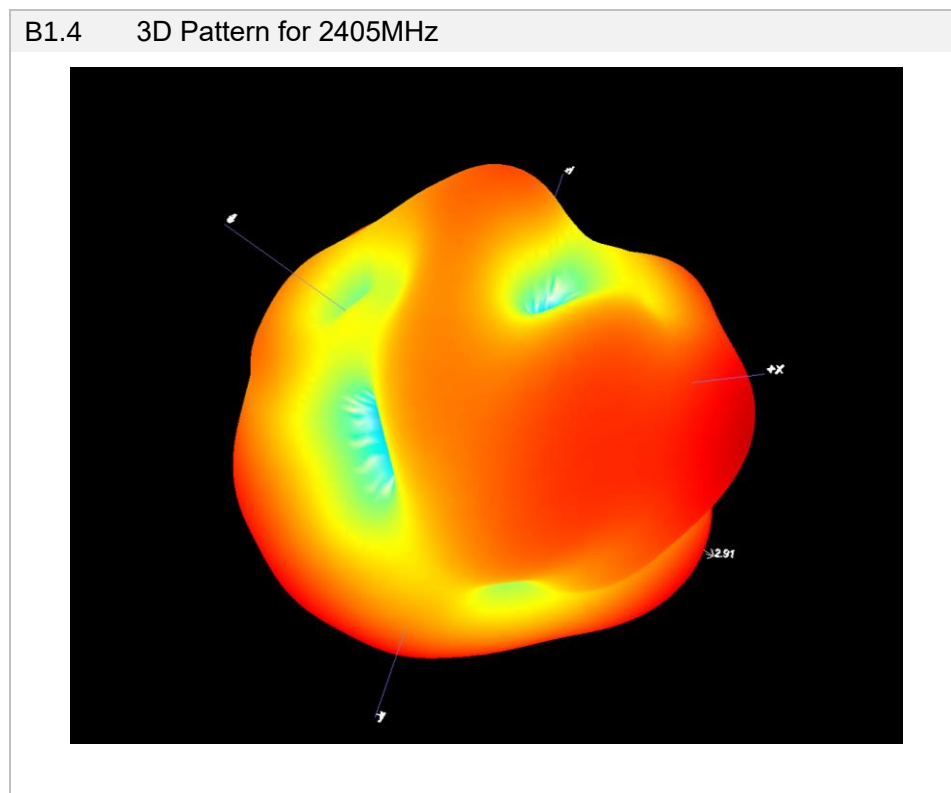

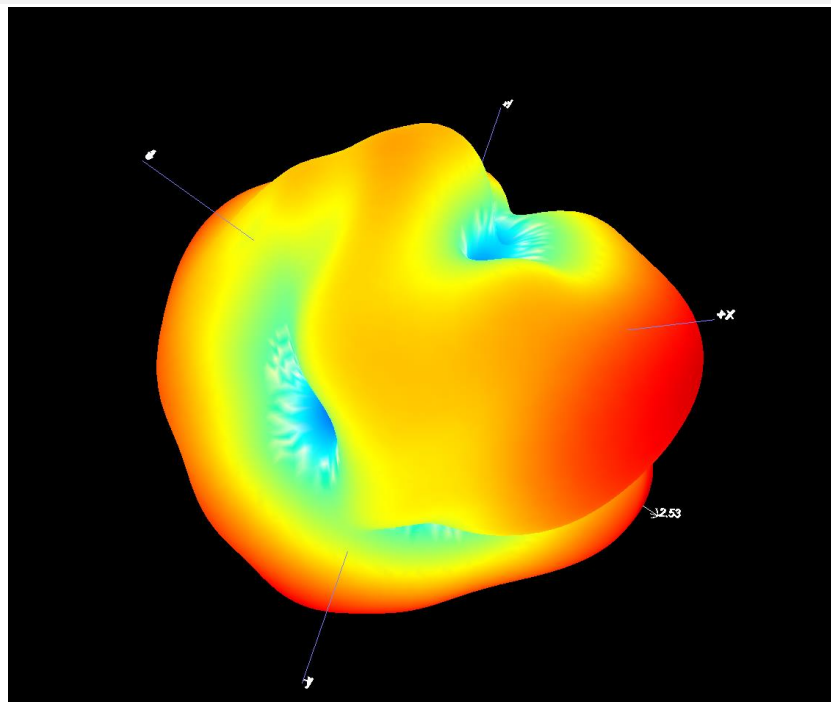

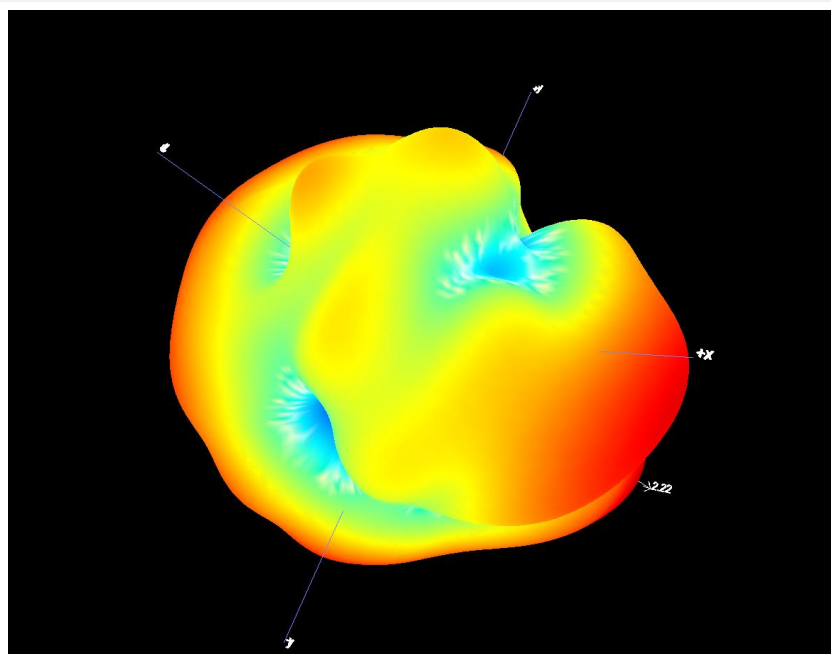

B1.5 3D Pattern for 2442MHz

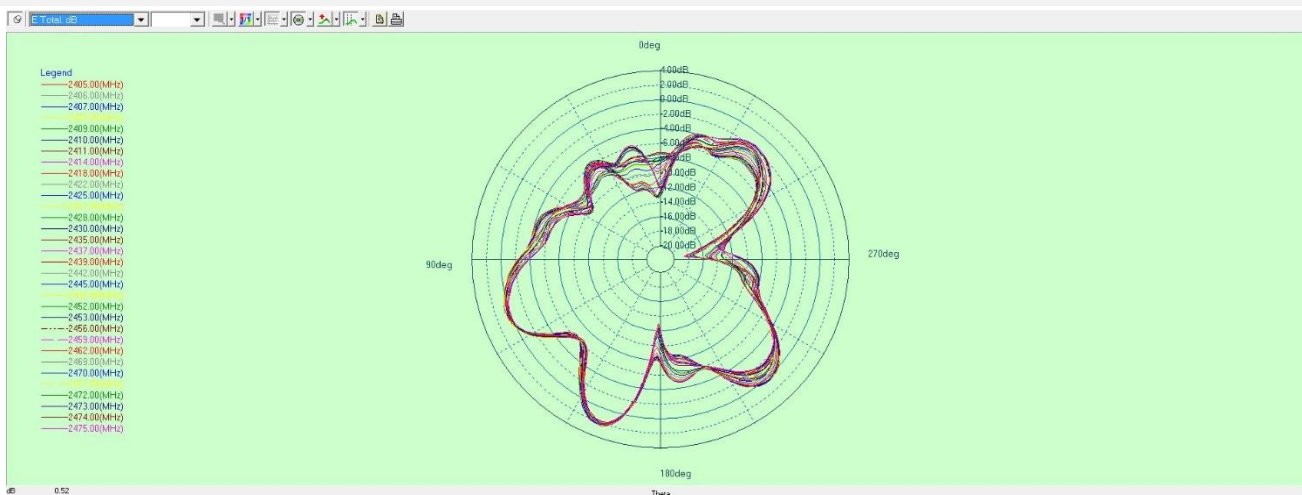


B1.6 3D Pattern for 2475MHz

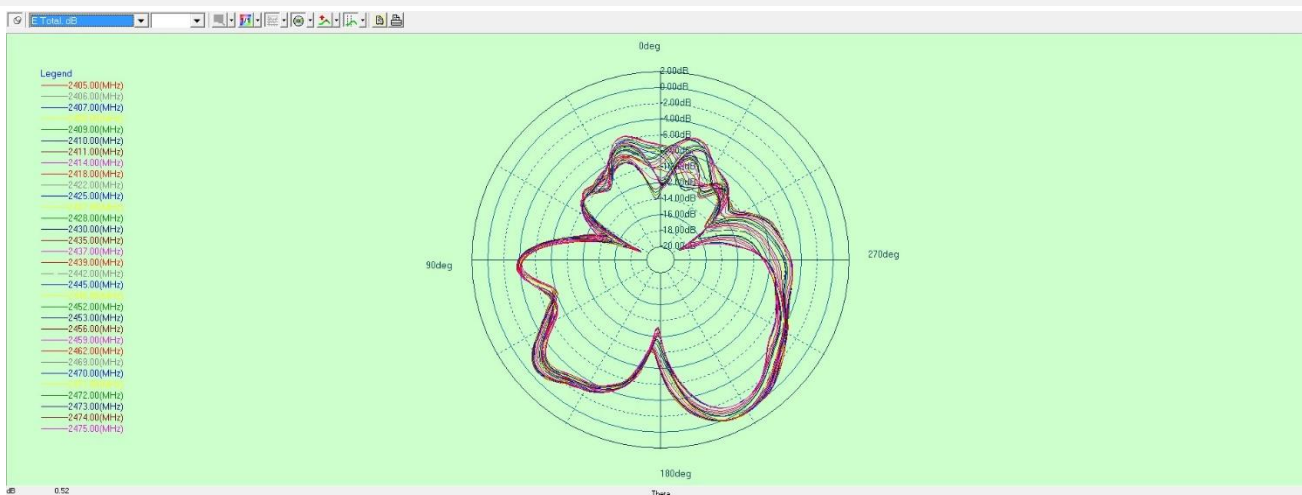


B.2 1D Radiation Pattern 2# (EUT 2)

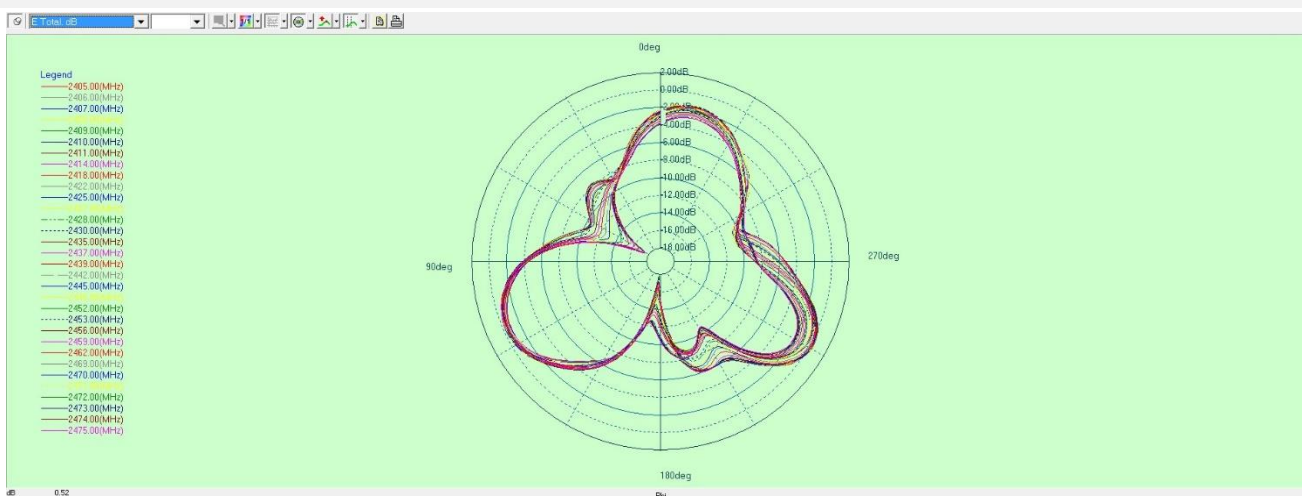

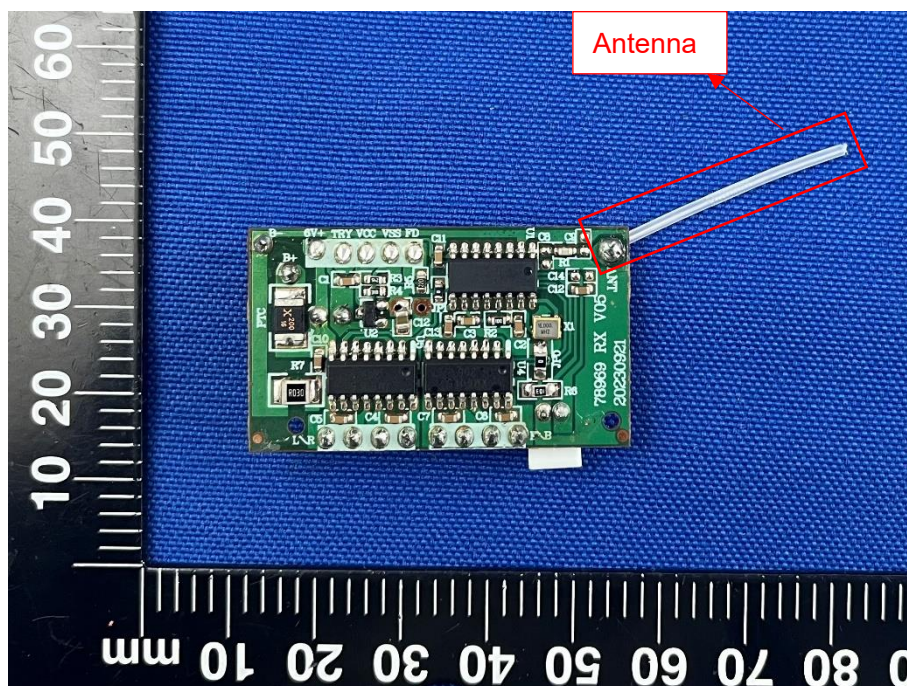
