

1.0 General Description

1.1 Product Description

The Equipment Under Test (EUT) is a transmitter of a RC system, which is operating at 49.860MHz as dictated by a crystal. The EUT is powered by 9V DC source (1 x 9.0V Block size battery). The EUT has a on/off switch, a left / right control lever and a forward / backward control lever.

After switching ON the EUT and the corresponding car (ie. Receiver), activating the control key on the EUT can control the car moving forward, backward, left and right.

The Model: 041519, 208636, 134691 and 166618 are the same as the Model: 5F62780 in hardware aspect. The difference in model number serves as marketing strategy. The models are different in model number only.

Antenna Type: External / Telescope-type antenna (with unique antenna connector)

1.2 Related Submittal(s) Grants

The Certification procedure of receiver (with FCC ID: OTM-62780-49MRX) for this transmitter (with FCC ID: OTM-62780-49MTX) is being processed as the same time of this application.

1.3 Test Methodology

Radiated emission measurements was performed according to the procedures in ANSI C63.4 (2009). All radiated measurements were performed in an Open Area Test Site. Preliminary scans were performed in the Open Area Test Site only to determine worst case modes. All radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application.

1.4 Test Facility

The open area test site facility used to collect the radiated data is located at Garment Centre, 576 Castle Peak Road, Kowloon, Hong Kong. This test facility and site measurement data have been placed on file with the FCC.

2.0 **System Test Configuration**

2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.4 (2009).

The device was powered by new 1 x 9V Block size battery.

For maximizing emissions, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. This step by step procedure for maximizing emissions led to the data reported in Exhibit 3.0.

The unit was operated standalone and placed in the center of the turntable.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was mounted to a plastic stand if necessary and placed on the wooden turntable, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

2.2 EUT Exercising Software

There was no special software to exercise the device. Once the unit is powered up, it transmits the RF signal continuously.

2.3 Special Accessories

There are no special accessories necessary for compliance of this product.

2.4 Measurement Uncertainty

When determining of the test conclusion, the Measurement Uncertainty of test has been considered.

3.0 Emission Results

Data is included of the worst case configuration (the configuration which resulted in the highest emission levels). A sample calculation, configuration photographs and data tables of the emissions are included.

3.1 Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any), Average Factor (optional) from the measured reading. The basic equation with a sample calculation is as follows:

FS = RA + AF + CF - AG - AV

where $FS = Field Strength in dB\mu V/m$

RA = Receiver Amplitude (including preamplifier) in dBµV

CF = Cable Attenuation Factor in dB

AF = Antenna Factor in dB AG = Amplifier Gain in dB AV = Average Factor in dB

In the following table(s), the reading shown on the data table reflects the preamplifier gain. An example for the calculations in the following table is as follows:

FS = RR + LF

where $FS = Field Strength in dB\mu V/m$

 $RR = RA - AG - AV \text{ in } dB\mu V$

LF = CF + AF in dB

Assume a receiver reading of 52.0 dB μ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB are added. The amplifier gain of 29 dB and average factor of 5 dB are subtracted, giving a field strength of 32 dB μ V/m. This value in dB μ V/m was converted to its corresponding level in μ V/m.

 $RA = 52.0 dB\mu V/m$

AF = 7.4 dB $RR = 18.0 \text{ dB}\mu\text{V}$ CF = 1.6 dB LF = 9.0 dB

CF = 1.6 dB AG = 29.0 dB

AV = 5.0 dB

FS = RR + LF

 $FS = 18 + 9 = 27 \, dB\mu V/m$

Level in μ V/m = Common Antilogarithm [(27 dB μ V/m)/20] = 22.4 μ V/m




8.0 Miscellaneous Information

The miscellaneous information includes details of the test procedure and measured bandwidth / calculation of factor such as pulse desensitization and averaging factor.

8.1 Measured Bandwidth

The plot shows the fundamental emission is confined in the specified band. The field strength of any emission appearing between the band edges and up to 10kHz above and below the band edges (49.81 and 49.91 MHz) is at least 26 dB below the carrier level. And at 49.81 & 49.91 MHz, there are at least 43.26 dB below the carrier level. It meets requirement of Section 15.235(b).

8.2 Discussion of Pulse Desensitization

Pulse desensitivity is not applicable for this device. The effective period (Teff) is approximately 350µs for a digital "1" bit which illustrated on technical specification, with a resolution bandwidth (3dB) of 100kHz, so the pulse desensitivity factor is 0dB.

8.3 Calculation of Average Factor

It is not necessary to apply average factor as the measured (peak) data has been complied with average limit of the radiated emission.

8.4 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services Hong Kong Ltd. in the measurements of transmitter operating under the Part 15, Subpart C rules.

The transmitting equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately one meter in height above the ground plane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjusted through all three orthogonal axis to obtain maximum emission levels. The antenna height and polarization are also varied during the testing to search for maximum signal levels. The height of the antenna is varied from one to four meters.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings. A detailed description for the calculation of the average factor can be found in Exhibit 8.3.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower.

8.4 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements were made as described in ANSI C63.4 (2009).

The IF bandwidth used for measurement of radiated signal strength was 100 kHz or greater when frequency is below 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. A discussion of whether pulse desensitivity is applicable to this unit is included in this report (See Exhibit 8.1). Above 1000 MHz, a resolution bandwidth of 1 MHz is used.

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the forbidden bands and above 1 GHz, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, unless otherwise reported. Measurements taken at a closer distance are so marked.
