



- Do not overcharge the battery pack. Do not charge for more than 6 hours 2 Do not charge the battery pack if it shows leakage, corrosion, or has loose or 3. exposed wires or other damage
- Do not cover the battery pack with any sort of materials while charging
- Do not touch the battery pack when it is hot. Wait until the battery pack cools 5. before installing it in the Vehicle and before recharging
- 6. Do not dispose of the battery in fire
- 7. Do not dismantle the battery or charger, and do not cut the battery or charger cables
- 8. The battery pack will be warm after charging, and hot after use in a vehicle
- 9 The supply terminals are not to be short-circuited
- 10. Rechargeable batteries are to be removed from the toy before being charged
- 11. Rechargeable batteries are only to be charged by adult.
- 12. Battery replacement must be only made by adults
- 13. The transformer (charger) is not a toy

# **Battery Installation**

### For Vehicle (Fig. 1 and Fig. 2)

- Switch OFF the power Unscrew the screw on the battery cover 2
- 3. Open the battery cover
- 4.
- Install 6.4V battery pack with correct polarities (+/-) as shown inside the battery compartment
- Close the battery cover 5
- Tighten the screw on the battery cover 6.






- intended to be correctly orientated in a vertical or floor mount position. This charger is intended to be used for charging 6.4V lithium rechargeable battery pack with capacity 1300mAh Max. It cannot be used for charging non-rechargeable batteries. Regular examination of battery charger for any damage to their cord, plug, enclosure and other parts, and that, in the event of such damage, it must not be used with the charger or battery pack charge until such damage has been repaired. Note that the 9V battery is non-rechargeable and is not to be recharged. Only batteries of the same or equivalent type as recommended are to be used. It will need replacement when transmission is poor
- 15. Exhausted batteries are to be removed from the product.

### Charging the Rechargeable Battery Pack for the Vehicle:

- Connect the 6.4V lithium rechargeable battery pack to the battery charger 1
- 2. Plug the charger into the standard AC socket
- 3. The charging time for a full charge is about 3 hours
- When charging is completed, unplug the charger from the AC socket 4.
- 5. Disconnect the rechargeable battery pack form the battery charger

### For Transmitter (Fig. 3 and Fig. 4)

- Unscrew the screw on the battery cover 1.
- Open the battery cover
- Install 1 new 9V battery with correct polarity (+/-) as shown inside the battery 3 compartment
  - Close the battery cover
  - Tighten the screw on the battery cover 5



### 1. Turn on the Vehicle.



- 2. Keep pulling the trigger of the Transmitter forward then turn the Transmitter on. Do not release the trigger until the binding process completed.
- 3. The LED light of the Transmitter will keep flashing for the binding process, which is within 8 seconds. Do not turn off any buttons while in progress, otherwise, the process will be terminated.
- 4. After the wheels of the Vehicle turn left and right and the LED light of the Transmitter stops flashing, the binding process completed for playing.
- If it cannot complete within 8 seconds, please turn off both Vehicle and Transmitter and re-start the binding process.
   When the binding process is done, whenever switching the Vehicle and Transmitter on and off, it searches for the code that it memorized, and will only lock on to
- the Transmitter signal containing that code. 7. Please turn off both Vehicle and Transmitter and re-start all binding process if changing to another 2.4GHz Transmitter for playing.

### How To Play

1. Switch ON the Vehicle and Transmitter.




2. Use the Steering Wheel to control the Vehicle turning left or right

- 4. If the vehicle does not run in straight line, adjust the Direction Adjustment on the Vehicle chassis
- Play on smooth surface to have the optimum performance
- Remember to switch OFF the power of the Vehicle and
- Transmitter after playing
- 7. The optimum control range is up to 30m outdoor

## **How To Fill In Water For Smoking Effect**

1. Fill in clear water into water container.



2. Open the cap of water tank on the vehicle. (Fig.5 and Fig.6)





3. Fill in clear water to vehicle by using the provided water container. (Fig.7)




4. Close the cap firmly. (Fig.8)

## How To Change To The Drifting Wheels

- Unscrew the screws on the wheels of the vehicle
- 2. Remove the screws and the wheels from the vehicle.
- Install the drifting wheels on the vehicle. 3
- Tighten the screws on the wheels. 4.

Note: Changing wheels needs to be processed or supervised by the adult.

- Performance Tips
  1. Do not drive on grass, dirt, sand, dusts, carpet or go through water.

- Do not drive in winds, can sand, values, cape of go through water. Avoid direct impact the Vehicle with obstacles. Switch OFF the power when not in use to prevent damage of Vehicle and Transmitter due to leakage of electrolyte from batteries. Remove all batteries from the Vehicle and Transmitter when not in use for long period. 4
- 5
- Keep fingers, hair and loose clothing away from wheels. The operating range can be affected by a variety of factors a) Low Voltage of batteries in Transmitter or Vehicle b) Interference from other items that emit radio frequency signals.
- Outdoor usage is recommended in order to get optimum control range. Recommend to play the vehicle on a clean and smooth surface.
- Clean the battery compartment to make sure it is free from dust to prevent poor 10. contact of batteries
