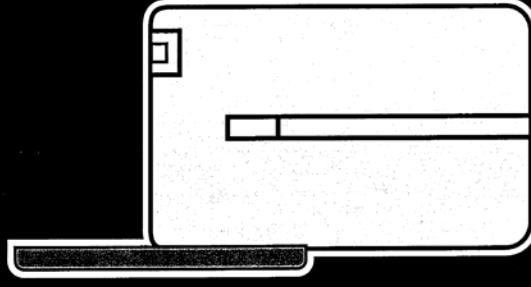

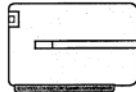


### PRODUCT DESCRIPTION ///

The Shell HomeGenie™ Power Switch allows users to remotely turn power on and off to most devices up to 1600 watts that can be plugged into standard power outlets.

### LOCAL OPERATION ///

The Shell HomeGenie™ Power Switch allows local and remote access to the device. You can turn the device on and off as well as view the current state of the Power Switch.

1. Each time the TEST button is pressed, it will cycle power (on/off) to the device connected to the Power Switch.
2. When power is 'ON' the LED indicator will be lit red, otherwise the LED indicator will be off.

### WARNING:

This device is intended for indoor use only. Do not enclose or cover this device. Use in a well-ventilated, open area. Do not use this device at temperatures higher than 104° F (40° C). Do not use in wet or damp conditions. Do not use this product with any electrical device that exceeds the maximum rating as stated in the Technical Specs section of this manual.
