#### 3.4 Uncertainty

Spurious Emission (Radiated)

The measurement uncertainty (with a 95% confidence level) for this test using Biconical antenna is  $\pm 4.59$ dB(3m)/ $\pm 4.58$ dB(10m).

The measurement uncertainty (with a 95% confidence level) for this test using Logperiodic antenna is  $\pm 4.62 dB(3m)/\pm 4.60 dB(10m)$ .

The measurement uncertainty (with a 95% confidence level) for this test using Horn antenna is  $\pm 5.27$ dB. The data listed in this test report has enough margin, more than the site margin.

Other test except Conducted Emission and Spurious Emission (Radiated)

The measurement uncertainty (with a 95% confidence level) for this test is  $\pm 3.0$ dB.

#### SECTION 5: Radiated emission (Fundamental and Spurious Emission and -26dB Bandwidth)

#### **Test Procedure**

The Radiated Electric Field Strength intensity has been measured on No.1 and No.2 semi anechoic chamber with a ground plane and at a distance of 3m.

Frequency : From 9kHz to 30MHz at distance 3m

The EUT was rotated a full revolution in order to obtain the maximum value of the electric field intensity. The measurements were performed for each antenna angle 0deg., 45deg. and 90deg.

Frequency : From 30MHz to 1GHz at distance 3m

The measuring antenna height varied between 1 and 4m and EUT was rotated a full revolution in order to obtain the maximum value of the electric field intensity.

The measurements were performed for both vertical and horizontal antenna polarization.
