- DCPx,y,z: DCP are numerical linearization parameters assessed based on the data of power sweep with CW signal (no uncertainty required). DCP does not depend on frequency nor media.
- Ax,y,z; Bx,y,z; Cx,y,z, VRx,y,z: A, B, C are numerical linearization parameters assessed based on the data of
 power sweep for specific modulation signal. The parameters do not depend on frequency nor media. VR is the
 maximum calibration range expressed in RMS voltage across the diode.
- ConvF and Boundary Effect Parameters: Assessed in flat phantom using E-field (or Temperature Transfer Standard for f ≤ 800 MHz) and inside waveguide using analytical field distributions based on power measurements for f > 800 MHz. 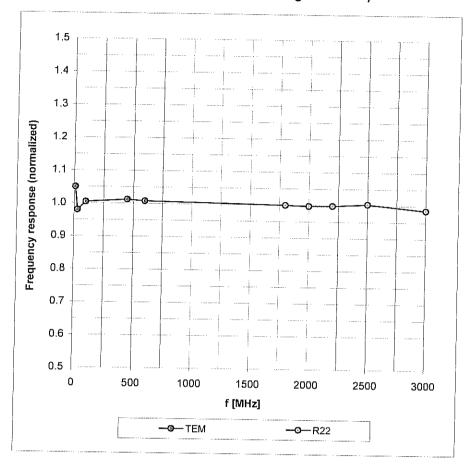

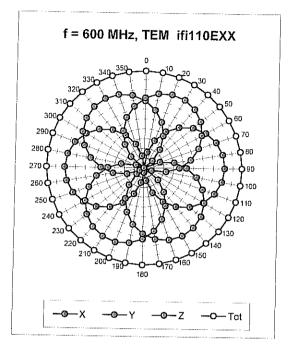

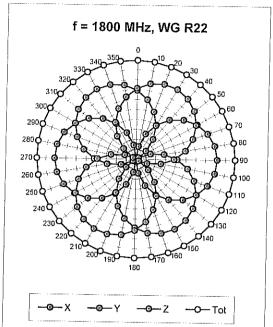


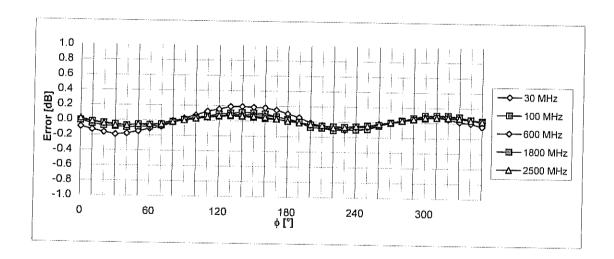
Uncertainty of Frequency Response of E-field: \pm 6.3% (k=2)

Receiving Pattern (ϕ), $\vartheta = 0^{\circ}$





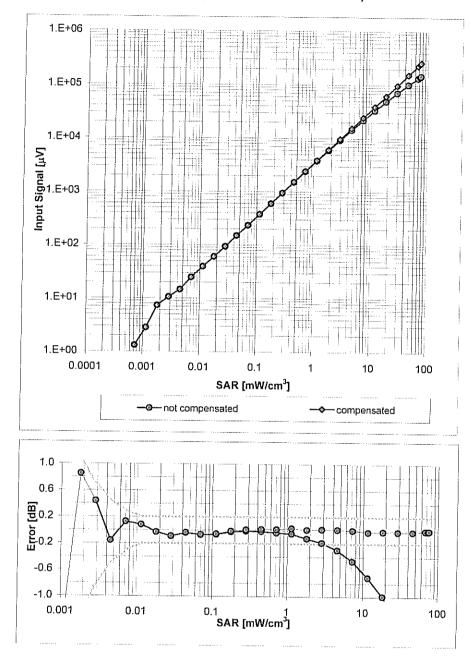


Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)

Dynamic Range f(SAR_{head})

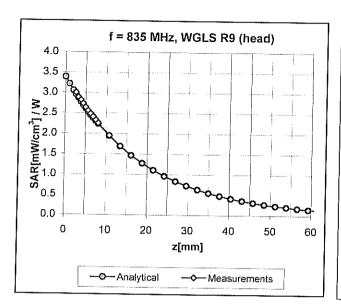

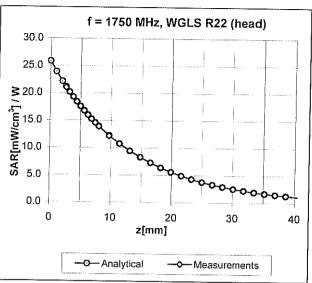


Uncertainty of Linearity Assessment: ± 0.6% (k=2)

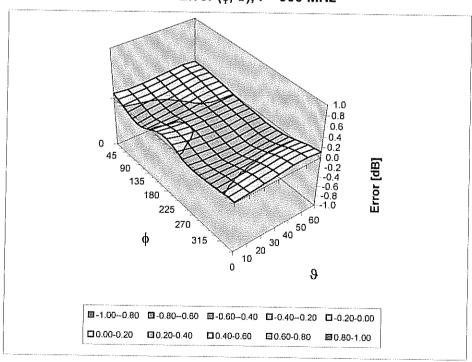
Conversion Factor Assessment



Frequency Response of E-Field (TEM-Cell:ifi110 EXX, Waveguide: R22)




Uncertainty of Frequency Response of E-field: ± 6.3% (k=2)










Uncertainty of Axial Isotropy Assessment: ± 0.5% (k=2)


Dynamic Range f(SAR_{head}) (TEM cell , f = 900 MHz)






Uncertainty of Linearity Assessment: ± 0.6% (k=2)
