2. TEST METHODOLOGY

The tests documented in this report were performed in accordance with TIA-603-C, FCC CFR 47 Part 2, FCC CFR 47 Part 22, FCC CFR Part 24, FCC Part 27, RSS-132 Issue 2, RSS-133 Issue 4 and RSS-139 Issue 2.

3. FACILITIES AND ACCREDITATION

The test sites and measurement facilities used to collect data are located at 47173 Benicia Street, Fremont, California, USA.

4. CALIBRATION AND UNCERTAINTY

4.1. MEASURING INSTRUMENT CALIBRATION

The measuring equipment utilized to perform the tests documented in this report has been calibrated in accordance with the manufacturer's recommendations, and is traceable to recognized national standards.

4.2. SAMPLE CALCULATION

Where relevant, the following sample calculation is provided:

Field Strength (dBuV/m) = Measured Voltage (dBuV) + Antenna Factor (dB/m) + Cable Loss (dB) – Preamp Gain (dB)

36.5 dBuV + 18.7 dB/m + 0.6 dB - 26.9 dB = 28.9 dBuV/m

5.3. SOFTWARE AND FIRMWARE

5.4. WORST-CASE CONFIGURATION AND MODE

The worst-case is, EUT with highest emissions. To determine the worst-case, the EUT was investigated for X, Y, and Z-Positions in both slide in and out condition, and the worst case among the above positions with AC/DC adapter. After the investigations, the worst-position was turned out to be a slide out Z-position with AC adapter, a slide out X-position adapter with out AC adapter and a slide out X-position with AC adapter for Cell, AWS, and PCS bands respectively.







CELL SPURIOUS & HARMONIC (ERP)






