CCS has performed sample testing on above device.

The max. ERP and EIRP measured by CCS are :

Part 22 / ERP: 25.4 dBm
Part 24 / EIRP :25.8 dBm

Attached please find ERP/EIRP measurement result.

The measurement made by CCS are within +/-3 dB ERP/EIRP tolerance allowed.

Based upon measurement result, I am requesting the Commission to put this application in audit mode so TCB can make necessary changes on the ERP/EIRP output power based upon statement made by the applicant.

I suggest that you test a sample of the device to confirm that the output power was indeed incorrect due to operator/testing errors. You can use this one sample test as part of the 2% that a TCB is required to test during the yearly operations.

After you confirm that the output power is indeed incorrect, submit this test report to the Commission along with the original request to place this application into the audit mode. At that time, we will be happy to assist you in making the necessary corrections.
