

Take out the POS terminal, the battery, the power adapter, and other necessary parts from the packing box, then follow the steps below for quick installation.


1 Install and remove the lithium battery:

Install the battery:

- ① Open the battery cover;
- ②Insert the plug side of the battery into the battery socket.
- ③ Put the battery into the battery container
- 4 Close the battery cover

## Remove the battery:

- ① Open the battery cover after power-off
- ② Slightly pull up the battery for a certain height to remove the battery



## 2 Install the SIM/ SAM (PSAM) card:

- ① Open the SIM/SAM card cover on the right side of the terminal;
- ②Follow the silkscreen indication and place each of the needed SIM/ SAM card separately into the right slot following the direction as the picture showed.

SIM/ SAM card can not paste stickers, tags, or other materials that may change the thickness of the card in order to prevent non-smooth installation or disassembly.

#### 3 Communication connection

When using GPRS to communicate, please insert the SIM card into the SIM card slot located on the right side of the terminal. When using Bluetooth to communicate, please turn on the Bluetooth module on the smart mobile terminal such as a smartphone or tablet, and search for the Micropayment POS terminal around to match.

# **Usage and Operation**

Power on / Power off:

Press and hold the on/off key for a few seconds, the device should be turned on or off.

Magnetic stripe card operation:

When operating a transaction with a magnetic stripe card, please set the track of the magnetic stripe on the card toward the device and swipe smoothly along with the track of the magnetic reader on the device.

### Contact IC card operation:

IC card reader is located on the bottom of the device. When operating a transaction with contact IC card, please hold the side of the IC card that is without the chip, and flat insert the card, the chip side should face up, into the card reader. During the transaction, the IC card should be kept in the card slot.

## Contactless IC card operation:

The IC card should be close to the center of the contactless sensing area, and stay for approximately 1 second. Do not remove the IC card until the transaction is successfully accepted.
