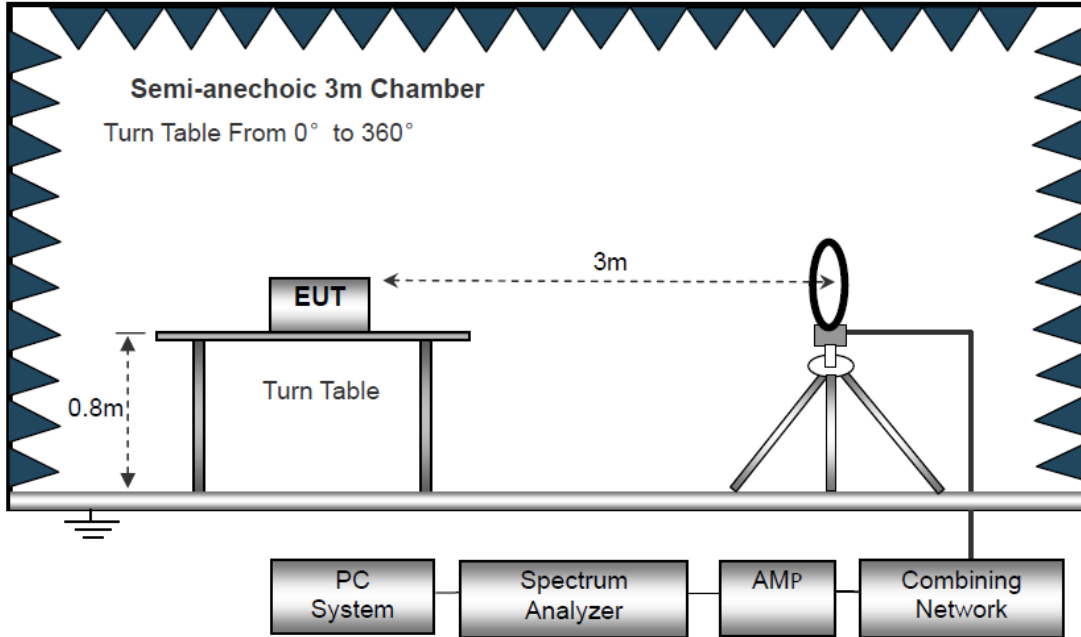

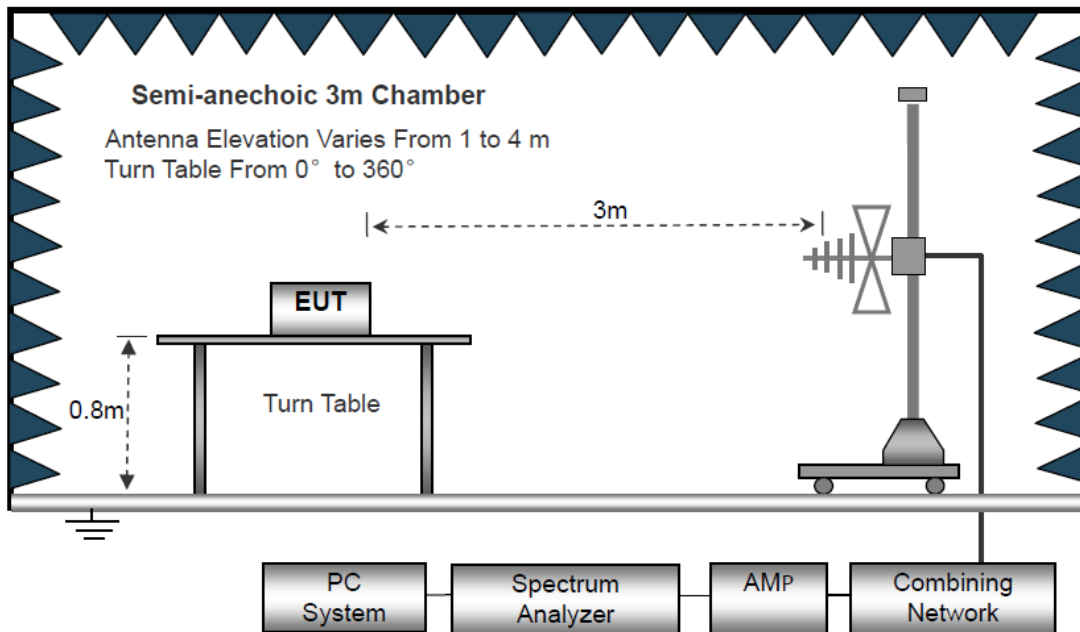

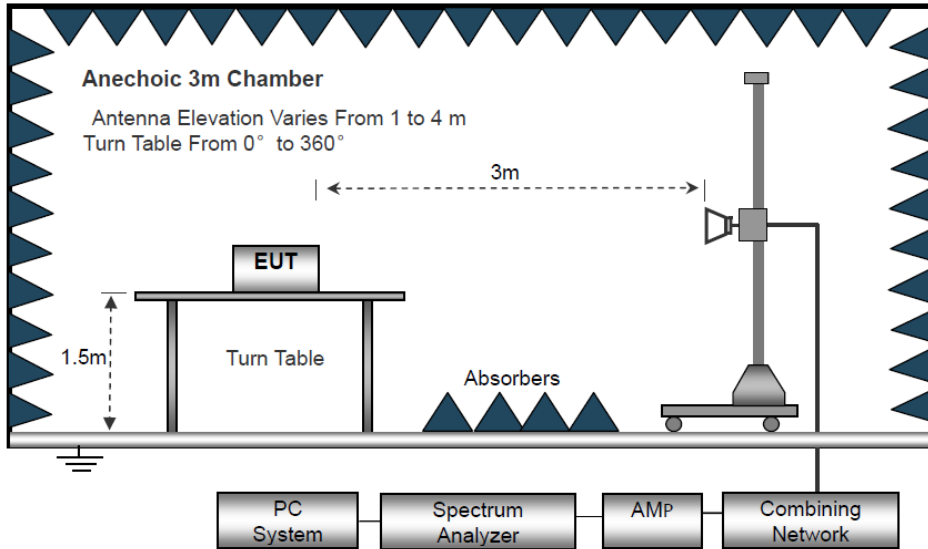
The test setup for emission measurement below 30MHz

## 6.4 Test Procedure

1. Below 1000MHz, The EUT was placed on a turn table which is 0.8m above ground plane, And above 1000MHz, The EUT was placed on a styrofoam table which is 1.5m above ground plane.
2. The turntable shall be rotated for 360 degrees to determine the position of maximum emission level.
3. EUT is set 3m away from the receiving antenna, which is moved from 1m to 4m to find out the maximum emissions. The spectrum was investigated from the lowest radio frequency signal generated in the device, without going below 9 kHz, up to the tenth harmonic of the highest fundamental frequency or to 40 GHz, whichever is lower.
4. Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
5. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical.
6. Repeat above procedures until the measurements for all frequencies are complete.
7. The radiation measurements are tested under 3-axes(X,Y,Z) position(X denotes lying on the table, Y denotes side stand and Z denotes vertical stand), After pre-test, It was found that the worse radiation emission was get at the X position. So the data shown was the X position only.
8. The test above 1GHz must be use the fully anechoic room, and the test below 1GHz use the half anechoic room

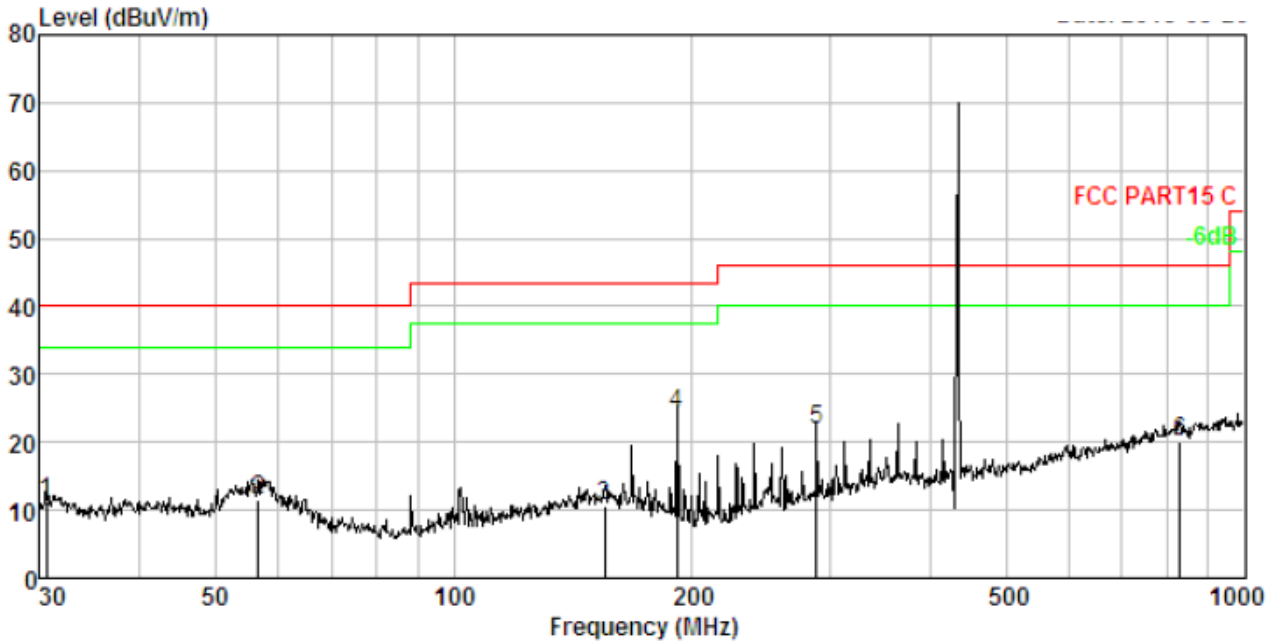

Antenna Polarization: Horizontal



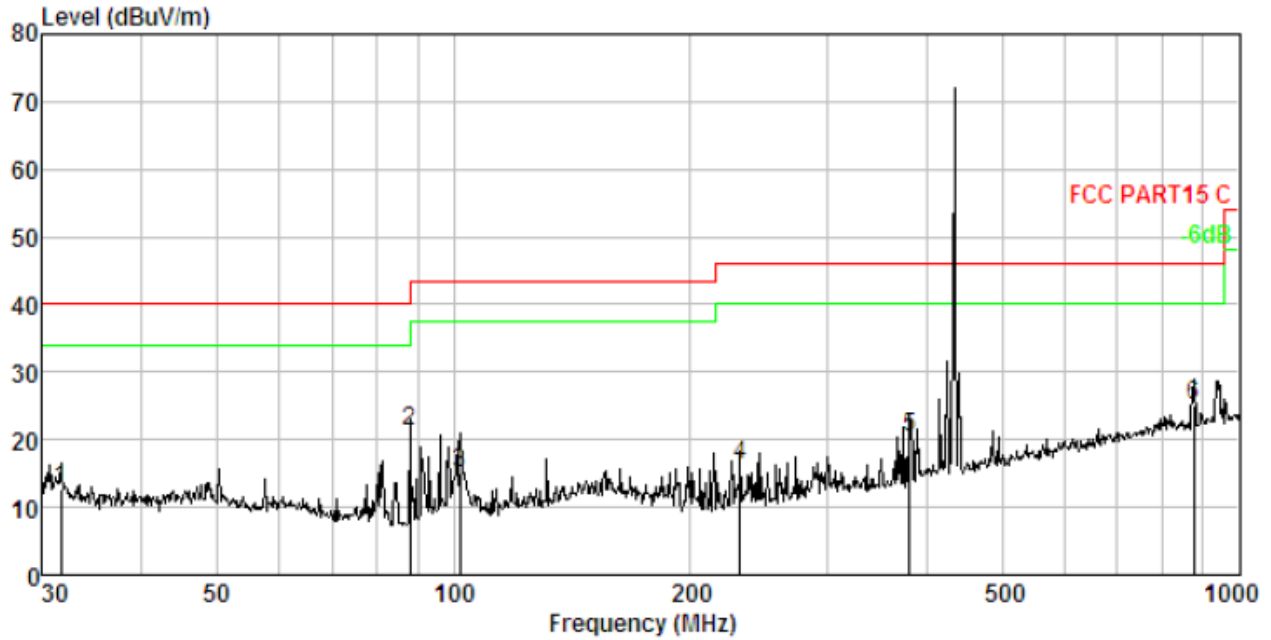

## 7 OCCUPIED BANDWIDTH

### 7.1 Applicable Standard

According to FCC Part 2.1049 and part 15.231(c)

### 7.2 Conformance Limit

The bandwidth of the emission shall be no wider than 0.25% of the center frequency for devices operating above 70 MHz and below 900 MHz. For devices operating above 900 MHz, the emission shall be no wider than 0.5% of the center frequency. Bandwidth is determined at the points 20 dB down from the modulated carrier.

### 7.3 Test Procedure

The EUT was operating in transmit mode and controlled its channel. Printed out the test result from the spectrum by hard copy function.

The RF output of EUT was connected to the spectrum analyzer by RF cable and attenuator. The path loss was compensated to the results for each measurement.

Set to the maximum power setting and enable the EUT transmit continuously

Set RBW = 1% occupied bandwidth (30KHz).

Set the video bandwidth (VBW) =100KHz.

Set Span= approximately 2 to 3 times the occupied bandwidth

Set Detector = Peak.

Set Trace mode = max hold.

Set Sweep = auto couple.

The EUT should be transmitting at its maximum data rate. Allow the trace to stabilize. Use the marker-to-peak function to set the marker to the peak of the emission. Use the marker-delta function to measure 99% down one side of the emission. Reset the markerdelta function, and move the marker to the other side of the emission, until it is (as close as possible to) even with the reference marker level. The marker-delta reading at this point is the 99% bandwidth of the emission.

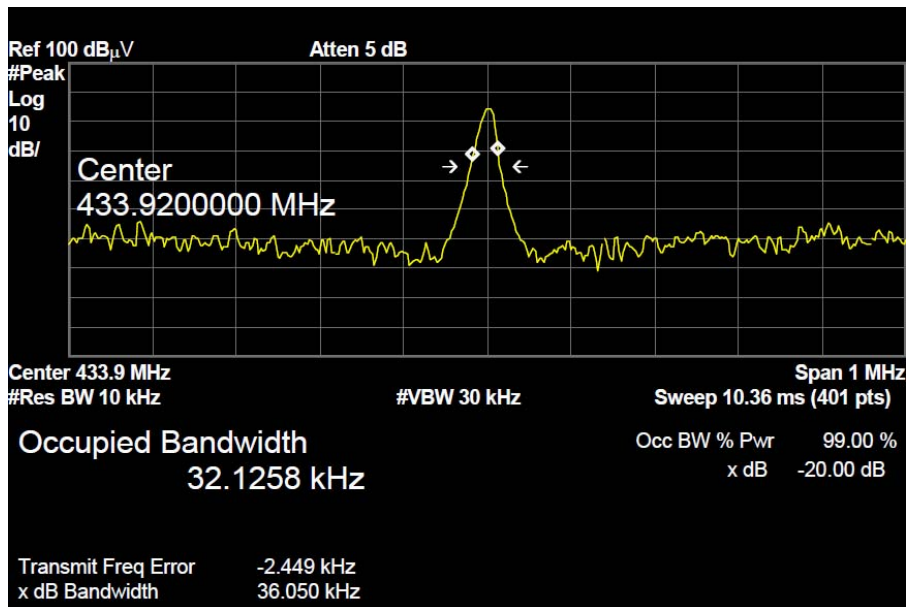
If this value varies with different modes of operation (e.g., data rate, modulation format, etc.), repeat this test for each variation.

Measure and record the results in the test report.

### 8.1 Applicable Standard

According to FCC Part 15.231.

### 8.2 Conformance Limit

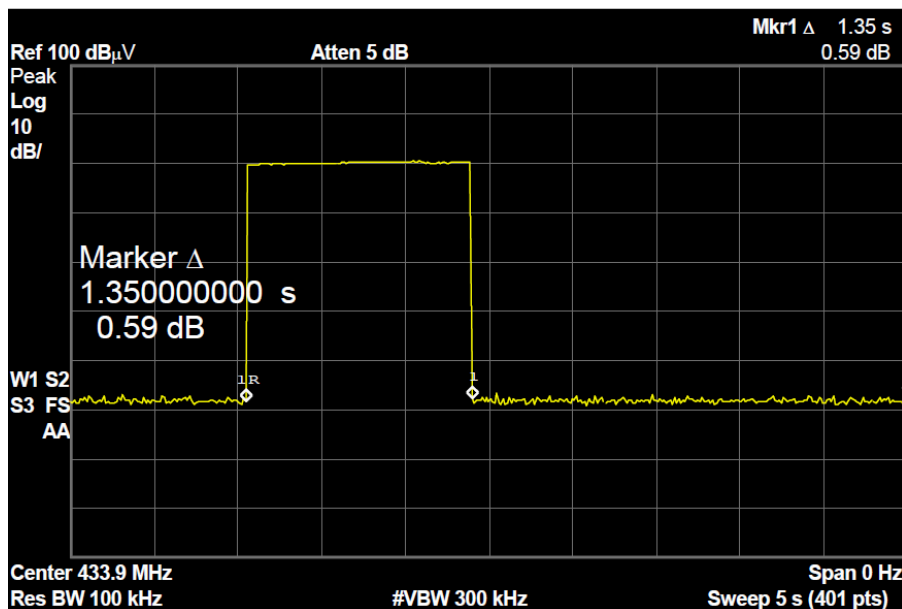
According to FCC 15.231a, A manually operated transmitter shall employ a switch that will automatically deactivate the transmitter within not more than 5 seconds of being released.

### 8.3 Test Procedure

- (1) Set Spectrum Analyzer Center Frequency=Fundamental Frequency. RBW=100KHz, VBW=300KHz.
- (2) Setup the EUT as normal operation and press transmitter button.
- (3) Set Spectrum Analyzer View. Delta Mark time.

### 8.4 Test Result

## 9 DUTY CYCLE

### 9.1 Test Procedure

Place the EUT on the table and set it in the transmitting mode.

Remove the antenna from the EUT and then connect a low loss RF cable from the antenna port to the spectrum analyzer.

Set centre frequency of spectrum analyzer=operating frequency.

Set the spectrum analyzer as RBW=100KHz, VBW=100KHz to obtain the “worst-case” pulse on time

Repeat above procedures until all frequency measured was complete.

### 9.2 Test Result

Plot 1, Plot 2: Transmit once in 70ms, and each cycle is 26.25ms there are three kinds of pulse in each cycle, the large pulses total 8, the small pulses total 10.

Plot 3: one large pulse in a time period of 1.575ms

Plot 4: one middle pulse in a time period of 0.55ms

Duty cycle=ON/Total=(8\*1.575+10\*0.55)/26.25=18.1/26.25=68.95%

$20 \log_{10}(\text{Duty Cycle}) = -3.22$

Average =Peak Value+ 20 log<sub>10</sub>(Duty Cycle), AV =PK-3.22

The smallest pulse width(PW)=0.55ms

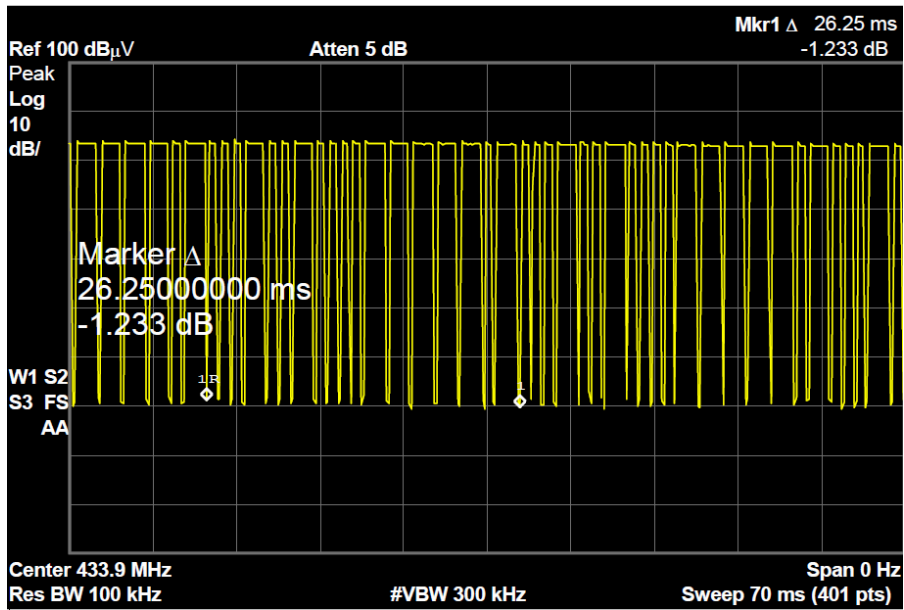
$2/PW=2/0.55(\text{ms})=3.636\text{KHz}<100\text{KHz}$

Because  $2/PW<RBW$ , so the PDCF is not needed.

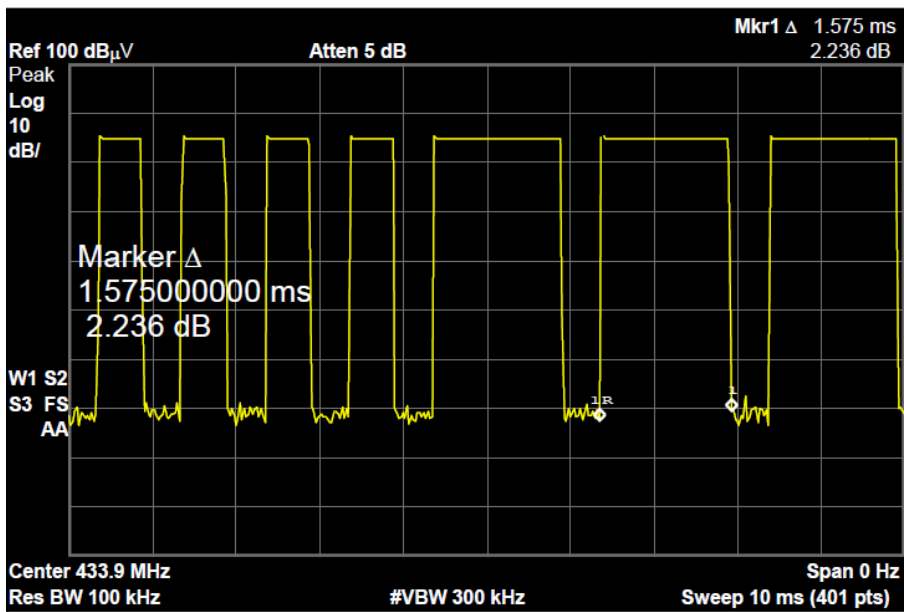

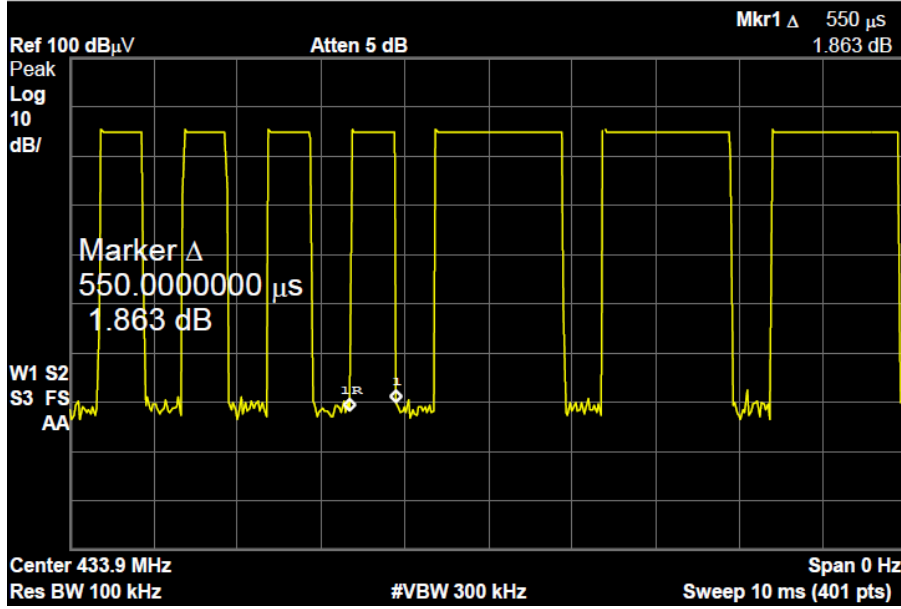

## **10 Antenna Application**

### **10.1 Antenna Requirement**

For intentional device, according to FCC 47 CFR Section 15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device. And if transmitting antennas of directional gain greater than 6dBi are used, the power shall be reduced by the amount in dB that the directional gain of the antenna exceeds 6dBi.

### **10.2 Result**

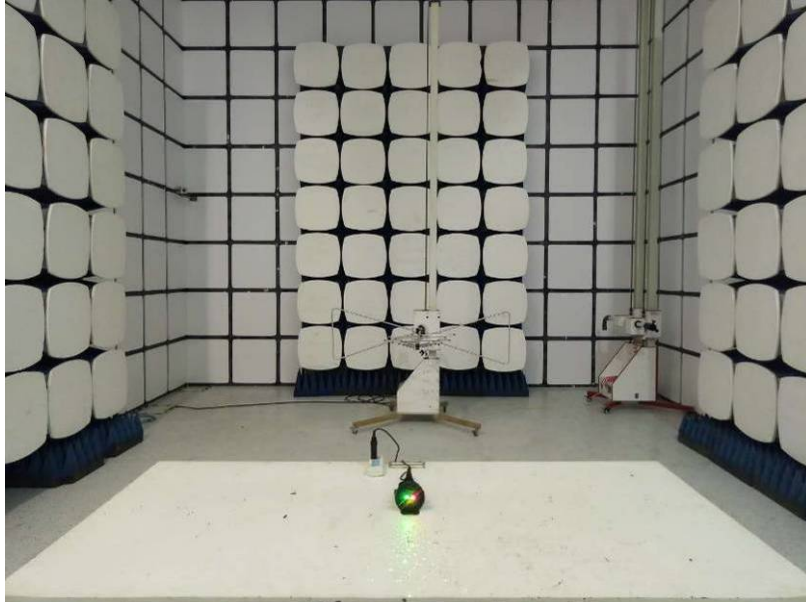
The EUT'S antenna, permanent attached antenna, is internal PCB antenna. The antenna's gain is 0.8 dBi and meets the requirement.

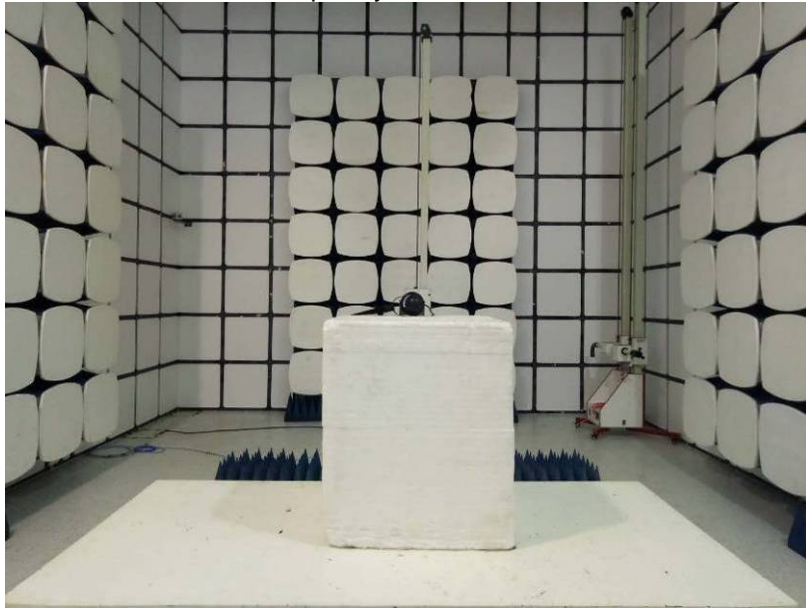


### Radiated Spurious Emissions From 30MHz-1000MHz





Test frequency from 1GHz-18GHz



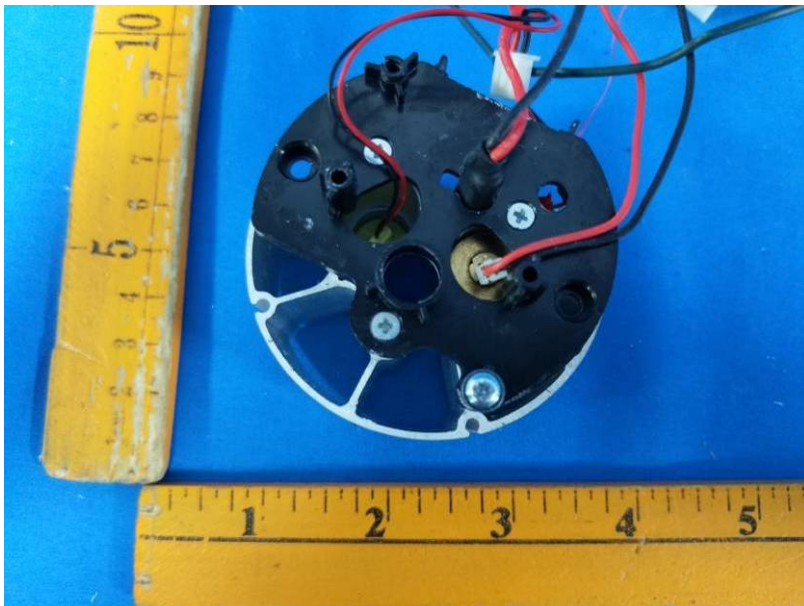


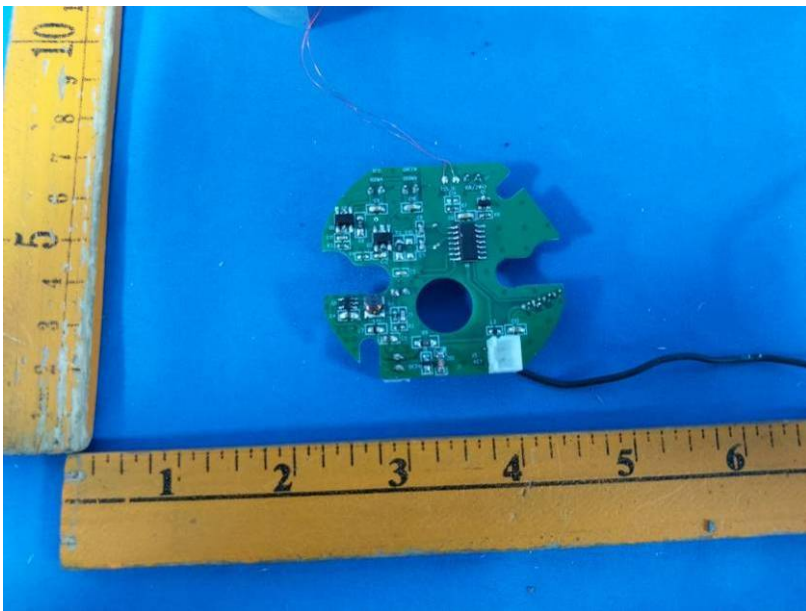
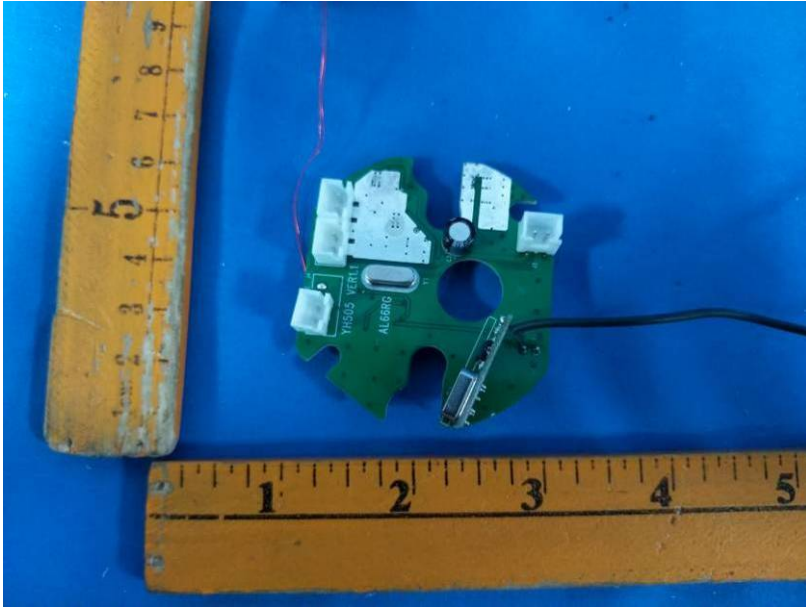
