The EUT sends radio signal to the receiver and them the receiver converts the signal to the infrared signals that control audio and/or video components. Also the EUT can be programmed via a windows PC equipped with a USB port using supplied software, MX-3000 Editor. The associated receiver is manufactured by OH SUNG ELECTRONICS CO., LTD., Model No: MRF-250, FCC ID: OZ5URCMRF250. The product specification described herein was obtained from product data sheet or user's manual.

To get a maximum radiated emission from the EUT, the touch screen o the EUT was pushed to transmit RF signal continuously. To activate continuous transmission, software was changed as above for testing only.

Occupied Bandwidth Measurement:

This measurement is performed with the antenna located close enough to give a fullscale deflection of the modulated carrier on the spectrum analyzer. The plot is taken at 60kHz/division frequency span, 10 kHz resolution bandwidth and 10dB/division logarithmic display from an 8568B spectrum analyzer.

3.5 Antenna Requirement

For intentional device, according to §15.203, an intentional radiator shall be designed to ensure that no antenna other than that furnished by the responsible party shall be used with the device.

Antenna Construction:

The transmitter antenna of the EUT is inside of the EUT, no consideration of replacement by the user.








Photo Data for MMP


