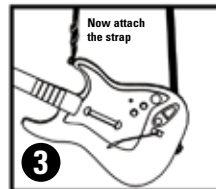
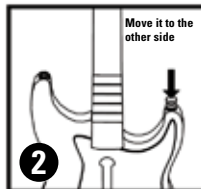
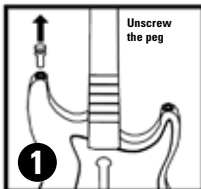
- Do not modify, disassemble or attempt to open any controller.

## FREQUENTLY ASKED QUESTIONS

**QUESTION: I'm having trouble triggering Overdrive; how do I engage the Overdrive function on my guitar controller?**

**ANSWERS:**

1. You may be holding the guitar too vertically. Ensure the guitar is horizontally oriented while playing.
2. You may be holding the guitar with the face a bit upwards. The tilt sensor won't work if the guitar is too flat.
3. The + / - buttons will also trigger Overdrive. If you still have trouble, please visit [www.madcatz.com/FAQ/rockband](http://www.madcatz.com/FAQ/rockband) for further info.

**QUESTION: How do I connect the Overdrive pedal to the Stratocaster guitar controller?**

**ANSWER:** Plug the Overdrive cable into the Overdrive jack on the Stratocaster (see part L on diagram).
