



### Intallation

1. Unlock and remove mounting plate.












### 2. Insert CR123A Battery into Siren



3. The Siren of LED indicator will be blinking for 90sec while attempting to pair with the gateway or base station..

## Operation





1. Indicator LED (Red, Green, Blue color)

2. Buzzer
3. Test Button
4. Tamper

- When the battery is installed, the Blue LED will be blinking for 90 seconds which indicates paring process is on going.
- If pairing succes, Blue LED will be solid on for 3 seconds. If paring fail, Red LED will be solid on for 3 seconds.
- If paring fail, press "Test Botton" for 5 second to restart paring process.
- If Siren needs factory reset, press "Test Botton" for 10 second to Reset and restart paring process.
