3. TEST METHODOLOGY

The tests documented in this report were performed in accordance with ANSI C63.4. Radiated testing was performed at an antenna to EUT distance 3 meters.

3.1EUT CONFIGURATION

The EUT configuration for testing is installed on RF field strength measurement to meet the Commissions requirement and operating in a manner that intends to maximize its emission characteristics in a continuous normal application.

3.2EUT EXERCISE

The EUT was operated in the engineering mode to fix the Tx frequency that was for the purpose of the measurements.

According to its specifications, the EUT must comply with the requirements of the Section 15.207, 15.209 and 15.247 under the FCC Rules Part 15 Subpart C.

3.3GENERAL TEST PROCEDURES

Conducted Emissions

The EUT is placed on the turntable, which is 0.8 m above ground plane. According to the requirements in Section 13.1.4.1 of ANSI C63.4.Conducted emissions from the EUT measured in the frequency range between 0.15 MHz and 30MHz using CISPR Quasi-peak and average detector modes.

Radiated Emissions

The EUT is placed on a turn table, which is 0.8 m above ground plane. The turntable shall rotate 360 degrees to determine the position of maximum emission level. EUT is set 3m away from the receiving antenna, which varied from 1m to 4m to find out the highest emission. And also, each emission was to be maximized by changing the polarization of receiving antenna both horizontal and vertical. In order to find out the maximum emissions, exploratory radiated emission measurements were made according to the requirements in Section 13.1.4.1 of ANSI C63.4.

3.5DESCRIPTION OF TEST MODES

The EUT (model: RC8020) had been tested under operating condition. The EUT connected with Notebook PC via LAN Cable through Hub.

Software used to control the EUT for staying in continuous transmitting mode was programmed.

After verification, all tests were carried out with the worst case test modes as shown below except radiated spurious emission below 1GHz, which worst case was in normal link mode only.

After verification, power line conduction emission tests were carried out with the worst case test modes, which worst case was used DVE / DSA-5P-05 FUS 050100 in charging mode only.

IEEE802.11b mode:

Channel Low, Channel Mid and Channel High with 1Mbps data rate were chosen for full testing.

IEEE802.11g mode:

Channel Low, Channel Mid and Channel High with 6Mbps data rate were chosen for full testing.

Calibrated wideband preamplifiers, coaxial cables, and coaxial attenuators are also used for making measurements.





6dB Bandwidth (IEEE 802.11b / CH Low)




6dB Bandwidth (IEEE 802.11b / CH Mid)





6dB Bandwidth (IEEE 802.11b / CH High)




6dB Bandwidth (IEEE 802.11g / CH Low)







Peak Power (IEEE 802.11b / CH Low)




Peak Power (IEEE 802.11b / CH Mid)



Peak Power (IEEE 802.11b / CH High)




Peak Power (IEEE 802.11g / CH Low)




7.3 BAND EDGES MEASUREMENT

LIMIT

According to §15.247(d), in any 100 kHz bandwidth outside the frequency bands in which the spread spectrum intentional radiator in operating, the radio frequency power that is produced by the intentional radiator shall be at least 20 dB below that in the 100 kHz bandwidth within the band that contains the highest level of the desired power, based on either an RF conducted or a radiated measurement, provided the transmitter demonstrates compliance with the peak conducted power limits. - 5. Repeat the procedures until all the PEAK and AVERAGE versus POLARIZATION are measured.




Polarity: Horizontal

IEEE 802.11b / CH Low




IEEE 802.11b / CH Mid



IEEE 802.11b / CH High








