GENERAL INFORMATION

Product Description for Equipment under Test (EUT)

The *Drift Innovation Ltd*'s product, model number: *Compass-FD9972 (FCC ID: P2FFD9972)* or the "EUT" in this report was a *Camera*, which was measured approximately: 43 mm (L) \times 42 mm (W) \times 16 mm (H), rated with input voltage: DC 3.7V rechargeable Li-ion battery. The highest operational frequency is 2462MHz.

Note: There are two types of antenna for the EUT. One is South Star, which antenna gain is 1.8dBi. The other one is KeXinHuaCheng, which antenna gain is 3.8dBi.

Objective

This test report is prepared on behalf of *Drift Innovation Ltd* in accordance with Part 2-Subpart J, Part 15-Subparts A and B of the Federal Communication Commissions rules.

The objective of the manufacturer is to determine the compliance of the EUT with FCC Part 15 B.

Test Methodology

All measurements contained in this report were conducted with ANSI C63.4-2014, American National Standard for Methods of Measurement of Radio-Noise Emissions from Low-Voltage Electrical and Electronic Equipment in the range of 9 kHz to 40 GHz.

All emissions measurement was performed at Bay Area Compliance Laboratories Corp. (Shenzhen). The radiated testing was performed at an antenna-to-EUT distance of 3 meters.

Measurement uncertainty with radiated emission is 5.81 dB for 30MHz-1GHz, and 4.88 dB for above 1GHz, 1.95dB for conducted measurement.





Correction Factor = LISN VDF + Cable Loss + Transient Limiter Attenuation





The radiated emission tests were performed in the 3 meters chamber test site, using the setup accordance with the ANSI C63.4-2014. The specification used was the FCC Part 15.109 Class B limits.

The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

EMI Test Receiver Setup

The system was investigated from 30 MHz to 12.31 GHz.

Test Procedure

Maximizing procedure was performed on the highest emissions to ensure that the EUT complied with all installation combinations.

All data was recorded in the Quasi-peak detector mode from 30 MHz to 1 GHz and PK and average detector modes for frequencies above 1 GHz.

Corrected Amplitude & Margin Calculation

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:

Corrected Amplitude = Meter Reading + Antenna Factor + Cable Loss - Amplifier Gain

The "Margin" column of the following data tables indicates the degree of compliance with the applicable limit. For example, a margin of 7 dB means the emission is 7 dB below the limit. The equation for margin calculation is as follows:

Margin = Limit – Corrected Amplitude
