Question #1: Please submit an Agency Authorization Letter.

Question #2: External photos show that the EUT consists of two parts: CD/DVD player and AC power unit. But the user manual does not mention how AC power unit to be installed with the CD player. Please provide enough operation or installation information in the user manual.

Question #3: Please confirm the power supply with ferrite core is the AC power unit that connected to CD player, or the AC/DC power supply that connected to Notebook PC.

Question #4: Based upon ANSI C63.4 section 11.1.1.1 "Where a peripheral is the EUT, the host shall have other peripherals connected to it for a minimum of two different types of available I/O protocols". The setup photos does not show this requirement has been met. Please explain.

Question #5: The user manual said 5 speakers can be connected to the DVD player, however there are 6 speakers shown on the setup photos. Please explain.

Question #6: The test report indicates power supply (AC-NW50) was used during the test, but external photos show AC-NW10, please update the external photos.
