Input VS Output, Input Spectrum Plots



Input VS Output, Output Spectrum Plots, UHF Band







Intermodulation Products Spectrum Plots, UHF Band




8.7.4 12.5 kHz Signal, Uplink, AGC +3dB


8.7.5 12.5 kHz Signal, Uplink, AGC


8.8.2 1 GHz to 10th Harmonic, VHF Band Uplink






8.8.3 30 MHz to 1 GHz, UHF Band Uplink






8.8.4 1 GHz to 10th Harmonic, UHF Band Uplink
