1. MAXIMUM PERMISSABLE EXPOSURE

Calculations for Maximum Permissible Exposure Levels

Power Density = Pd (mW/cm²) = EIRP/ $(4*\pi*d^2)$

EIRP = P * G

P = Peak output power (mW)

G = Antenna numeric gain (numeric)

d = Separation distance (cm)

Numeric Gain = $10 ^ (G (dBi)/10)$

The calculations in the table below use the highest conducted power values for the EUT. These calculations

represent worst case in terms of the exposure levels.

Note: for mobile or fixed location transmitters the minimum separation distance is 20cm, even if calculations indicate the MPE distance to be less.
