



- 2. EUT connected to the line impedance stabilization network (LISN)
- 3. Receiver set RBW of 9kHz and Detector Peak, and note as quasi-peak and average.
- Maximum procedure was performed on the six highest emissions to ensure EUT compliance.
- 5. Recorded Line for Neutral and Line.

Spurious Emission 30MHz-25GHz




