Tellus Group Corp. 's CF Card, with the FCC ID: PB6-04021 has your authorization as a limited modular approval specific to products below:

This transmitter module is authorized only for use in OEM device where the antenna may be installed such that 20cm may be maintained between the antenna and users.

The requirements of the Public Notice DA-00-1407 have been met and shown on the following statements:

- 1. The modular transmitter must have its own RF shielding: The radio portion of this module has been shielded. Please refer to EUT Photo.
- 2. The modular transmitter must have buffered modulation / data inputs: The EUT has buffered data inputs, it is integrated in chip ZyDas ZD1200.
- 3. The modular transmitter must have its own power supply regulation:
 The chips IF converter and RF/IF converter which will influence the frequency radiation, have to be 3.3VDC/1.8VDC powered. The CF interface provides 3.3VDC so there are regulators in front of these chips, the part number of this regulator is AME8800A
- 4. The modular transmitter must comply with the antenna requirements of the Section 15.203 and 15.204(c):
 - The EUT meets the FCC antenna requirements. The spurious emission unique antenna connector and photo of antennas are shown in the test report.
- 5. The modular transmitter must be tested in a stand-alone configuration: The EUT was tested in a stand-alone configuration via a Compact Flash interface to test kit. Please see section Photographs of Test Configuration in the test report, the EUT was plugged in this test kit.
- 6. The modular transmitter must be labeled with its own FCC ID number and, if the FCC ID is not visible when the module is installed inside another device, then the outside of the device into which the module is installed must also display a label referring to the enclosed module." Please see exhibition Label Sample for the FCC ID of this module. And also in the exhibition Users Manual, there are instructions give to the OEM on how to label the end product.

- 7. The modular transmitter must comply with any specific rule or operating requirements applicable to the transmitter and the manufacturer must provide adequate instructions along with the module to explain any such requirements:
