### 1. INSTRUCTIONS

#### How to use

- ① Switch on/off: press the power button, the blue light will on/off.
- ② **Bluetooth connection:** turn on the Bluetooth on your mobile phone, and search the Bluetooth name "MAGICSING", click and paired the device will tick sound.
- ③ Playing music: turn on the mobile phone music application such as "MAGICSING", download your favorite songs or accompaniment songs. Volume could be adjusted by mobile phone.
- ④ Adjusting sound: adjust MIC volume or ECHO in suitable place.

#### Cable connection

Connect the audio cable, plug the micro USB jack into this device and 3.5mm audio jack into mobile phone.

※ Bluetooth will automatically disconnect when audio cable plug in.

### 2. HOW TO RECHARGE

- ① When the battery voltage is too low, the product will automatically shutdown.
- ② Using USB cable to connect with mobile phone standard jack the red light will light.
- ③ about 2 hours to fully charged, when the charging is completed, the red light is automatically extinguished.
- ④ In normal conditions works 6-8 hours.
