## **MPE Calculations**

Systems operating under the provision of 47 CFR 1.1307(b)(1) shall be operated in a manor that ensures that the public is not exposed to radio frequency energy levels in excess of the FCC guidelines.

The EUT will only be used with a separation of 20 centimeters or greater between the antenna and the body of the user or nearby persons and can therefore be considered a mobile transmitter per 47 CFR 2.1091(b). The MPE calculation for this exposure is shown below.

### Using the CF-73 802.11b Antennas:

The peak radiated output power (EIRP) is calculated as follows:

EIRP = P + G

EIRP = 16.51dBm + 3.30 dBi

EIRP = 19.81dBm (95.72 mW)

Where

P = Power input to the antenna (mW).

G = Power gain of the antenna (dBi)

Power density at the specific separation:

 $S = PG/(4R^2\pi)$ 

 $S = (44.77 \times 2.138) / (4 \times 20^2 \times \pi)$ 

 $S = 0.019 \text{ mW/cm}^2$ 

Where

S = Maximum power density (mW/cm<sup>2</sup>)

P = Power input to the antenna (mW).

G = Numeric power gain of the antenna

R = Distance to the center of the radiation of the antenna (20cm = limit for MPE)

The maximum permissible exposure (MPE) for the general population is 1mW/cm<sup>2</sup>.

The power density at 20cm does not exceed the 1mW/cm<sup>2</sup> limit. Therefore, the exposure condition is compliant with FCC rules.

Estimated safe separation:

 $R = \sqrt{PG/4\pi}$ 

 $R = \sqrt{(44.77 \times 2.138)/4\pi}$ 

R = 2.76 cm

Where

P = Power input to the antenna (mW).

G = Numeric power gain of the antenna

R = The safe estimated separation that the user must maintain from the antenna (cm)

The numeric gain (G) of the antenna with a gain specified in dB is determined by:

 $G = Log^{-1}$  (dB antenna gain/10)  $G = Log^{-1}$  (3.30 dBi/10)

G = 2.138

## **Using the WLAN PIFA Antennas:**

The peak radiated output power (EIRP) is calculated as follows:

EIRP = P + G

EIRP = 16.51 dBm + 3.0 dBi

EIRP = 19.51 dBm (89.33 mW)

#### Where

P = Power input to the antenna (mW).

G = Power gain of the antenna (dBi)

Power density at the specific separation:

 $S = PG/(4R^2\pi)$ 

 $S = (44.77 \times 2.00) / (4 \times 20^2 \times \pi)$ 

 $S = 0.018 \text{ mW/cm}^2$ 

#### Where

S = Maximum power density (mW/cm<sup>2</sup>)

P = Power input to the antenna (mW).

G = Numeric power gain of the antenna

R = Distance to the center of the radiation of the antenna (20cm = limit for MPE)

The maximum permissible exposure (MPE) for the general population is 1mW/cm<sup>2</sup>.

The power density at 20cm does not exceed the 1mW/cm<sup>2</sup> limit. Therefore, the exposure condition is compliant with FCC rules.

# Estimated safe separation:

 $R = \sqrt{(44.77 \times 2.00) / 4\pi}$ 

R = 2.67 cm

G = Numeric power gain of the antenna
