After a review of the submitted information, I have a few comments on the above referenced Application.

1) Please provide a close up photograph of the RF sections located underneath the shields.

Response: Please refer to the new internal photograph uploaded with this response.

2) The information regarding frequencies of operation given in the application are not consistent. Please clarify what the actual frequencies are and correct the affected exhibits.

Response: The actual RX frequencies are those listed on the 731 Form. The Operational Description and the User Manual (p. 62) have been corrected, and uploaded with this response.

3) The EUT is considered a composite device (PC Peripheral Device + scanning RX) and is subject to the applicable requirements of both. However, in the configuration specified in the test report the EUT has only been tested for the receiver portion of the device. For meeting the requirements of 15.107 & 15.109 as a PC peripheral the device should have also been tested with a minimum PC configuration as specified by ANSI C63.4 in order to meet the DoC requirements as a PC Peripheral Device. Please confirm that the EUT has been evaluated and tested in a properly configured configuration or alternatively provide a copy of the DoC report.

Response: A copy of the DoC report has been uploaded with this response under 'Additional Information'.

4) If the device has been approved under a DoC authorization, the device should include a compliance information sheet that meets the following requirements:

COMPLIANCE INFORMATION (47CFR 2.1077)

If a product is tested and authorized under a Declaration of Conformity, a compliance information statement (all information located together on one single page or as a separate sheet) shall be supplied with the product at the time of marketing or importation, containing the following information:

- (1) Identification of the product, i.e. name and model number.
- (2) A statement similar to that contained in Section 15.19(a)(3) that the product complies with Part 15 of the regulations.
- (3) The identification, by name, address and telephone number, of the responsible party. The responsible party is defined as either the manufacturer, or if the equipment is imported, the importer. The responsible party for a Declaration of Conformity must be located within the United States.

Note: All this information was found in the users manual, but should be contained on a single page in the manual.

Response: The combined compliance information appears on the right side of page 2 of the revised user manual, uploaded with this response. I need to provide a USA address and phone number for the USA distributor, which I am confirming now. I will submit an updated manual asap.
