Hi Kwok,

I hope all is well with you and your family (your kids must be getting big... I know mine are!). Based on the info provided last week at the Workshop, I am contacting you to let you know that I am currently reviewing an application for a WLL PCS CDMA phone that has CDMA 2000 capabilities.

As with most WLL phones that we see, it is designed to replace the phone on your desk (i.e., it sits on the desk, and looks like a regular corded phone- no RF in the handset, just a whip antenna sticking out of the back of the base portion). The lab performed body SAR measurements with a separation distance of 2.5 cm. Is there anything specific for which I should look, given its CDMA 2000 capabilities? Please let me know at your earliest convenience (of course, we are under pressure to finish the review ASAP).

I appreciate your time and effort- thank you. Take care.
