1 General Information

1.1 General Description

The equipment under test (EUT) is a superregenerative receiver for 6V Batman Monster Truck. Operating at 49.860 MHz which is controlled by a LRC Circuit. The EUT is powered by 6V rechargeable battery and it has a internal anterna. When it received a forward or backward signal, it will go forward or backward. When it received a turn left or turn right signal, it will go left or right.

The brief circuit description is listed as follows:

- Q16 and associated circuit act as super regenerative circuit.
- Q1 and associated circuit act as voltage readjust.
- U1 and associated circuit act as decoder.
- R8 and associated circuit act as oscillator for decoder.
- Q33-Q38 and associated circuit act as control steering motor circuit.
- Q2, Q6~Q8, Q11, Q27, Q28 and associated circuit act as control drive motor circuit.

2 Description of the radiated emission test

2.1 Test Procedure

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 – 2001.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of $1.5 \,\mathrm{m}\,x$ 1m and $0.8 \,\mathrm{m}$ high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

A signal generator was used to radiate an unmodulated continuous wave (CW) signal to the EUT (superregenerative receiver) at its operating frequency in order to "cohere" the characteristic broadband emissions from the receiver.

2.2 Test Result

The emissions meeting the requirement of section 15.109 are based on measurements employing the CISPR qusai-peak detector.

It was found that the EUT meet the FCC requirement.
