





Duty Cycle Correction During 100msec


Each function key sends a different series of characters, but each packet period (11.025msec) never exceeds a series of 4 long (900μ sec) and 10 short (300μ sec) pules. Assuming any combination of short and long pules may be obtained due to encoding the worse case transmit duty cycle would be considered $4x900\mu$ sec+ $10x300\mu$ sec per 11.025msec=59.8% duty cycle. Figure A through C show the characteristics of the pulse train for one of these function.

Remarks:

Figure B [Long Pulse]





Figure C [Short Pulse]



Inner Circuit Bottom View


