#### 1 General Information

### 1.1 General Description

The equipment under test (EUT) is a transmitter for XFO operating at 27.145 MHz which is controlled by a crystal. The EUT is powered 9 V battery. There a joystick in the center of the EUT. When the joystick push up once, it will transmit a radio frequency for receiver flying up. When the joystick push down once, it will transmit a radio frequency for receiver stop flying.

### 2 Description of the radiated emission test

#### 2.1 Test Procedure

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 – 1992.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5m x 1m and 0.8m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

The device was rotated through three orthogonal axes to determine which attitude and configuration produce the highest emission during measurement.

#### 2.2 Test Result

Peak Detector data was measured unless otherwise stated.

\* Emissions appearing within the restricted bands shall follow the requirement of section 15.205.

It was found that the EUT meet the FCC requirement.

#### 5.1 Bandwidth

The plot on saved in TestRpt 2.pdf shows the fundamental emission is confined in the specified band. It also shows that the band edge met the 15.229 requirement at 26.9599 and 27.2801 MHz.

#### 5.2 The duty cycle is simply the on-time divided by the period :

The duration of one cycle = 12.36 ms.

Effective period of the cycle =  $(0.38 \times 11) \text{ ms.} + (0.17 \times 10) \text{ ms.}$ 

= 5.88 ms.

Duty Cycle = 5.88/12.36 ms.

= 0.476 ms.

Therefore, the average factor is found by  $20 \log_{10} 0.476 = -6.4 \text{ dB}$
