1 General Information

1.1 General Description

The equipment under test (EUT) is a super regenerative receiver for R/C Stunt Car. Operating at 49.860MHz which is controlled by a LRC circuit. The EUT is powered by 6 x 1.5V AA size battery. When it switch on, it can receive radio signal and running to forward, backward, left, right or stunt moving.

The brief circuit description is listed as follows:

- Q2and associated circuit act as super regenerative circuit.
- U1 U3 and associated circuit act as decoder.
- Q15, Q27 and associated circuit act as power control.
- Q4 ~ Q9 and associated circuit act as forward and backward motor control.
- Q3, Q10 ~ Q14 and associated circuit act as left and right motor control.
- Q17 ~ Q22 and associated circuit act as stunt motor control.

2 Description of the radiated emission test

2.1 Test Procedure

Radiated emissions measurements are investigated and taken pursuant to the procedures of ANSI C63.4 - 2003.

The equipment under test (EUT) was placed on a non-conductive turntable with dimensions of 1.5m x 1m and 0.8m high above the ground. 3m from the EUT, a broadband antenna mounting on the mast received the signal strength. The turntable was rotated to maximize the emission level. The antenna was then moving along the mast from 1m up to 4m until no more higher value was found. Both horizontal and vertical polarization of the antenna were placed and investigated.

For below 30MHz, a loop antenna with its vertical plane is placed 3m from the EUT and rotated about its vertical axis for maximum response at each azimuth about the EUT. And the centre of the loop shall be 1 m above the ground.

A signal generator was used to radiate an unmodulated continuous wave (CW) signal to the EUT (superregenerative receiver) at its operating frequency in order to "cohere" the characteristic broadband emissions from the receiver.

2.2 Test Result

All other measurements are well below the limit. Thus, those highest emissions were presented in next page.

The emissions meeting the requirement of section 15.109 are based on measurements employing the CISPR quasi-peak detector.

It was found that the EUT meet the FCC requirement.
