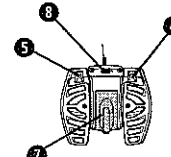
### II. BASIC OPERATION

- Ⓐ LEFT UP/RIGHT UP: FORWARD
- Ⓑ LEFT UP/RIGHT RELEASE: TURN RIGHT
- Ⓒ LEFT UP/RIGHT DOWN: SPIN RIGHT
- Ⓓ RIGHT UP/LEFT RELEASE: TURN LEFT
- Ⓔ RIGHT UP/LEFT DOWN: SPIN LEFT
- Ⓕ LEFT DOWN/RIGHT DOWN: REVERSE

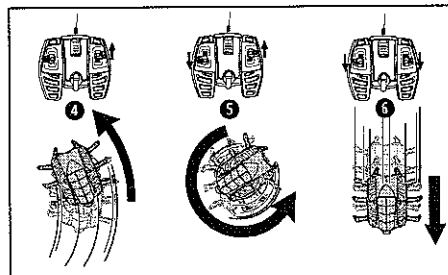
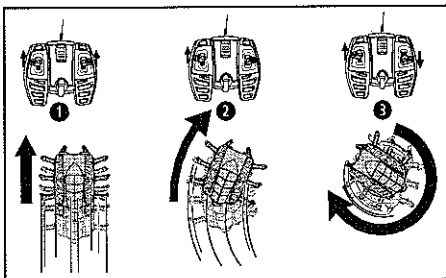
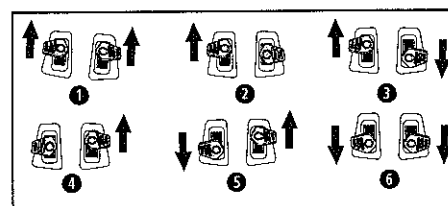
If your vehicle doesn't move when you use the transmitter there's a good chance your vehicle's battery is ready for a recharge.

### TO SHOOT GUN

1. Hold down center button on top of transmitter (#6) to raise gun.
2. Squeeze trigger on bottom right side of the transmitter.
3. Hold down center button (#6) to lower gun or tap button gently to adjust height.

N.S.E.C.T.<sup>™</sup> can shoot and walk simultaneously but cannot shoot while the cannon is being raised and lowered.

When the gun is in the lowered position under the wings, the eyes will be yellow. When the gun is in the upper position – wings spread out – the eyes will be red.

The gun will only shoot when the eyes are in the red mode.

If the gun will not retract into N.S.E.C.T.'s body, check under the gun to make sure that no loose darts or debris have impeded its path.

**!** Do not fire at people or animals or at point blank range. Keep hands clear of N.S.E.C.T.'s legs.

### III. BATTERY INSTALLATION

Requires a 7.2v Tyco® (NiCd) battery pack for vehicle and a 9v battery for transmitter.

#### Vehicle

1. Unscrew to open the battery door (screwdriver not included). Pull the battery door up and away from the vehicle.
2. Insert the battery pack into the battery compartment as shown.
3. Replace the battery door. Screw back in to lock the battery door.
4. To remove the battery pack: First turn the vehicle off, unscrew the battery compartment, open the battery door and lift out the battery pack.

**!** **CAUTION:** Battery pack may be hot after use. Allow to cool before touching.

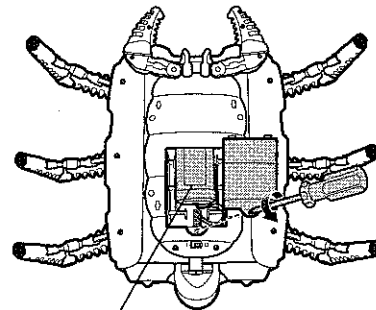
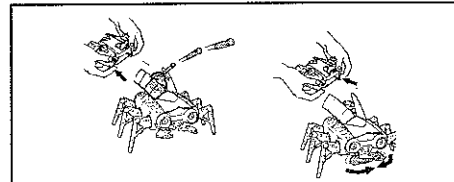
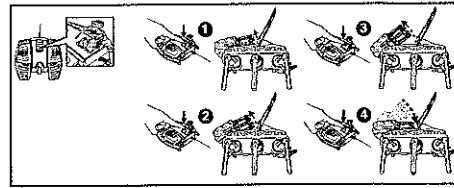
1. To install the transmitter battery, open the battery door as shown.
2. Install one 9V battery in the battery compartment as shown. Observe the battery polarity (+ and -).
3. Close the battery door.

### IV. BATTERY CHARGING/CARE

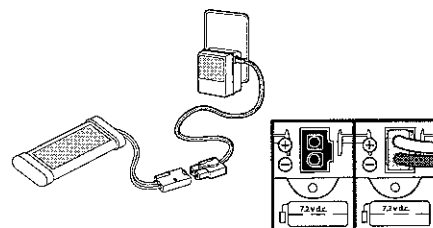
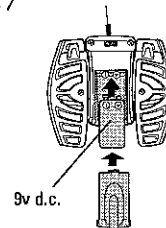
**!** **CAUTION:** Use only the charger supplied with this toy. Do not use any other charging source.

Use only Tyco® 7.2V NiCd battery pack. Other batteries may leak or rupture, causing personal injury and damage.

1. Plug the wall pack charger into a standard wall outlet.
2. Connect the wires leading from the battery pack to the wall pack charger connector. Make certain the two connectors are tightly snapped together.
3. To disconnect the wires, push down on the connector clip and pull apart.
4. After charging, the battery will feel warm. This condition is normal for fully charged batteries.
5. New battery packs must be charged for 5 1/2 hours the first two times charged. Subsequent charges will require 4 hours. Charging the battery pack for more than 4 hours will not give you a longer running time. 4 hours is all that is required for a fully charged battery pack.
6. Unlike alkaline batteries, which lose power gradually, a NiCd battery will run for its normal running time and then lose

most of its power at once. That's when you'll know it's time to recharge the battery pack.

7. After use, the battery pack will be hot! Wait at least 20 minutes until the battery pack cools before recharging. Recharging a warm or hot battery pack will greatly reduce the number of times your battery pack can be recharged.
8. The charger must be disconnected from the electric supply.

#### RECHARGEABLE BATTERY INFORMATION:

- DO NOT RECHARGE BATTERY PACK IF IT'S HOT. ALLOW IT TO COOL BEFORE RECHARGING.
- DO NOT RECHARGE A BATTERY PACK THAT SHOWS LEAKAGE OR CORROSION.

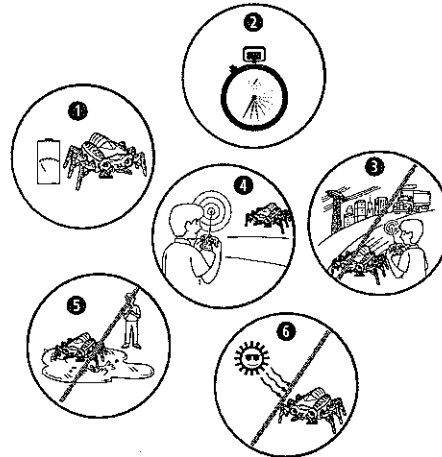

#### V. QUICK TIPS

- 1 When N.S.E.C.T.™ starts to lose power you'll start to lose performance. It's time for a recharge. As a rule, you should always start with a fully charged battery.
- 2 Be forewarned--N.S.E.C.T.'s running time may change depending on your driving style.
- 3 Radio interference can mess up the signals you're sending, causing N.S.E.C.T.™ to perform erratically. Things to look for that may be causing the interference: other R/C vehicles running on the same frequency, electrical wires, large buildings, CB radios, or other wireless gear that can cause interference.
- 4 Point your transmitter antenna up -- not down toward N.S.E.C.T.™. If N.S.E.C.T.™ escapes your antenna's grasp, you can kiss proper functioning goodbye.
- 5 Don't drive N.S.E.C.T.™ through water or snow. Not only won't you get very far, you might ruin the creature. If N.S.E.C.T.™ does get wet, wipe it with a towel and allow it to dry completely.
- 6 Don't store N.S.E.C.T.™ near heat or in direct sunlight. Always turn the switches OFF and, if you're not planning on any search and destroy maneuvers for awhile, remove all the batteries...really. It's amazing how one bad battery can destroy a super-secret experimental creature technology (that would be N.S.E.C.T.™).

☀ Please recharge your battery when you notice that the N.S.E.C.T.™ eyes are blinking slowly. If the N.S.E.C.T.™ is blocked by some obstacle for an extended period of time it may turn itself off. Remove N.S.E.C.T.™ from the path of the obstacle. If it cannot receive any signal from the transmitter, the eyes will blink yellow. If the battery is dying the eyes will blink red.



#### VI. CONSUMER INFORMATION

#### Safety Tips

- Yes, N.S.E.C.T.™ is a multi-terrain vehicle but you should NEVER, EVER play with it on the street!
- DO NOT pick up N.S.E.C.T.™ while in motion. Take your fingers off the transmitter buttons and then pick it up.



**CAUTION:** Keep fingers, hair and loose clothing away from N.S.E.C.T.™ while it's on.

- Adult supervision is recommended when N.S.E.C.T.™ is being used.
- To avoid accidental or unwanted operation, remove all the batteries when not in use. Always turn N.S.E.C.T.™ OFF before removing the batteries.

#### BATTERY SAFETY INFORMATION
