

- 3. Set EUT at maximum power through base station.
- 4. Select lowest, middle, and highest channels for each band and different modulation.
- 5. Measure the maximum burst average power.






- 1. The EUT's output RF connector was connected with a short cable to the spectrum analyzer

- 3. The EUT was placed inside the temperature chamber.
- 4. Set the spectrum analyzer RBW low enough to obtain the desired frequency resolution and measure EUT 25℃ operating frequency as reference frequency.
- 5. Turn EUT off and set the chamber temperature to −30°C. After the temperature stabilized for approximately 30 minutes recorded the frequency.
- 6. Repeat step measure with 10°C increased per stage until the highest temperature of +50°C reached.


