3 How to Install and Start

3.1Install

When the vehicle is shut down, insert the device into the OBDII interface. This interface is usually located under the dashboard of the vehicle and above the accelerator pedal. If not, refer to the schematic or your owner's manual. If the installation affects driving, you can purchase the extension cable and place it in a safe place.



3.2 first use

For the first use, initialization is required: after inserting the equipment, start the engine and keep idling for 3-5 minutes until the equipment works normally (the red and green status indicator lights are always on). Your device is ready for normal use!

3.3 WiFi on board

The on-board WiFi supports 4G high-speed network, and supports the access of mobile phone, pad and other equipment.

SSID and initial password is on the label of the back of the box for WiFi default name and password. The WiFi SSID and password can be modified through the App.

If you forget the password, press the key on the device for more than 10s to reset the WiFi name and password to the initial state.
