#### 1.0 **General Description**

# 1.1 Product Description

The equipment under test (EUT) is a transmitter for a 1:14 R/C,Asst operating at 27.145MHz. The EUT is powered by two 1.5V size AAA batteries.

The models: 81240, 81019, 81203 are package numbers. The model: 81240 include a transmitter and a receiver, the transmitter model number is 12049 or 12119, receiver model number is 81241, the additional receiver models: 81242, 81243, 81244, 81245, 81246, 81247, 81248, 81249, 81271, 81272, 81273, 81274, 81021, 81022, 81024, 81026, 81028,81031, 81032, 81041, 81042, 81044, 81045, 81275, 81276 are same as the model: 81241 in hardware and electrical aspect. Theirs difference in the appearance and model number.

Antenna Type: integral antenna

Type of modulation: Pulse modulation

For electronic filing, the brief circuit description is saved with filename: descri.pdf.

## 1.2 Related Submittal(s) Grants

The receiver for this transmitter is exempted from the Part 15 technical rules per 15.101(b).

## 1.3 Test Methodology

Radiated emission measurements were performed according to the procedures in ANSI C63.10 (2013). Radiated Emission measurement was performed in a Semi-anechoic chamber. Preliminary scans were performed in the Semi-anechoic chamber only to determine worst case modes. All Radiated tests were performed at an antenna to EUT distance of 3 meters, unless stated otherwise in the "Justification Section" of this Application.

#### 1.4 Test Facility

The Semi-anechoic chamber used to collect the radiated data is Intertek Testing Services Shenzhen Ltd. Guangzhou Branch and located at Block E, No.7-2 Guang Dong Software Science Park, Caipin Road, Guangzhou Science City, GETDD Guangzhou, China. This test facility and site measurement data have been fully placed on file with the FCC (Registration Number: 549654).

#### 2.0 **System Test Configuration**

#### 2.1 Justification

The system was configured for testing in a typical fashion (as a customer would normally use it), and in the confines as outlined in ANSI C63.10 (2013).

The EUT was powered by two 1.5V size AAA new batteries during test.

For maximizing emissions below 30 MHz, the EUT was rotated through 360°, the centre of the loop antenna was placed 1 meter above the ground, and the antenna polarization was changed. For maximizing emission at and above 30 MHz, the EUT was rotated through 360°, the antenna height was varied from 1 meter to 4 meters above the ground plane, and the antenna polarization was changed. This step by step procedure for maximizing emissions led to the data report in Exhibit 3.0.

The unit was operated standalone and placed in the centre of the turntable.

The equipment under test (EUT) was configured for testing in a typical fashion (as a customer would normally use it). The EUT was mounted to a plastic stand if necessary and placed on the wooden turntable, which enabled the engineer to maximize emissions through its placement in the three orthogonal axes.

# 2.2 EUT Exercising Software

There was no special software to exercise the device. Once the unit is powered up, it can transmit the RF signal continuously.

# 2.3 Special Accessories

There are no special accessories necessary for compliance of this product.

#### 2.4 Equipment Modification

Any modifications installed previous to testing by MAY CHEONG TOY PRODUCTS FTY., LTD will be incorporated in each production model sold/leased in the United States.

No modifications were installed by Intertek Testing Services Shenzhen Ltd.

#### 2.5 Measurement Uncertainty

When determining of the test conclusion, the Measurement Uncertainty of test has been considered.

#### 3.0 **Emission Results**

Data is included of the worst case configuration (the configuration which resulted in the highest emission levels). A sample calculation, configuration photographs and data tables of the emissions are included.

# 3.1 Field Strength Calculation

The field strength is calculated by adding the Antenna Factor and Cable Factor, and subtracting the Amplifier Gain (if any), Average Factor (optional) from the measured reading. The basic equation with a sample calculation is as follows:

FS = RA + AF + CF - AG - AV

where  $FS = Field Strength in dB\mu V/m$ 

RA = Receiver Amplitude (including preamplifier) in dBµV

CF = Cable Attenuation Factor in dB

AF = Antenna Factor in dB AG = Amplifier Gain in dB AV = Average Factor in dB

In the following table(s), the reading shown on the data table reflects the preamplifier gain. An example for the calculations in the following table is as follows:

FS = RR + LF

where  $FS = Field Strength in dB\mu V/m$ 

RR = RA - AG - AV in  $dB\mu V$ 

LF = CF + AF in dB

Assume a receiver reading of 52.0 dB $\mu$ V is obtained. The antenna factor of 7.4 dB and cable factor of 1.6 dB are added. The amplifier gain of 29 dB and average factor of 5 dB are subtracted, giving a field strength of 27 dB $\mu$ V/m. This value in dB $\mu$ V/m was converted to its corresponding level in  $\mu$ V/m.

## 8.1 **Measured Bandwidth**

The plot saved in bw.pdf which shows the fundamental emission is confined in the specified band. And it also shows that the emission is at least 37.44dB below the carrier level at the band edge (26.96MHz and 27.28 MHz). It meets the requirement of Section 15.227(b).

Pursuant to FCC part 15 Section 15.215(c), the 20dB bandwidth of the emission was contained within the frequency band designated (mentioned as above) which the EUT operated. The effects, if any, from frequency sweeping, frequency hopping, other modulation techniques and frequency stability over excepted variations in temperature and supply voltage were considered.

#### 8.2 Discussion of Pulse Desensitization

The determination of pulse desensitivity was made in accordance with Hewlett Packard Application Note 150-2, *Spectrum Analysis ... Pulsed RF.* 

The effective period ( $T_{\rm eff}$ ) was approximately 200.00us for a digital "1" bit, as shown in the plots of Exhibit 8.3. With a resolution bandwidth (3 dB) of 100 kHz, the pulse desensitivity factor was 0 dB.

#### 8.3 Calculation of Average Factor

Averaging factor in dB = 20 log (duty cycle)

The specification for output field strengths in accordance with the FCC rules specify measurements with an average detector. During testing, a spectrum analyzer incorporating a peak detector was used. Therefore, a reduction factor can be applied to the resultant peak signal level and compared to the limit for measurement instrumentation incorporating an average detector.

The time period over which the duty cycle is measured is 100 milliseconds, or the repetition cycle, whichever is a shorter time frame. The worst case (highest percentage on) duty cycle is used for the calculation. The duty cycle is measured by placing the spectrum analyzer in zero scan (receiver mode) and linear mode at maximum bandwidth (3 MHz at 3 dB down) and viewing the resulting time domain signal output from the analyzer on a Tektronix oscilloscope. The oscilloscope is used because of its superior time base and triggering facilities.

A plot of the worst-case duty cycle as detected in this manner are saved with filename: af.pdf

The duty cycle is simply the on-time divided by the period:

The duration of one cycle = 89.8 msEffective period of the cycle =  $0.72 \text{ms} \times 1 + 0.2 \text{ms} \times 13 = 3.32 \text{ms}$ 

DC = 3.32 ms / 89.8 ms = 0.0370 or 3.7%

Therefore, the averaging factor is found by 20  $log_{10}$  0.0370= -28.6 dB

#### 8.4 Emissions Test Procedures

The following is a description of the test procedure used by Intertek Testing Services in the measurements of transmitters operating under Part 15, Subpart C rules.

The test set-up and procedures described below are designed to meet the requirements of ANSI C63.10 - 2013.

The transmitting equipment under test (EUT) is placed on a wooden turntable which is four feet in diameter and approximately 0.8 meter in height above the ground plane. During the radiated emissions test, the turntable is rotated and any cables leaving the EUT are manipulated to find the configuration resulting in maximum emissions. The EUT is adjusted through all three orthogonal axes to obtain maximum emission levels. The antenna height and polarization are varied during the testing to search for maximum signal levels.

Detector function for radiated emissions is in peak mode. Average readings, when required, are taken by measuring the duty cycle of the equipment under test and subtracting the corresponding amount in dB from the measured peak readings. A detailed description for the calculation of the average factor can be found in Exhibit 8.3.

The frequency range scanned is from the lowest radio frequency signal generated in the device which is greater than 9 kHz to the tenth harmonic of the highest fundamental frequency or 40 GHz, whichever is lower.

#### 8.4 Emissions Test Procedures (cont'd)

The EUT is warmed up for 15 minutes prior to the test.

AC power to the unit is varied from 85% to 115% nominal and variation in the fundamental emission field strength is recorded. If battery powered, a new, fully charged battery is used.

Conducted measurements are made as described in ANSI C63.10 - 2013.

The IF bandwidth used for measurement of radiated signal strength was 10 kHz for emission below 30 MHz and 120 kHz for emission from 30 MHz to 1000 MHz. Where pulsed transmissions of short enough pulse duration warrant, a greater bandwidth is selected according to the recommendations of Hewlett Packard Application Note 150-2. A discussion of whether pulse desensitivity is applicable to this unit is included in this report (See Exhibit 8.2).

Transmitter measurements are normally conducted at a measurement distance of three meters. However, to assure low enough noise floor in the restricted bands, signals are acquired at a distance of one meter or less. All measurements are extrapolated to three meters using inverse scaling, but those measurements taken at a closer distance are so marked.
