#### **GENERAL INFORMATION**

#### **Product Description for Equipment under Test (EUT)**

The *Kenyazi Investment Limited*'s product, model number: 67816 (FCC ID: PKH-678XX-RX) or the "EUT" in this report was the receiver unit of an *Outdoor Remote Control LNS*, which was measured approximately: 21.5 cm (L) x 13 cm (W) x 10 cm (H), rated with input voltage: AC 120V/60Hz. The highest operating frequency is 433.92 MHz.

Note: Product Outdoor Remote Control LNS, model 67816, 67817, 67818, 67819, 67825, 67826, 67827, 67828 and 67829 are electrically identical, they have the same PCB layout and schematic, the difference between them is just the model number due to marketing purposes, which was explained in the attached declaration letter. Model 67816 was selected for fully testing, which was stated and guarantied by the applicant.

\*All measurement and test data in this report was gathered from production sample serial number: 1305113 (Assigned by BACL, Shenzhen). The EUT supplied by the applicant was received on 2013-05-21.

#### **Objective**





Correction Factor = LISN VDF + Cable Loss







The external I/O cables were draped along the test table and formed a bundle 30 to 40 cm long in the middle.

The spacing between the peripherals was 10 cm.

#### **EMI Test Receiver Setup**

The system was investigated from 30 MHz to 2 GHz.

#### **Corrected Amplitude & Margin Calculation**

The Corrected Amplitude is calculated by adding the Antenna Factor and Cable Loss, and subtracting the Amplifier Gain from the Meter Reading. The basic equation is as follows:
