
2.1 Test Mode

During all testing, EUT is in link mode with base station emulator at maximum power level. The spurious emission measurements were carried out in semi-anechoic chamber with 3-meter test range, and EUT is rotated on three test planes to find out the worst emission.

Frequency range investigated for radiated emission is 30 MHz to 9000 MHz.

3 Test Result

3.1 Field Strength of Spurious Radiation Measurement

3.1.1 Description of Field Strength of Spurious Radiated Measurement

The radiated spurious emission was measured by substitution method according to ANSI/TIA-603-E. The power of any emission FCC Part 90.691 on any frequency removed from the assigned frequency by more than 250 percent of the authorized bandwidth at least 43 + 10 log (P) dB. The spectrum is scanned from 30 MHz up to a frequency including its 10th harmonic.

The power of any emission outside of the authorized operating frequency ranges must be attenuated below the transmitter power (P) by a factor of at least 43+10log₁₀(P[Watts]) dB. The spectrum is scanned from 30 MHz up to a frequency including its 10th harmonic.

3.1.2 Measuring Instruments

The measuring equipment is listed in the section 4 of this test report.

3.1.3 Test Procedures

- 1. The EUT was placed on a turntable with 0.8 meter for frequency below 1GHz and 1.5 meter for frequency above 1GHz respectively above ground.
- 2. The EUT was set 3 meters from the receiving antenna, which was mounted on the antenna tower.
- 3. The table was rotated 360 degrees to determine the position of the highest spurious emission.
- 4. The height of the receiving antenna is varied between one meter and four meters to search the maximum spurious emission for both horizontal and vertical polarizations.
- 5. Make the measurement with the spectrum analyzer's RBW = 1MHz, VBW = 3MHz, Sweep = 500ms, Taking the record of maximum spurious emission.
- 6. A horn antenna was substituted in place of the EUT and was driven by a signal generator.
- 7. Tune the output power of signal generator to the same emission level with EUT maximum spurious emission.
- 8. Taking the record of output power at antenna port.
- 9. Repeat step 7 to step 8 for another polarization.
- 10. EIRP (dBm) = S.G. Power Tx Cable Loss + Tx Antenna Gain
- 11. ERP (dBm) = EIRP 2.15
- The RF fundamental frequency should be excluded against the limit line in the operating frequency band.
- 13. The limit line is derived from 43 + 10log(P) dB below the transmitter power P(Watts)




