

MPE Calculations(WLAN: 802.11b)

- Frequency range : 2412 MHz ~ 2462 MHz
- Maximum RF output power : 16.11 dBm
- Maximum antenna peak gain : 2.1 dBi

The EUT will only be used with a separation of 20 centimeters or greater between the antenna and the body of the user.
