#### Part 2: Driver Installation

1. Insert the PCS Connection Card into your computer's **PC Card slot** (Sprint label facing up). Then raise the antenna so that it is fully extended and pointed up at a 90 degree angle. Use in any other configuration may exceed FCC RF Exposure limits.
