Lower Emission Mask (763 MHz ~ 775 MHz)-16QAM-25RB#0



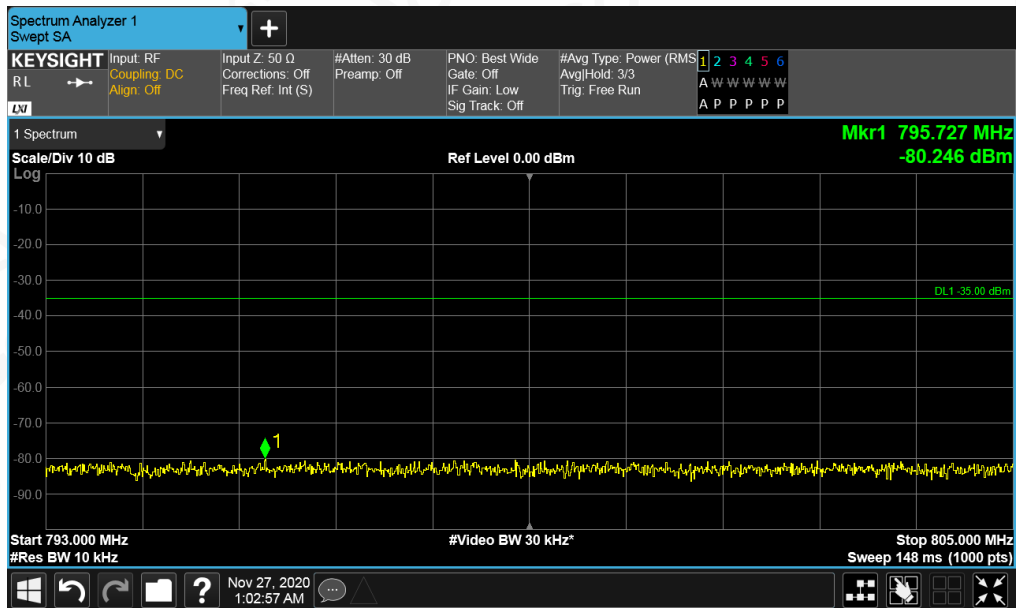

### Lower Emission Mask (769 MHz ~ 775 MHz)-16QAM-25RB#0



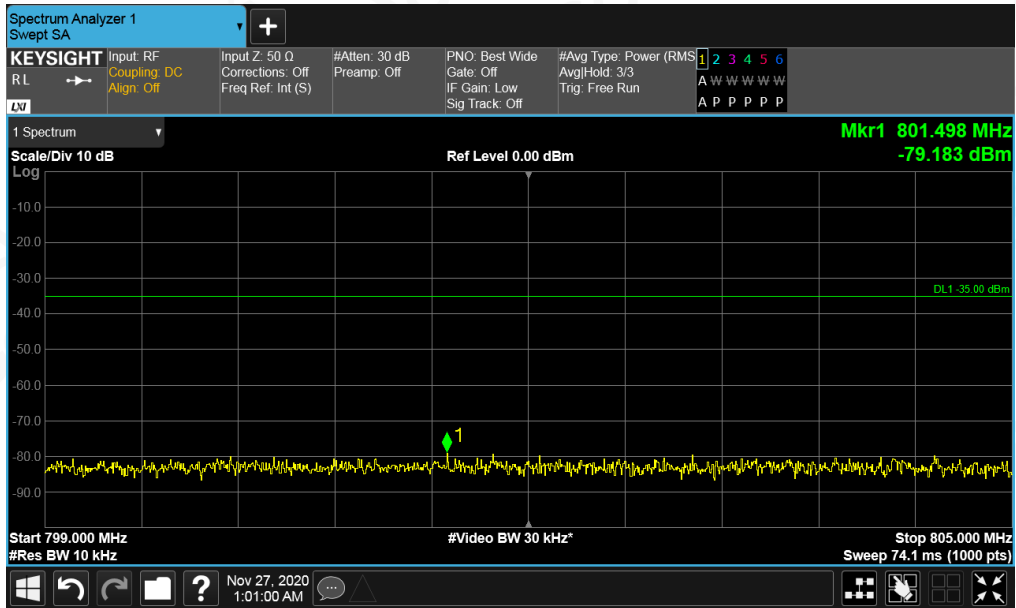

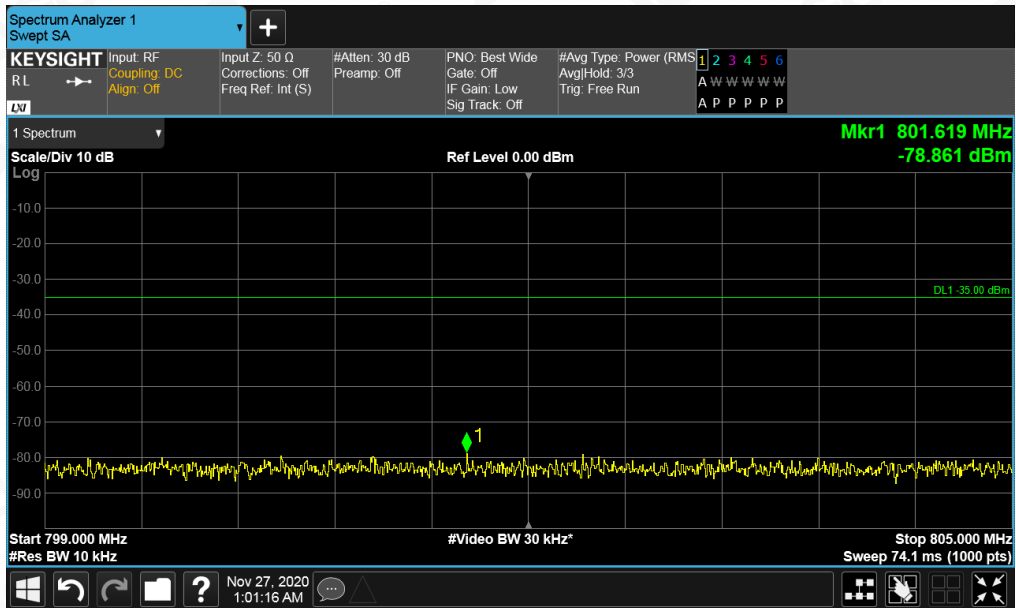




Upper Emission Mask (799 MHz ~805 MHz) -QPSK-25RB#0



Upper Emission Mask (799 MHz ~805 MHz) -16QAM-25RB#0

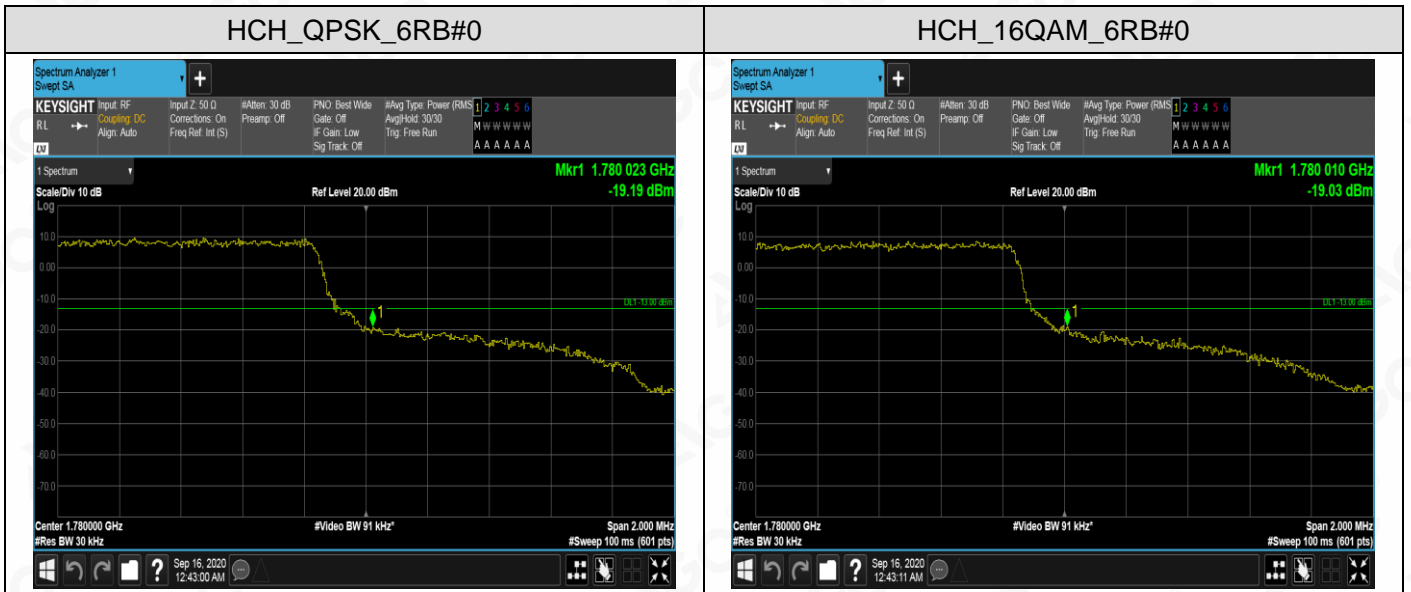
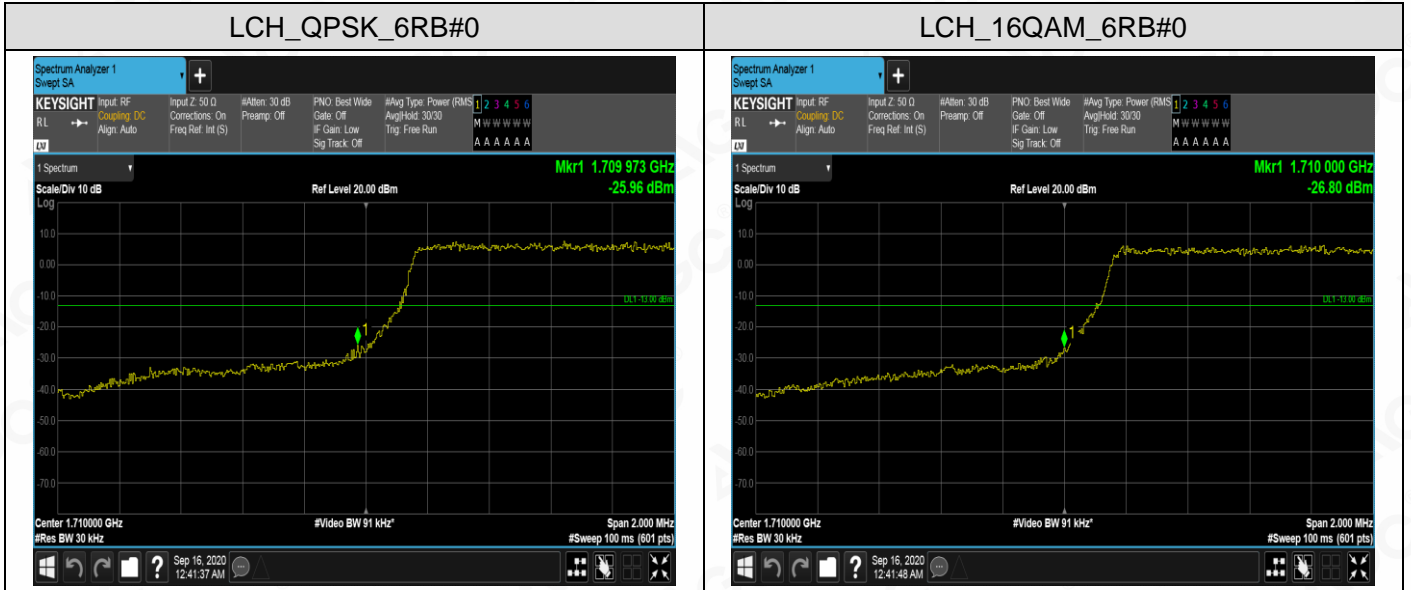
