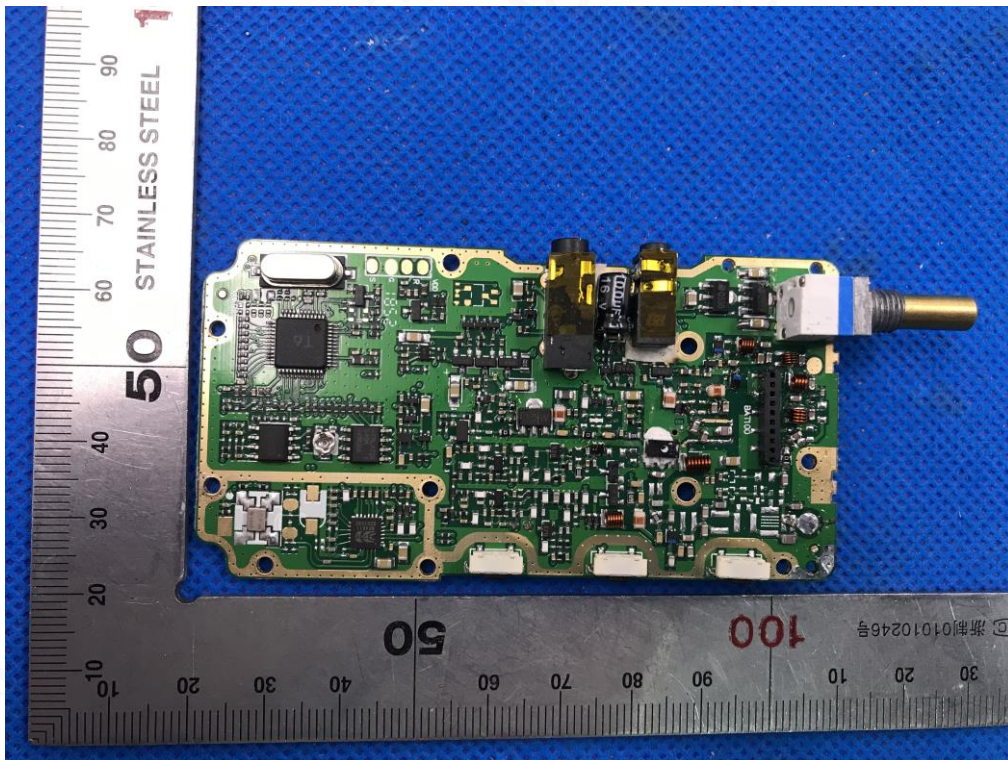

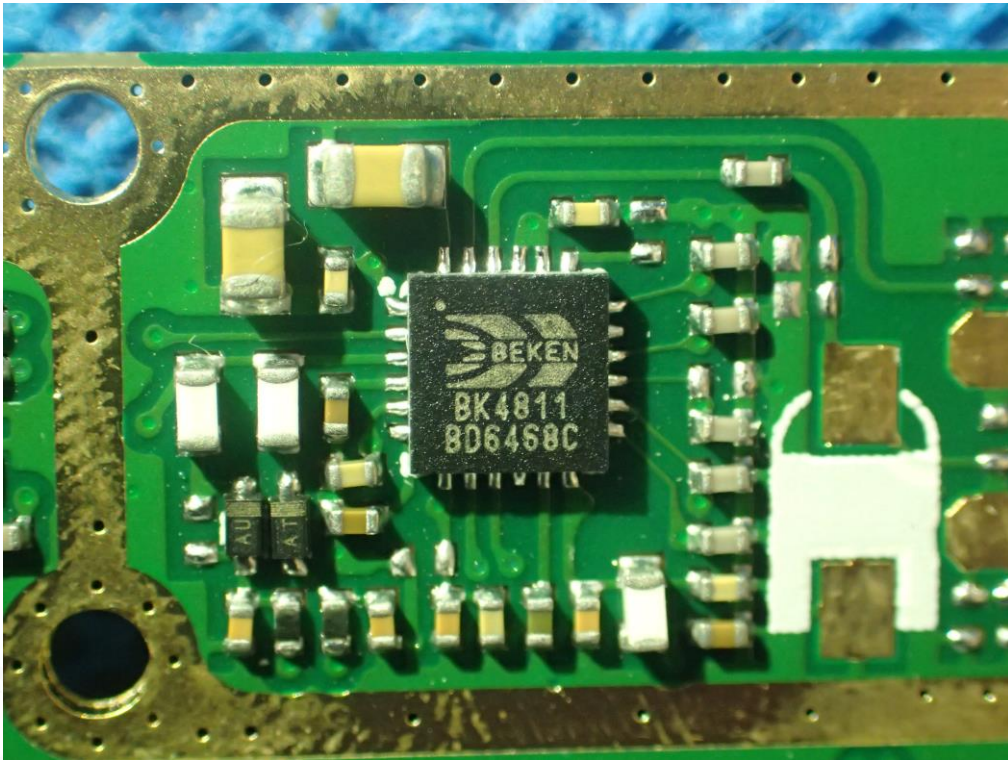

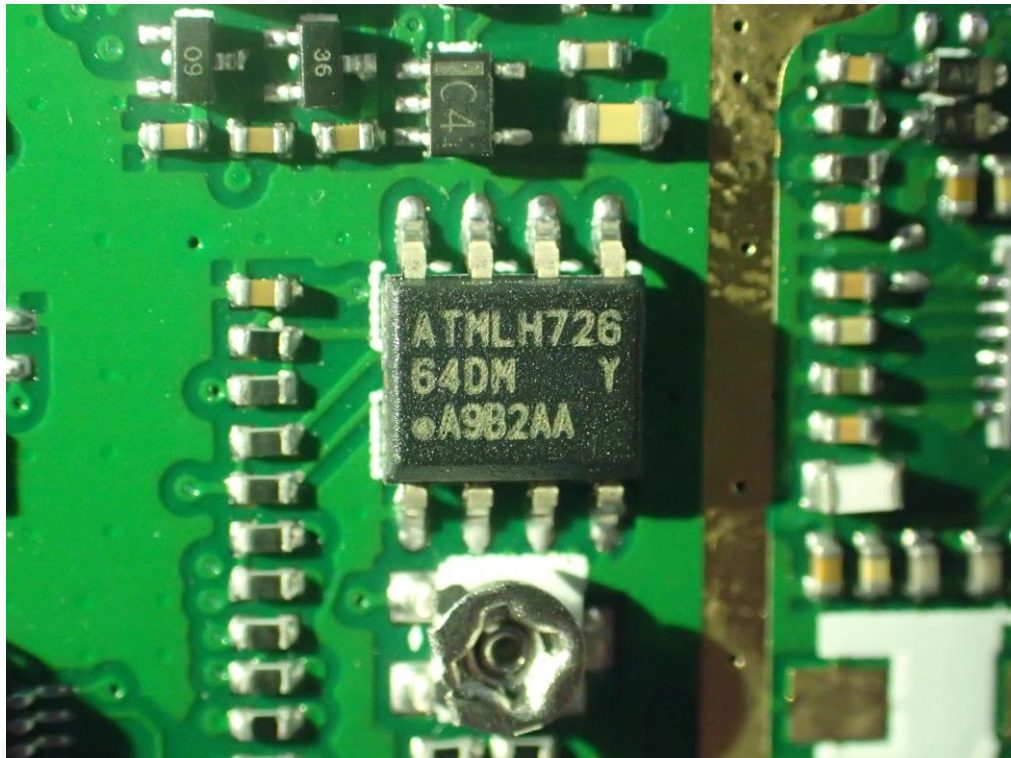
INTERNAL VIEW OF EUT(FIGURE 4)



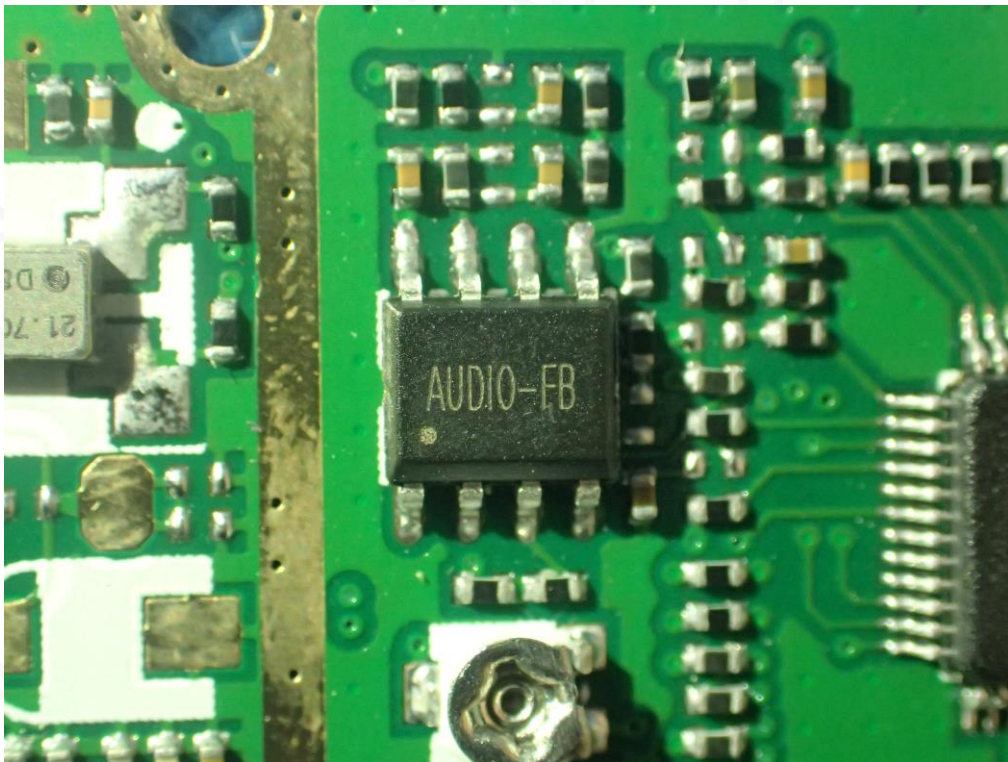

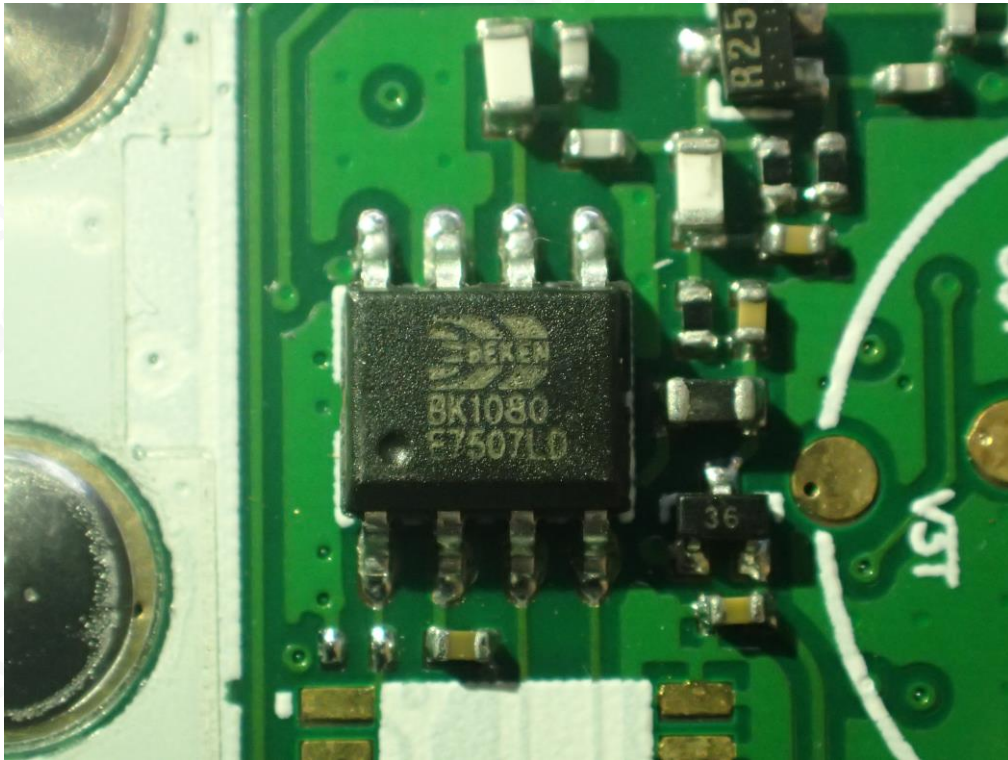

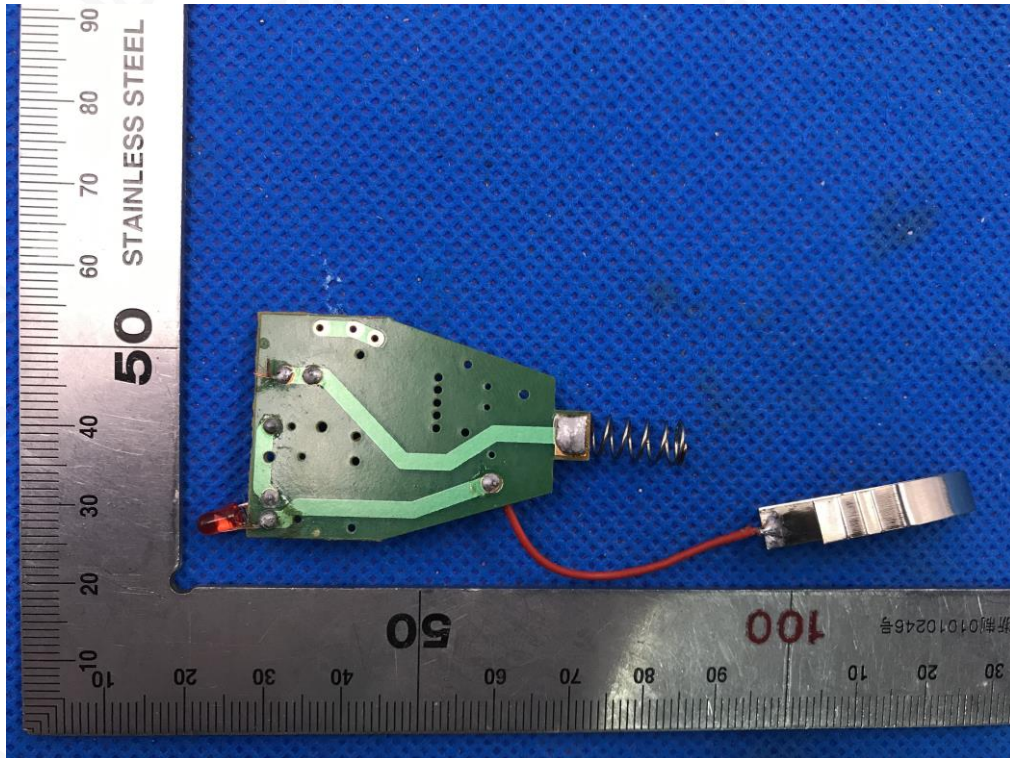

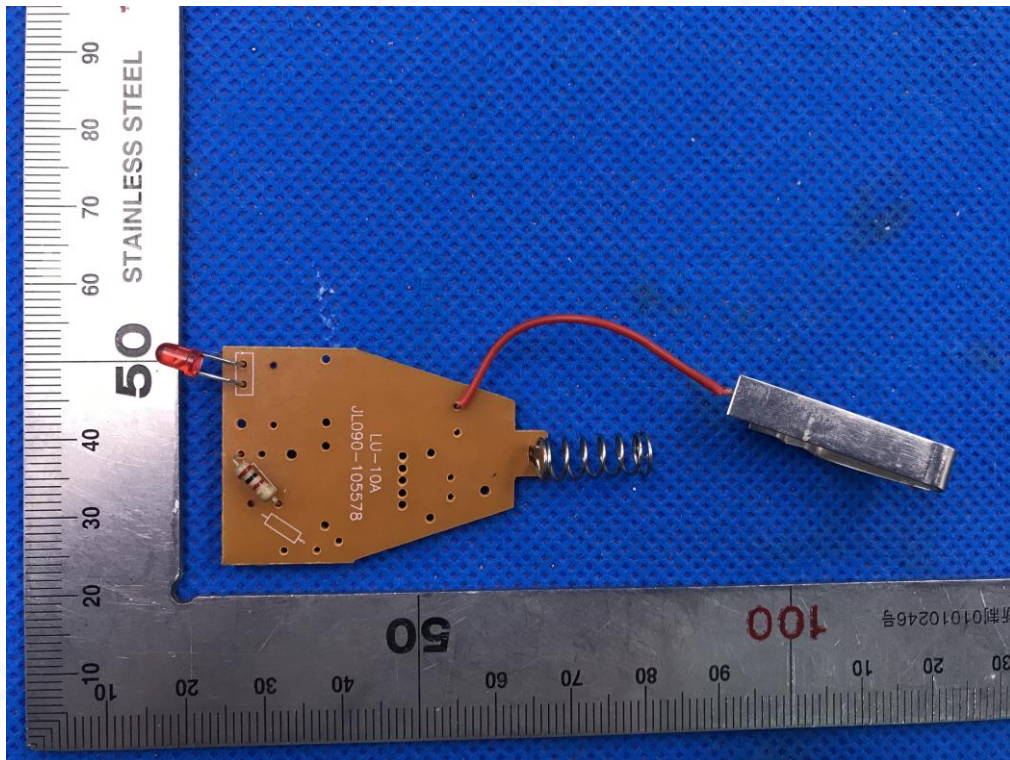

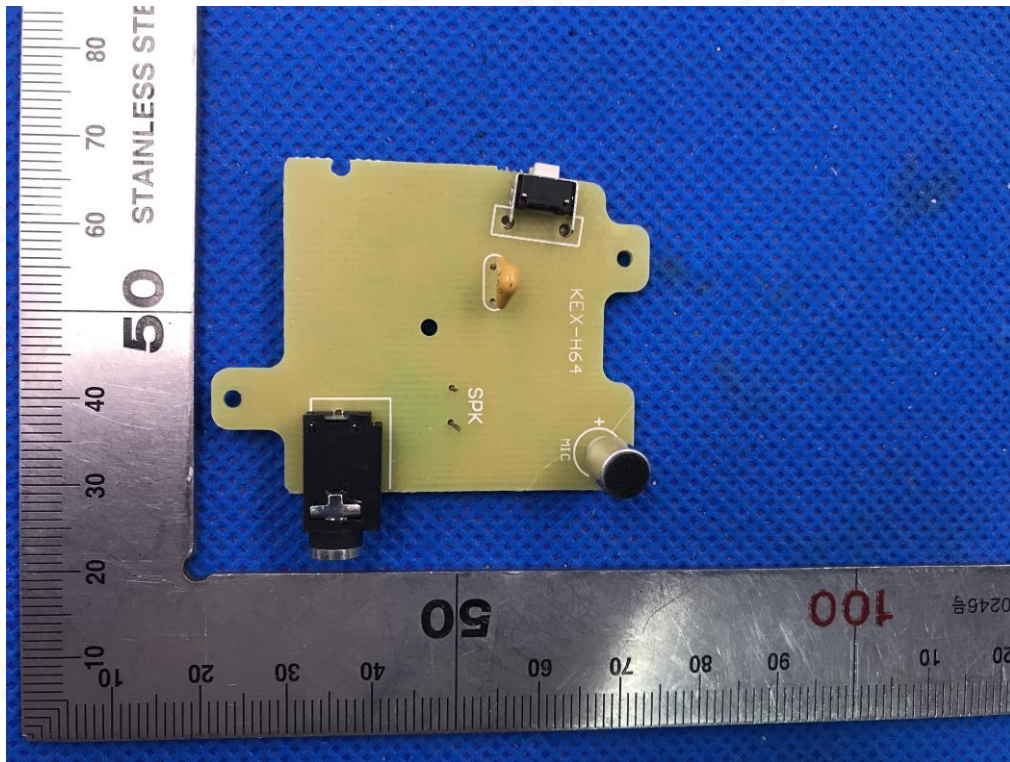
