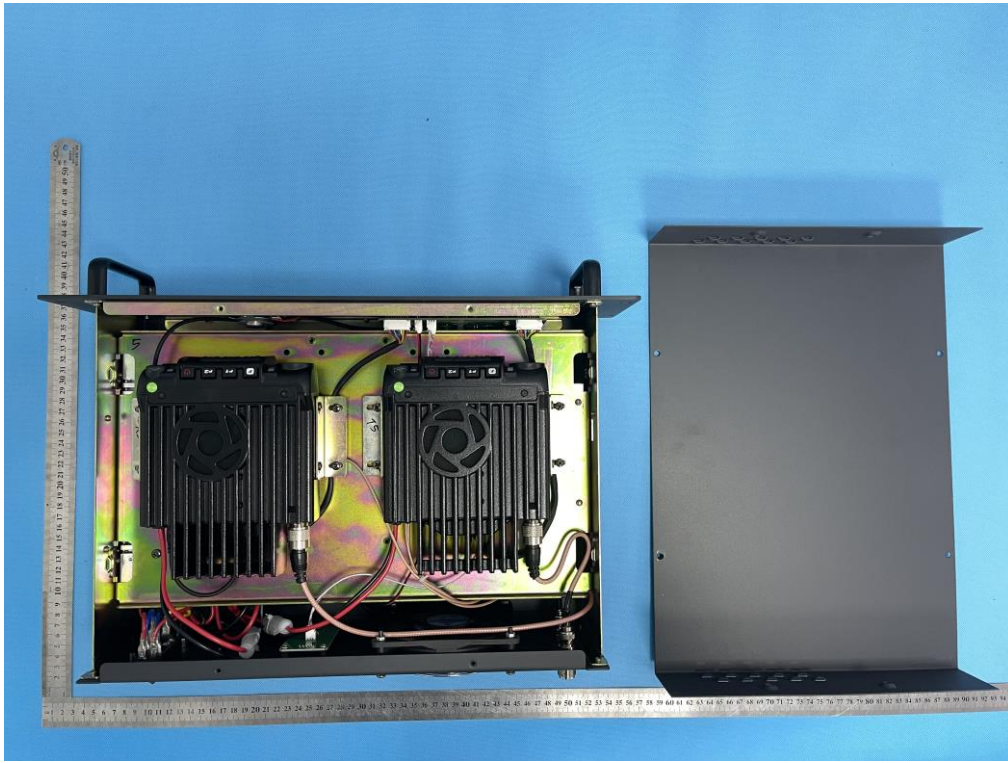


INTERNAL PHOTOS OPEN VIEW OF EUT (FIGURE 1)

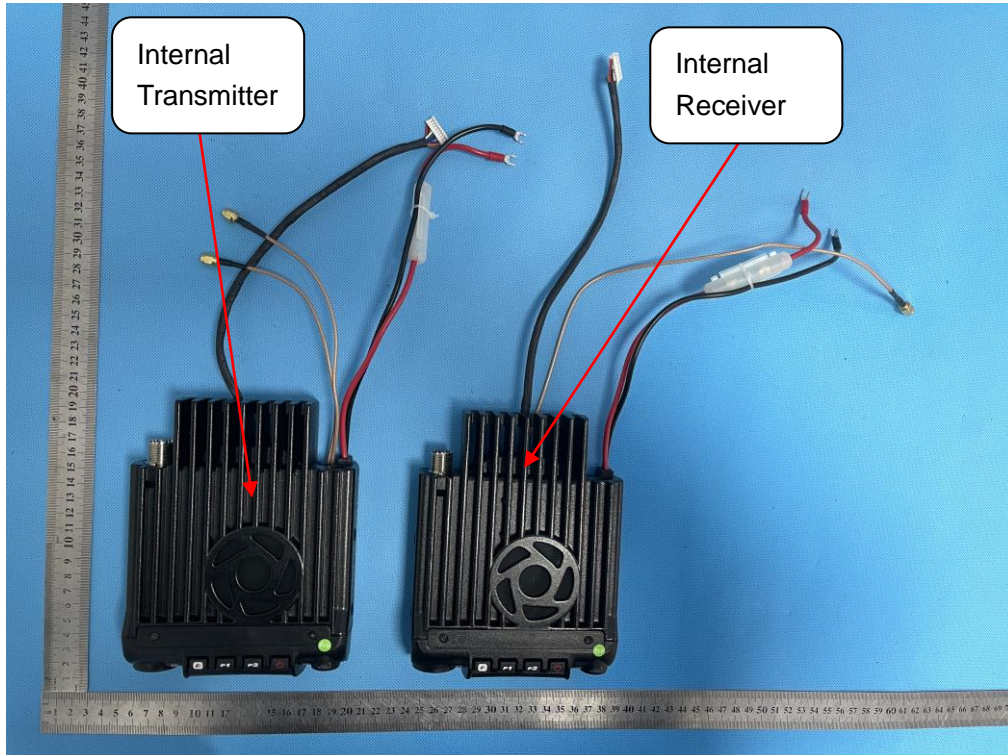


OPEN VIEW OF EUT (FIGURE 2)

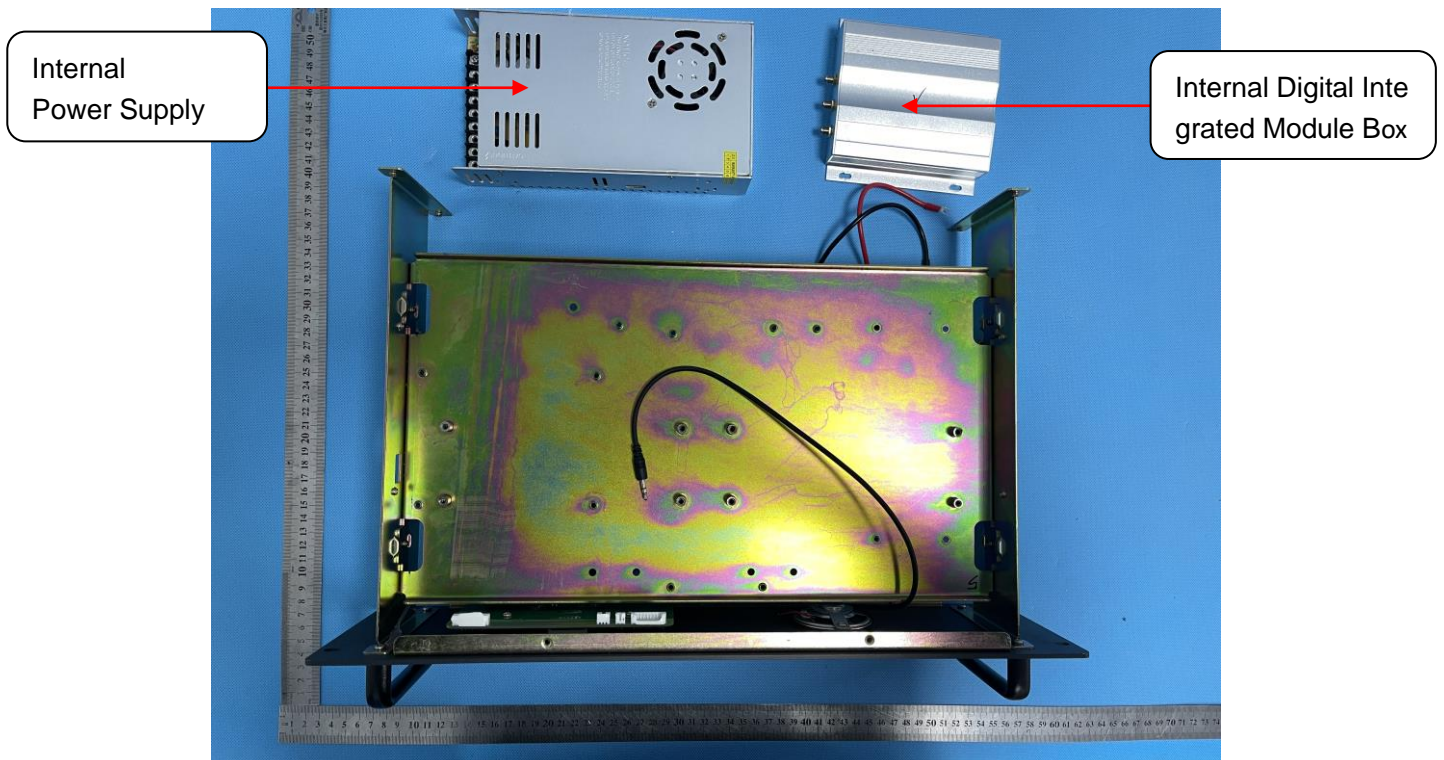

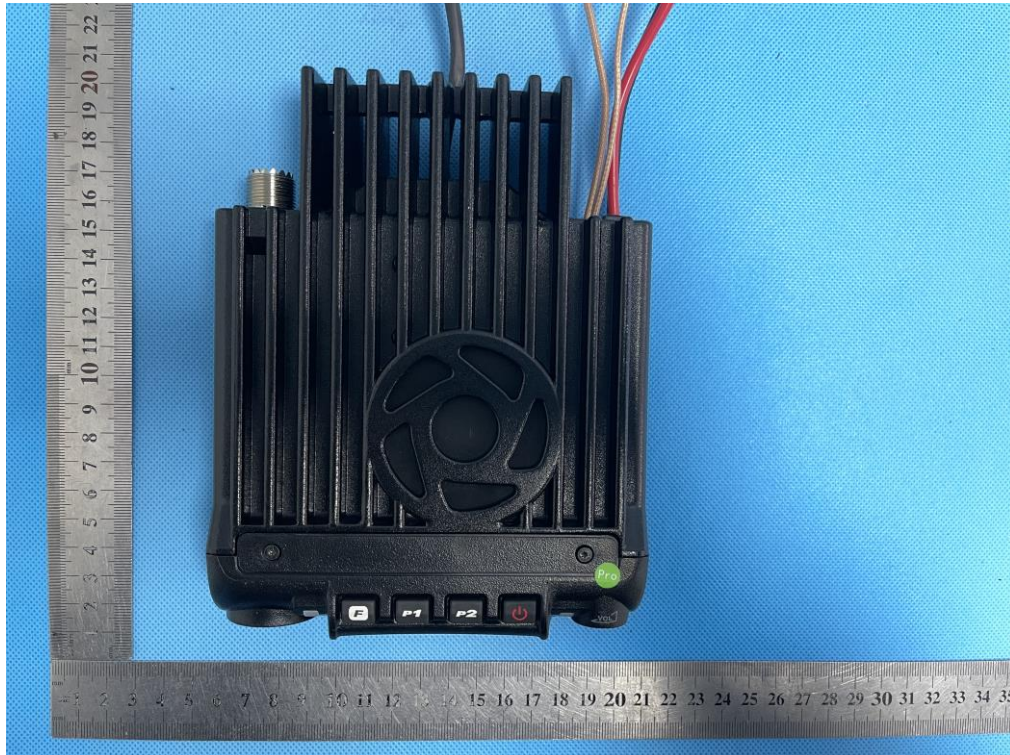
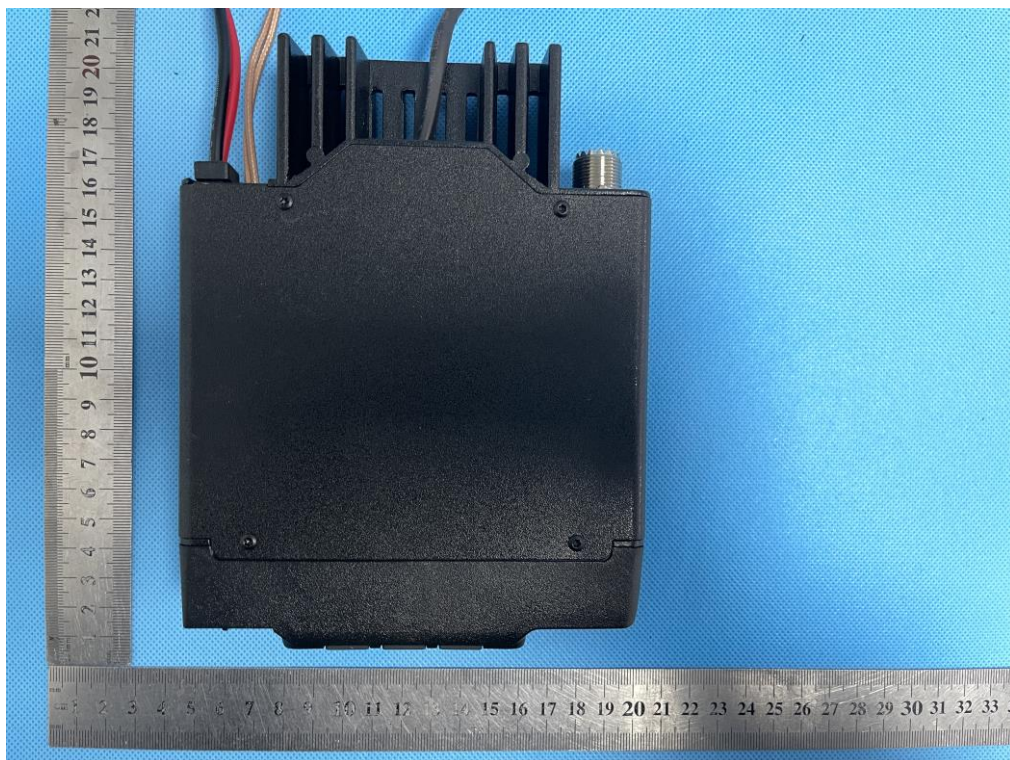

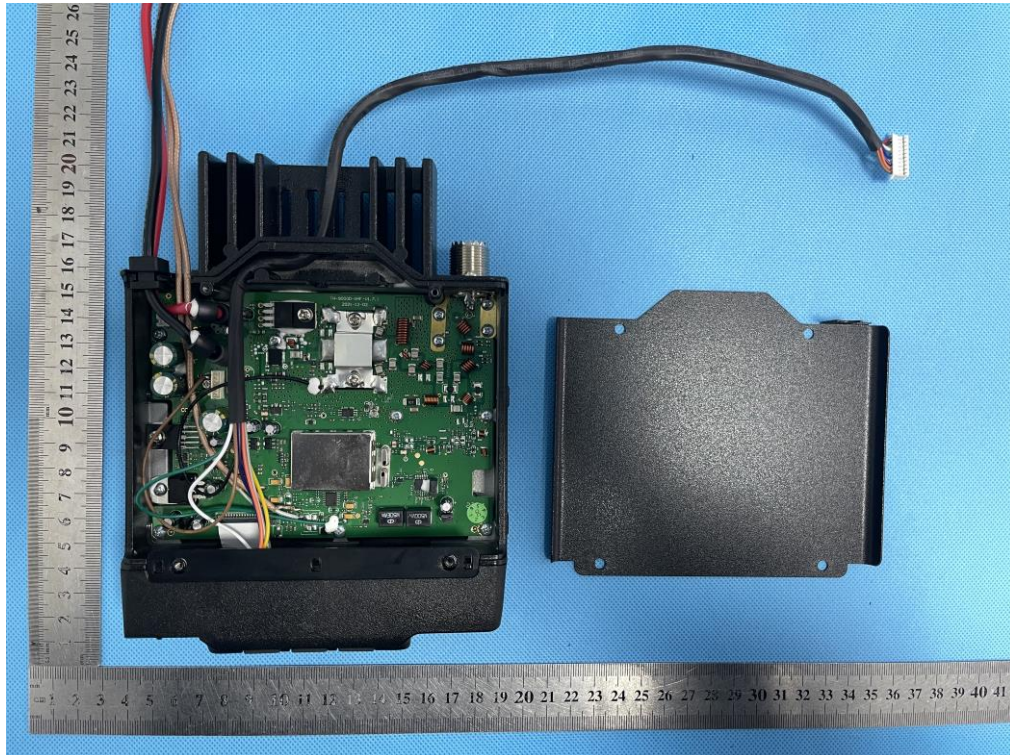


RIGHT VIEW OF INTERNAL TRANSMITTER

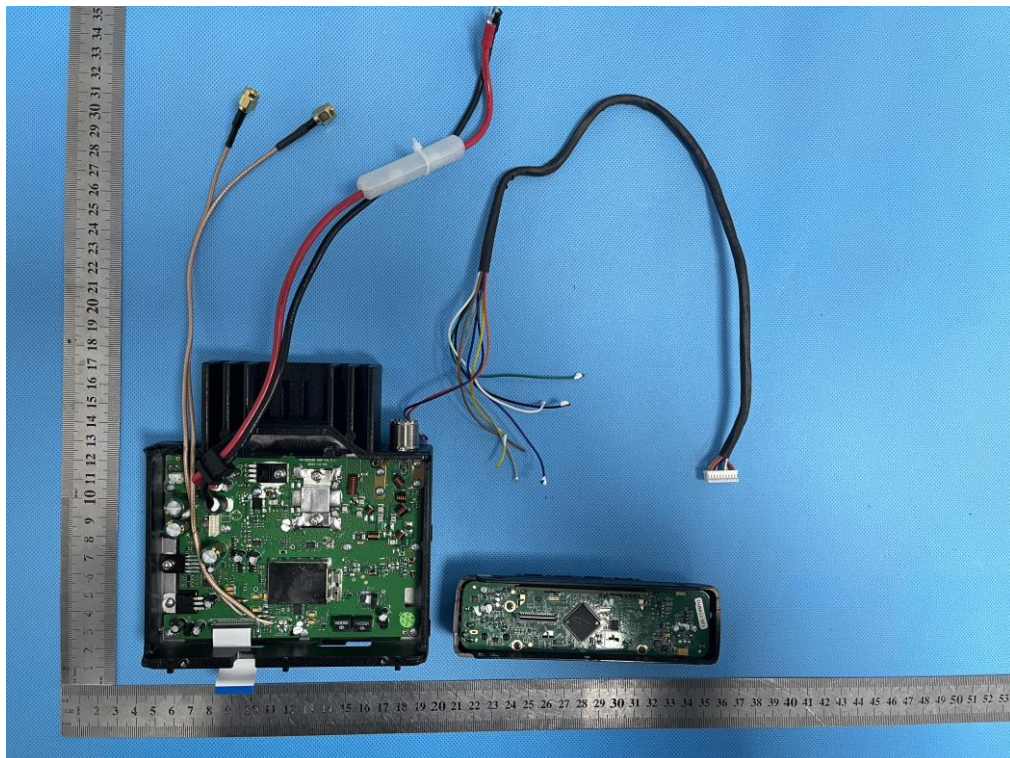

OPEN VIEW OF INTERNAL TRANSMITTER (FIGURE 1)

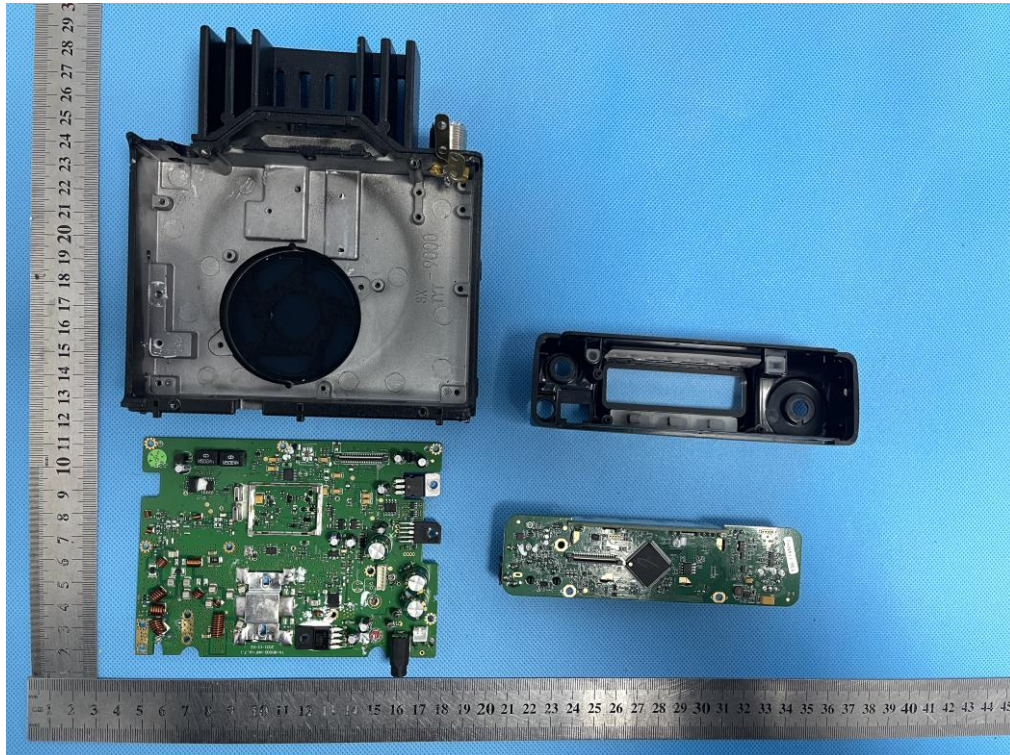


OPEN VIEW OF INTERNAL TRANSMITTER (FIGURE 2)

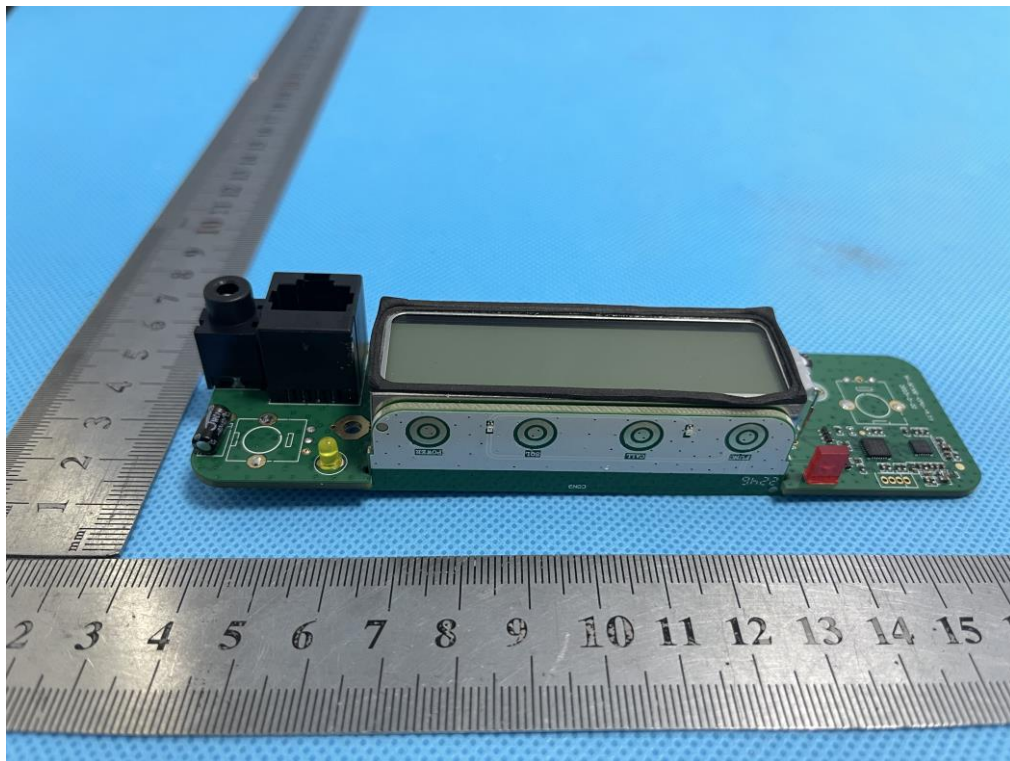

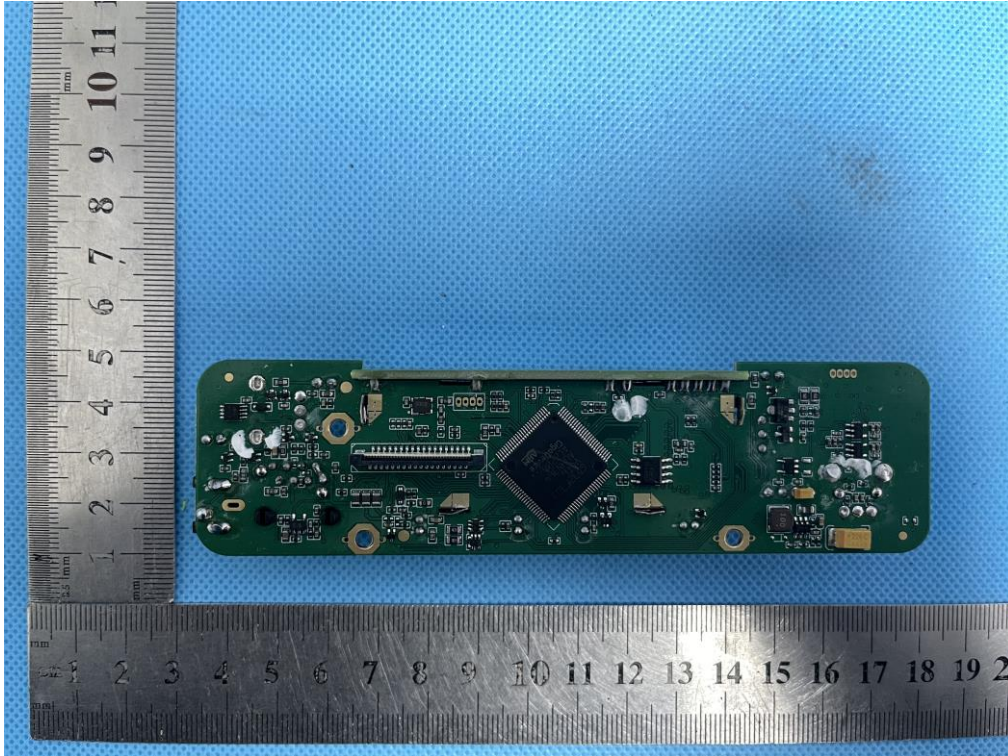


INTERNAL VIEW OF INTERNAL TRANSMITTER (FIGURE 1)

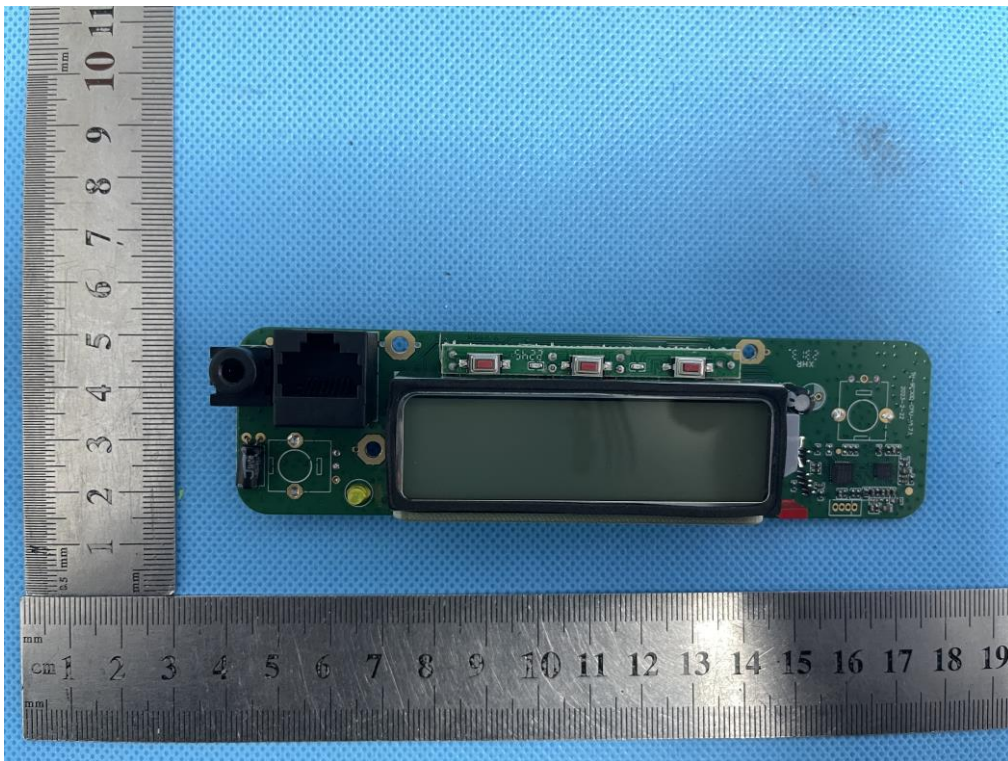

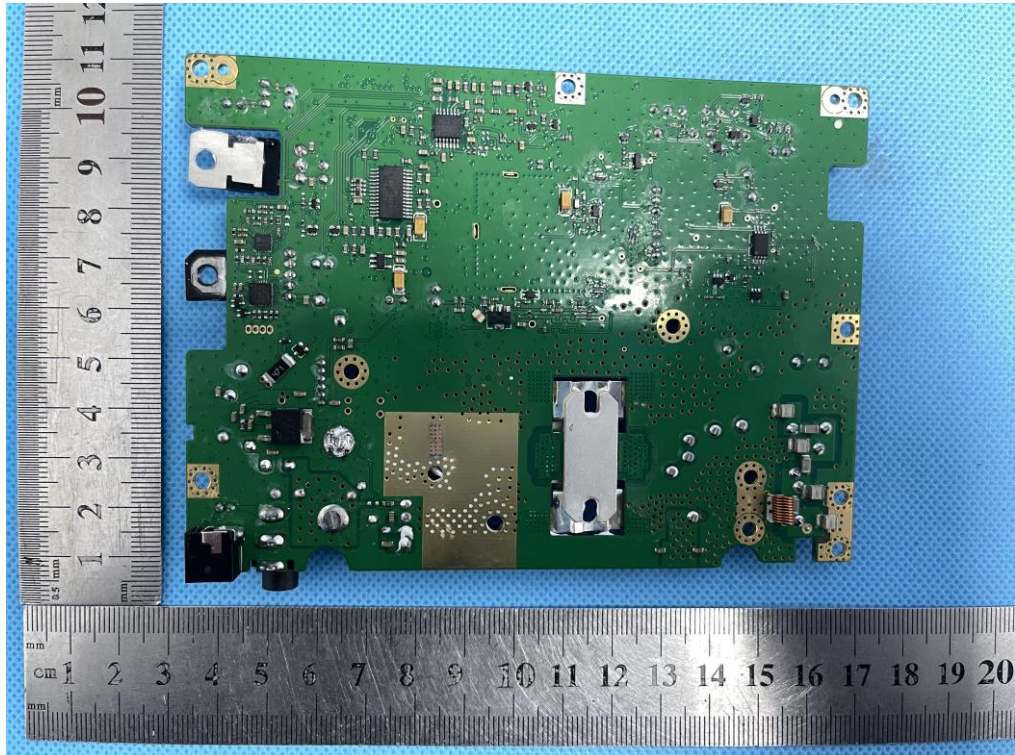


INTERNAL VIEW OF INTERNAL TRANSMITTER (FIGURE 3)

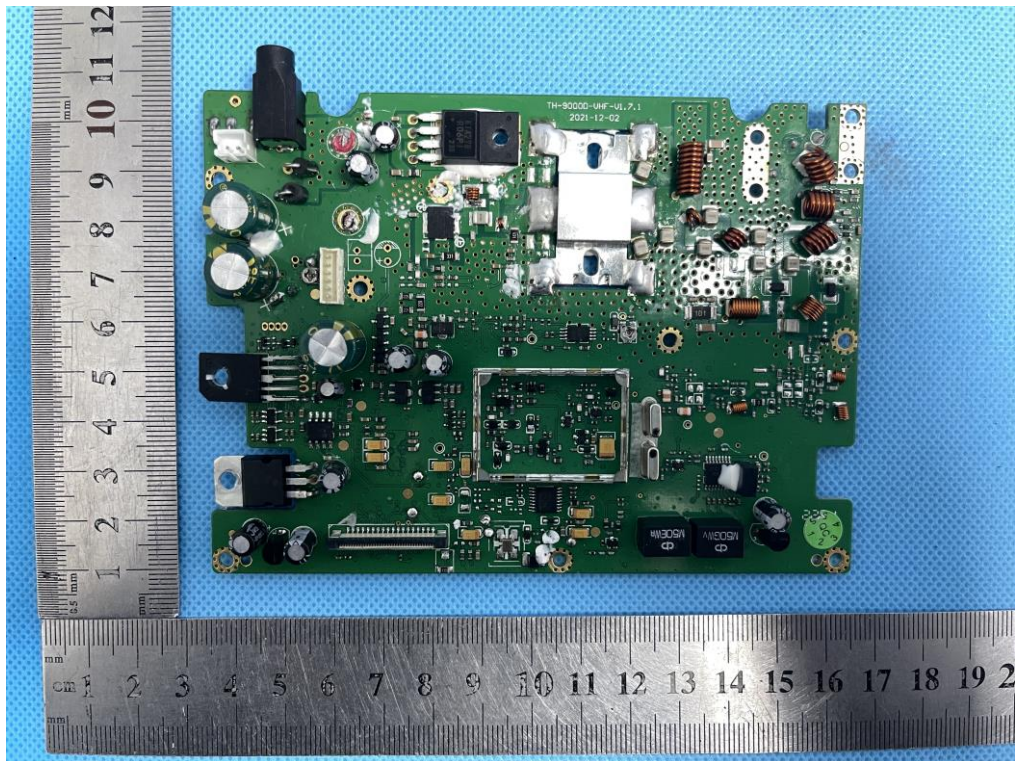

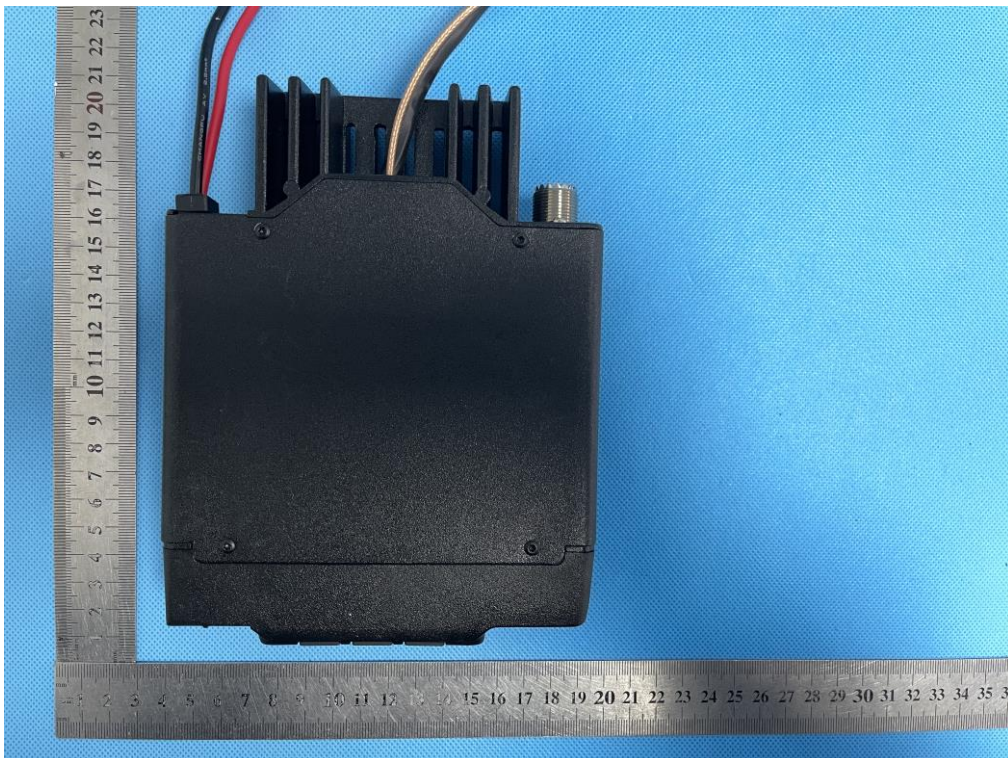

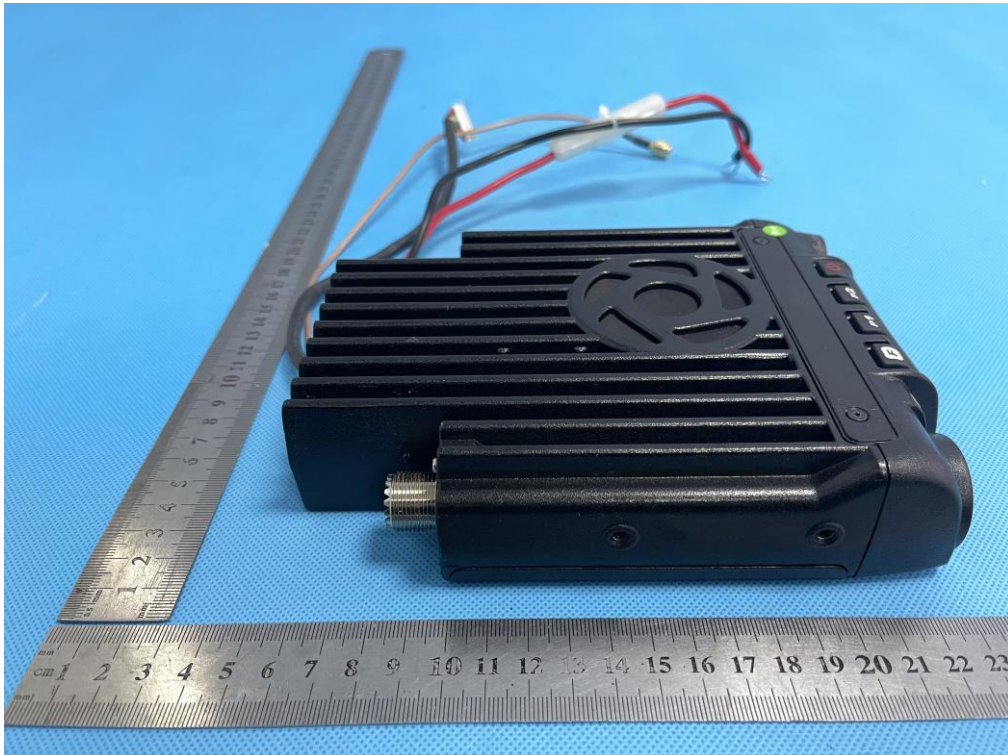


BACK VIEW OF INTERNAL RECEIVER

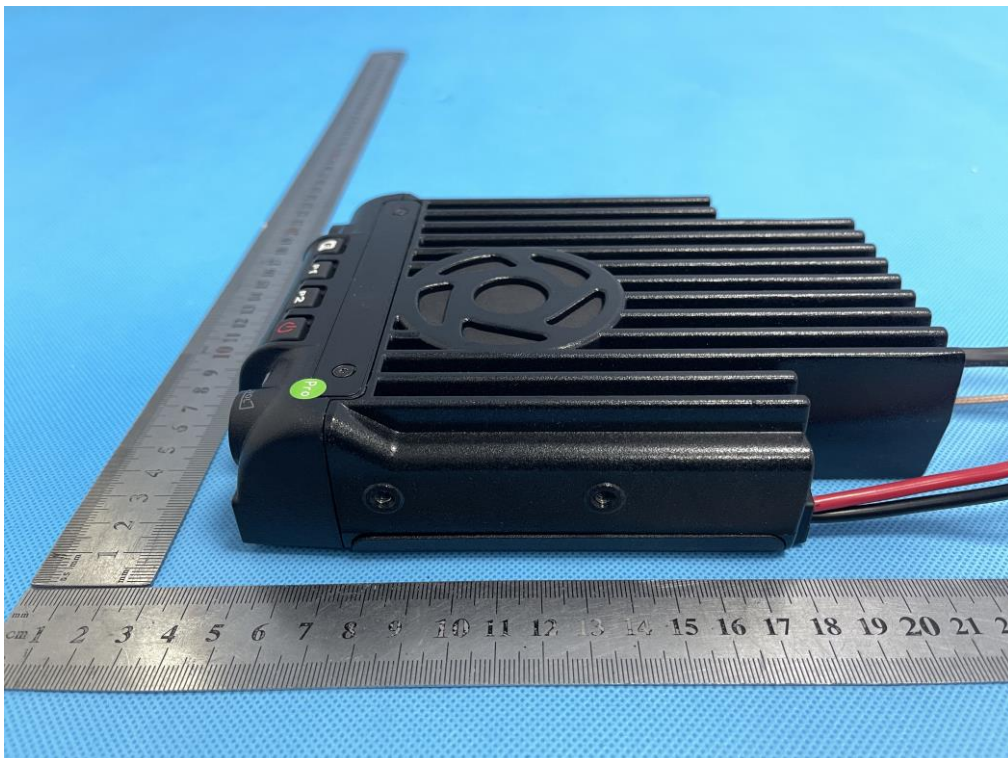

LEFT VIEW OF INTERNAL RECEIVER

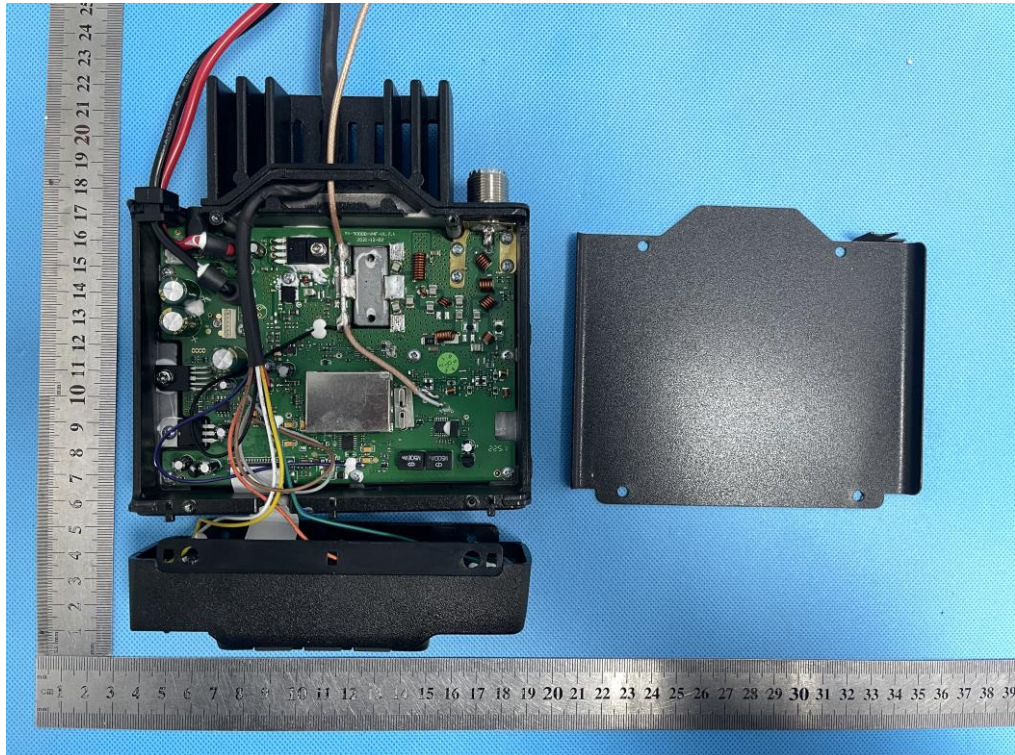


RIGHT VIEW OF INTERNAL RECEIVER

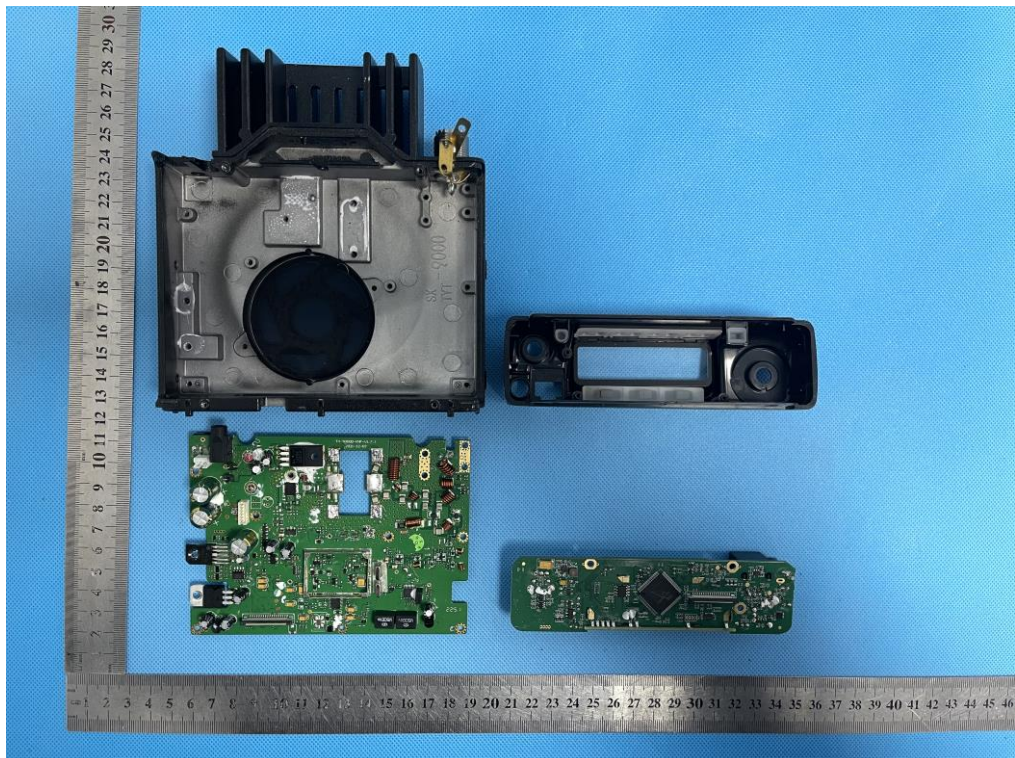

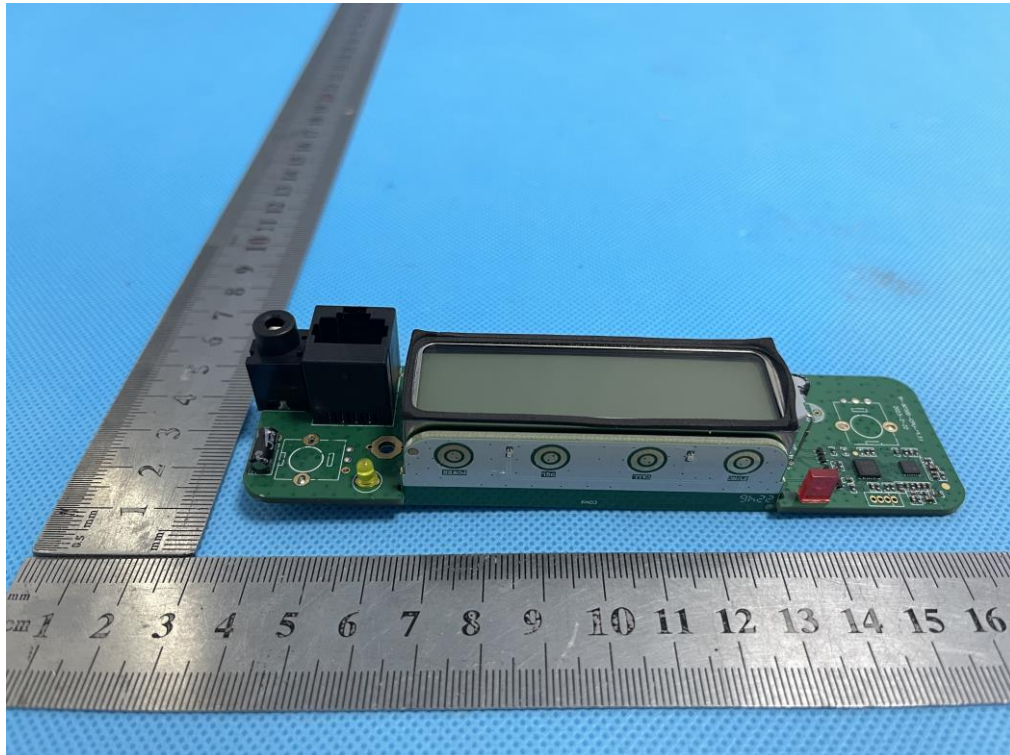


OPEN VIEW OF INTERNAL RECEIVER (FIGURE 2)

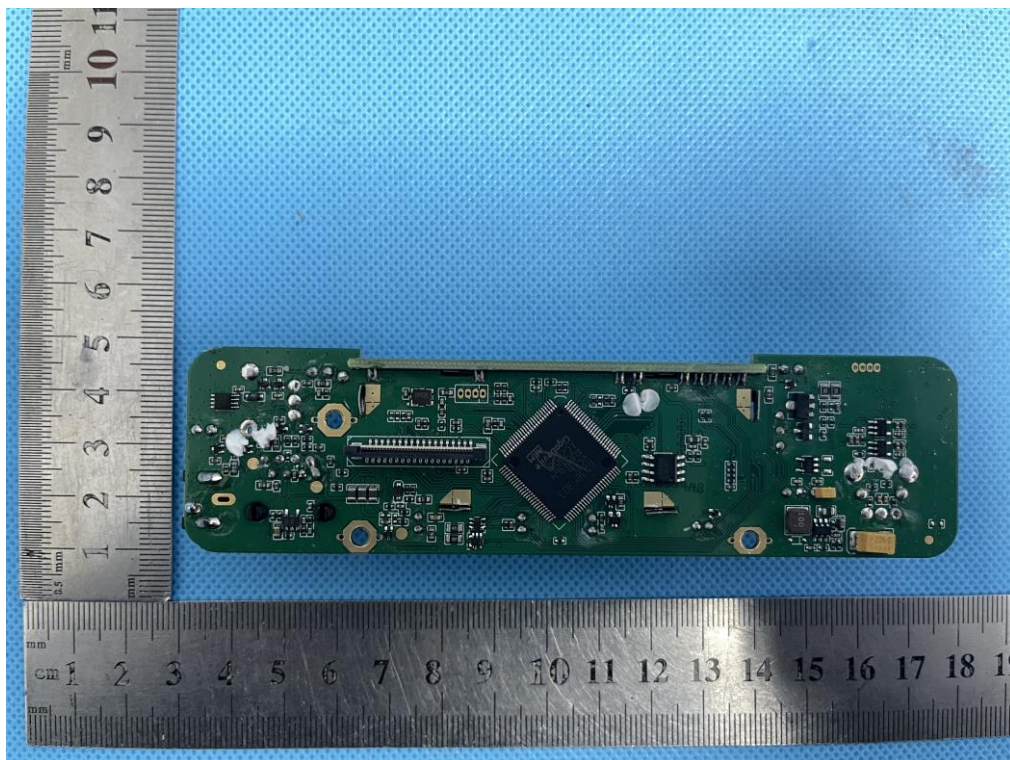
