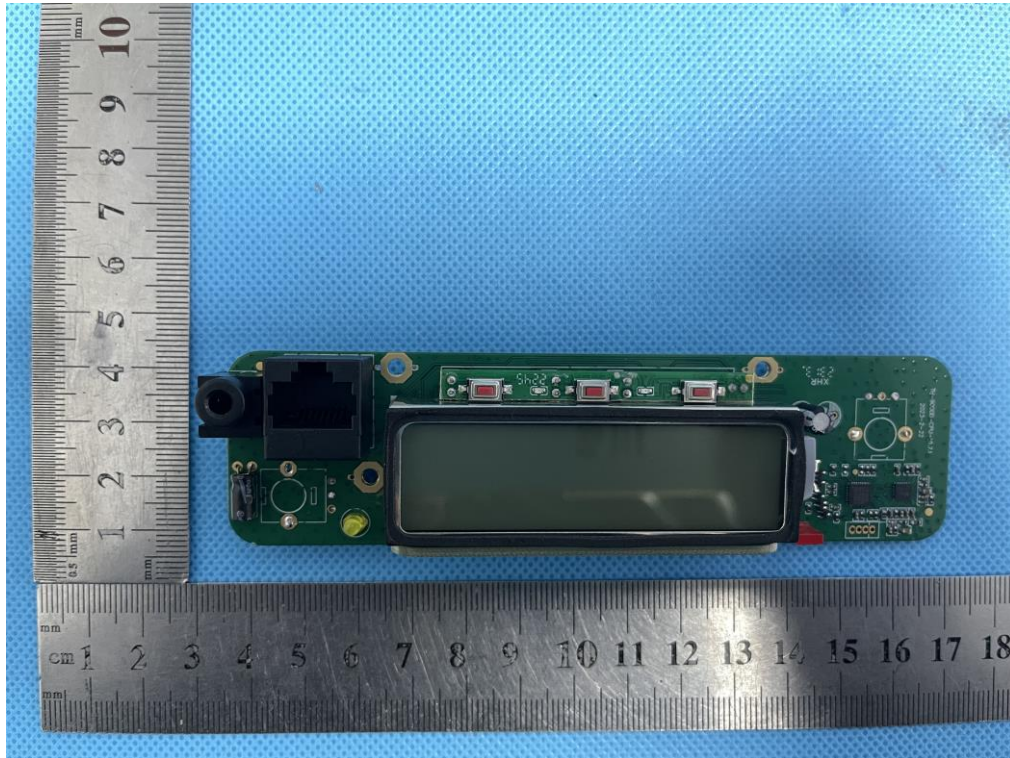
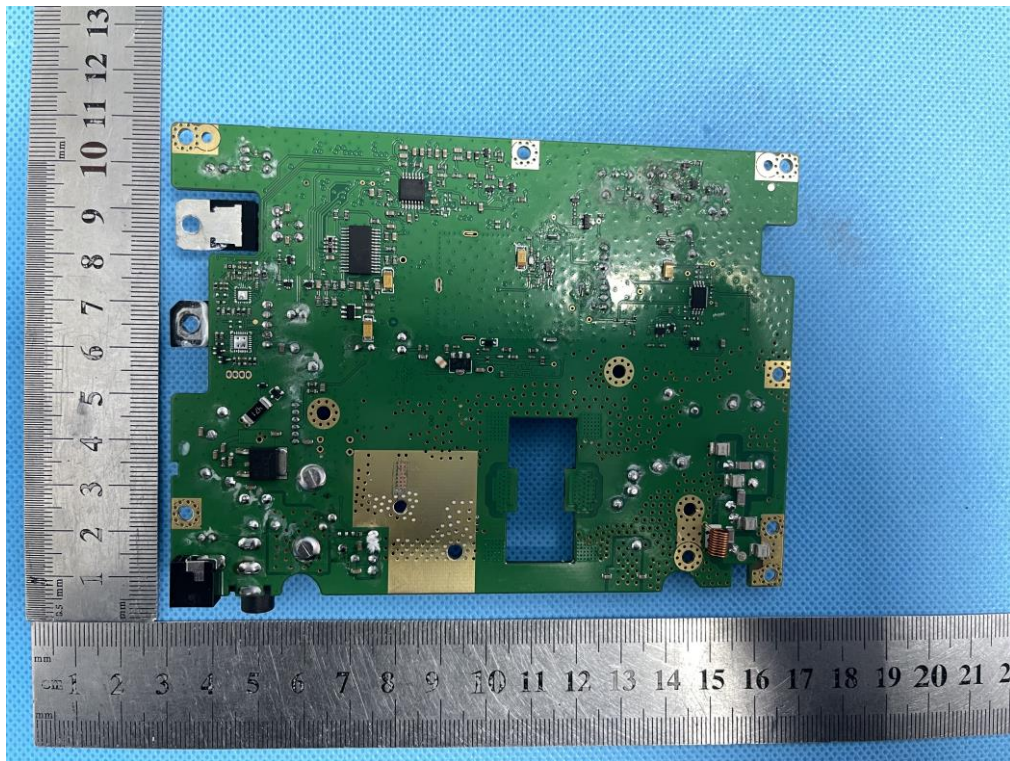


INTERNAL VIEW OF INTERNAL RECEIVER (FIGURE 3)

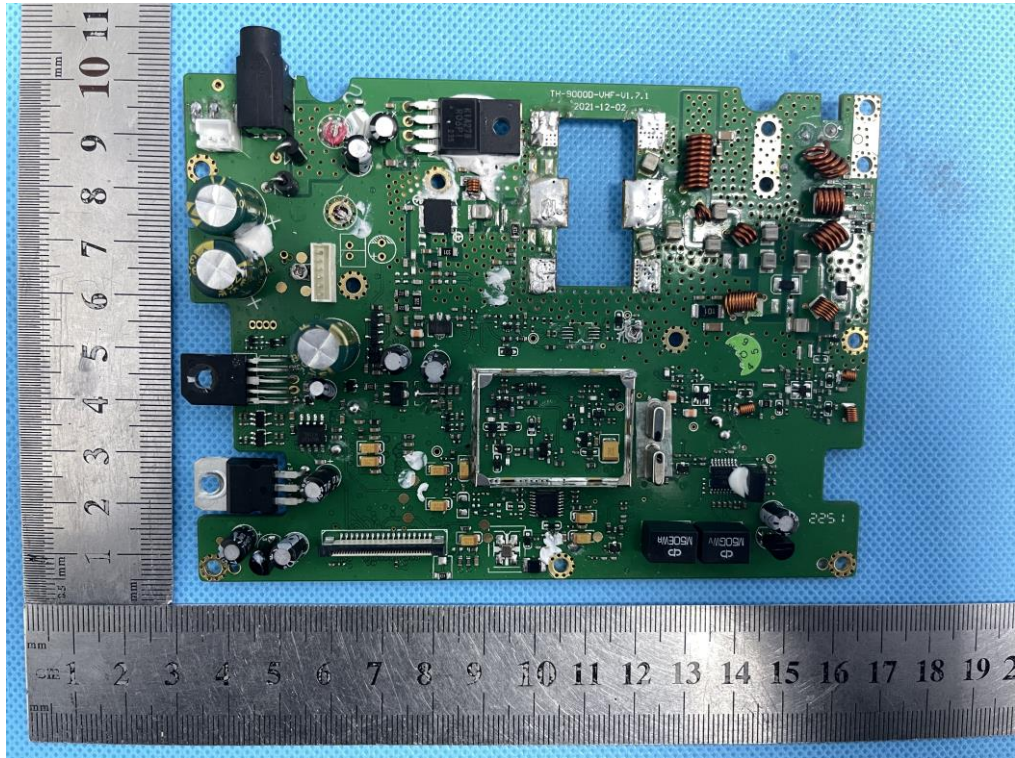


INTERNAL VIEW OF INTERNAL RECEIVER (FIGURE 4)

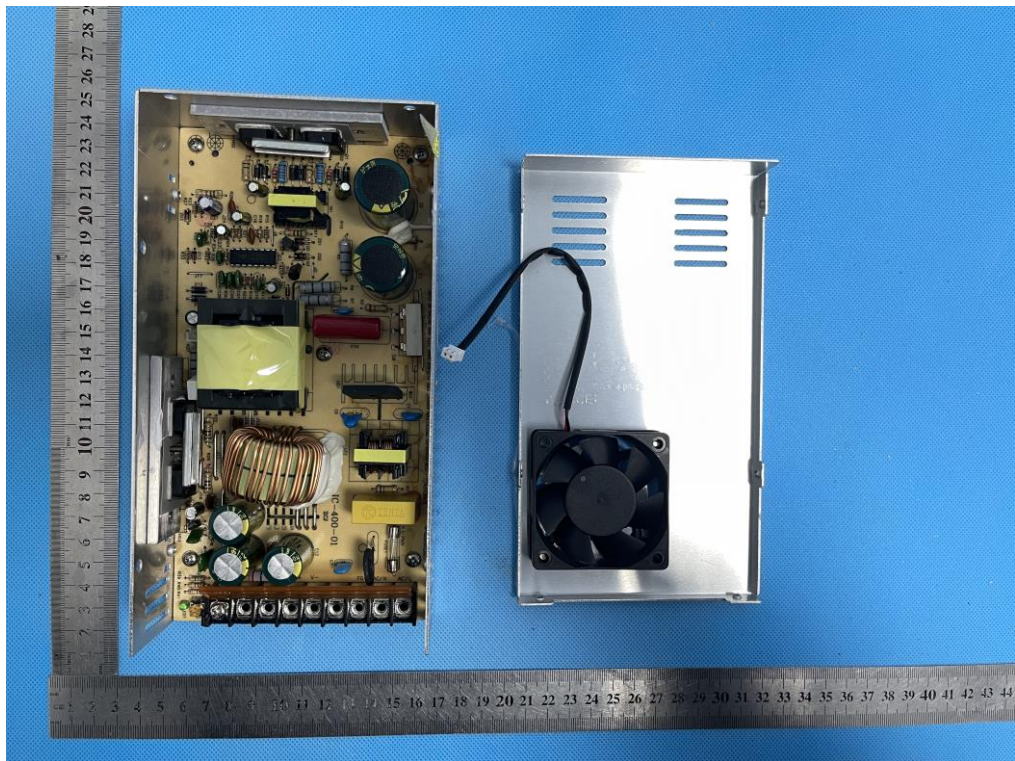

INTERNAL VIEW OF INTERNAL RECEIVER (FIGURE 5)

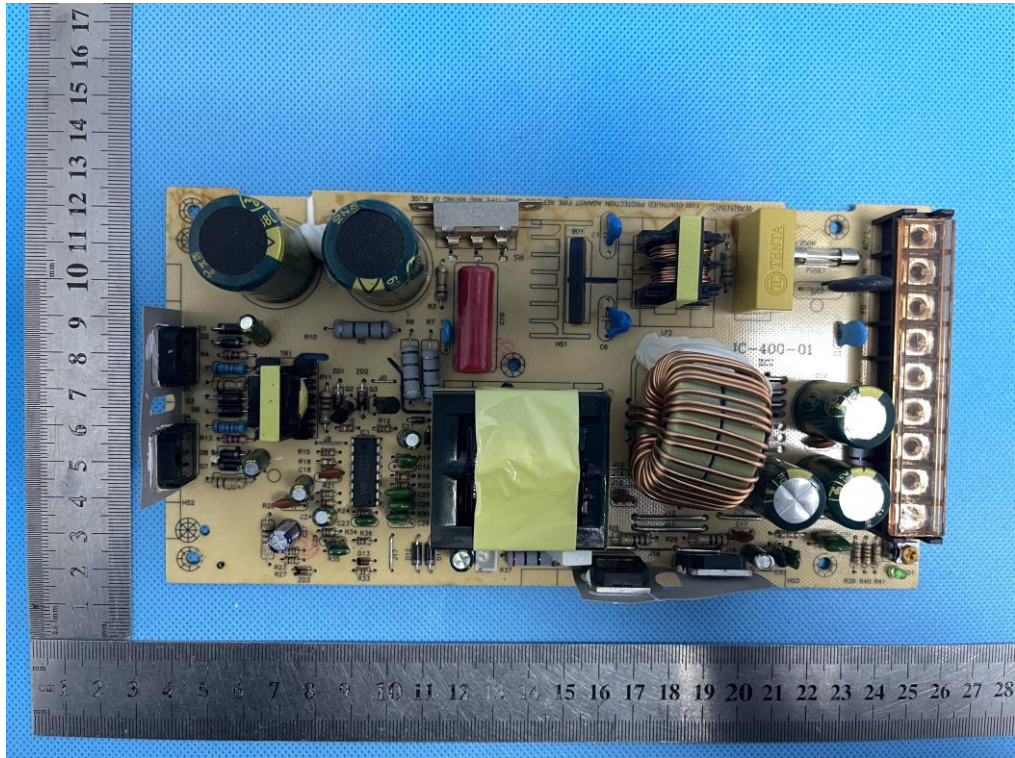


OPEN VIEW OF INTERNAL POWER SUPPLY (FIGURE 1)

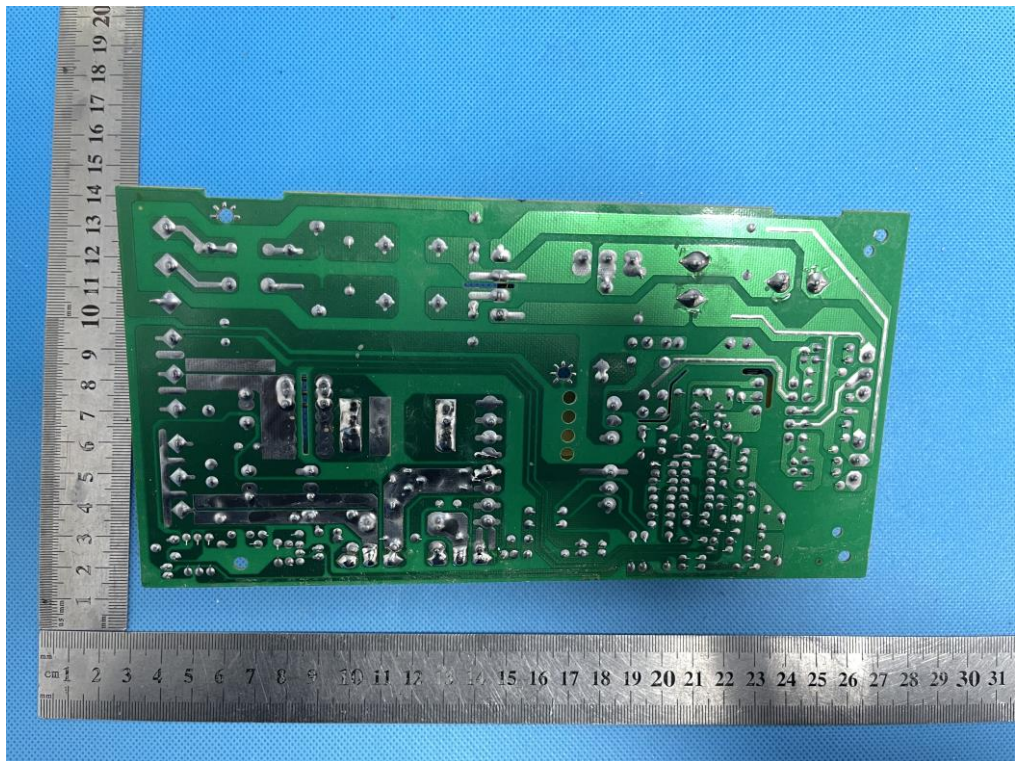

INTERNAL VIEW OF INTERNAL POWER SUPPLY (FIGURE 1)

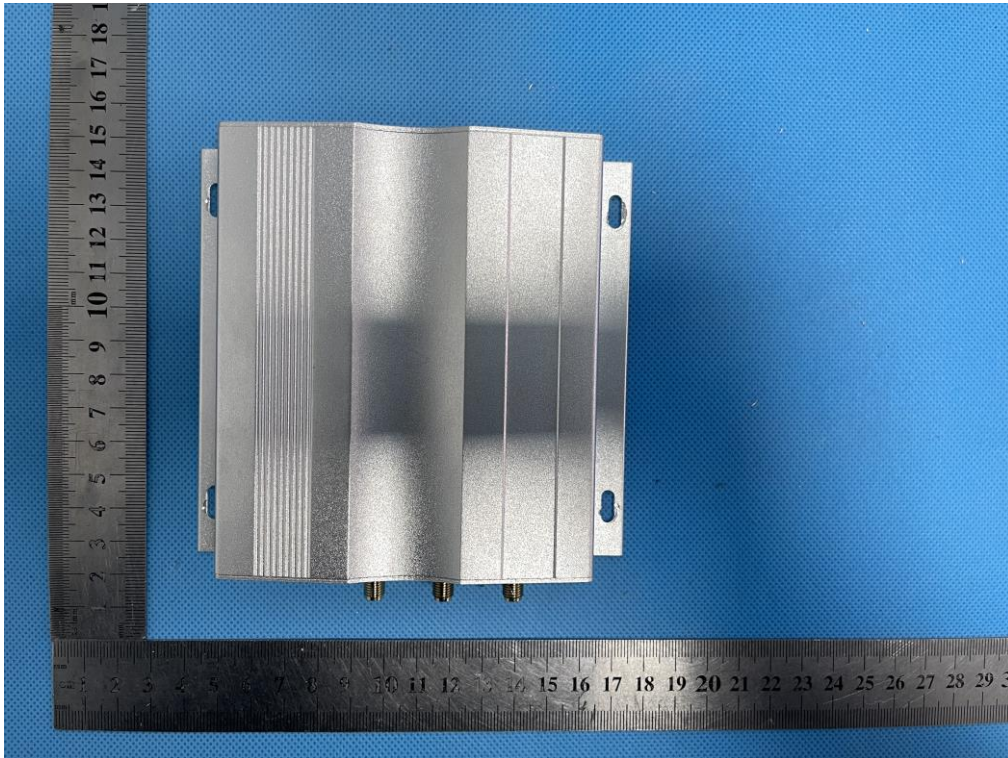


INTERNAL VIEW OF INTERNAL POWER SUPPLY (FIGURE 2)

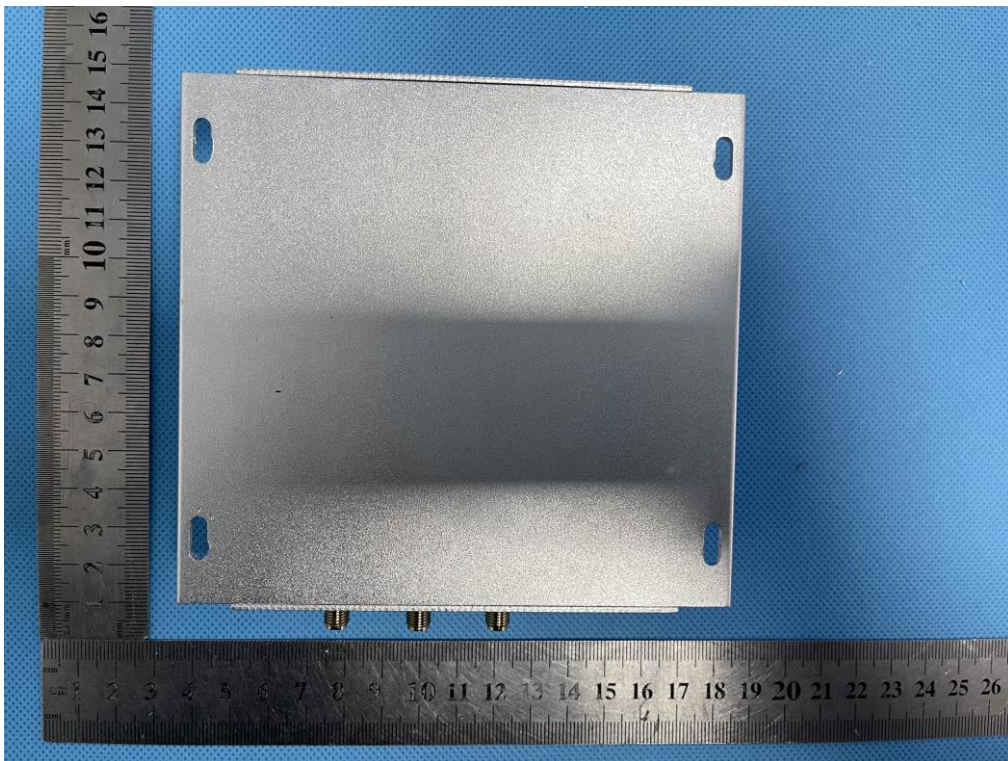

## BOTTOM VIEW OF INTERNAL DIGITAL INTEGRATED MODULE BOX

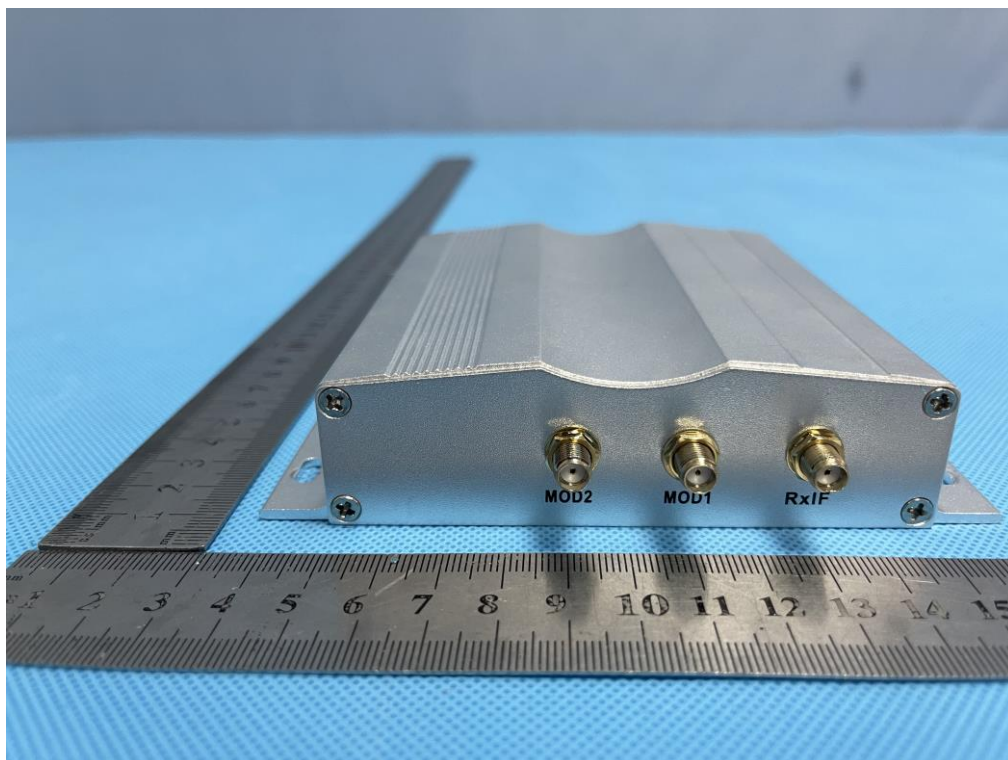

FRONT VIEW OF INTERNAL DIGITAL INTEGRATED MODULE BOX

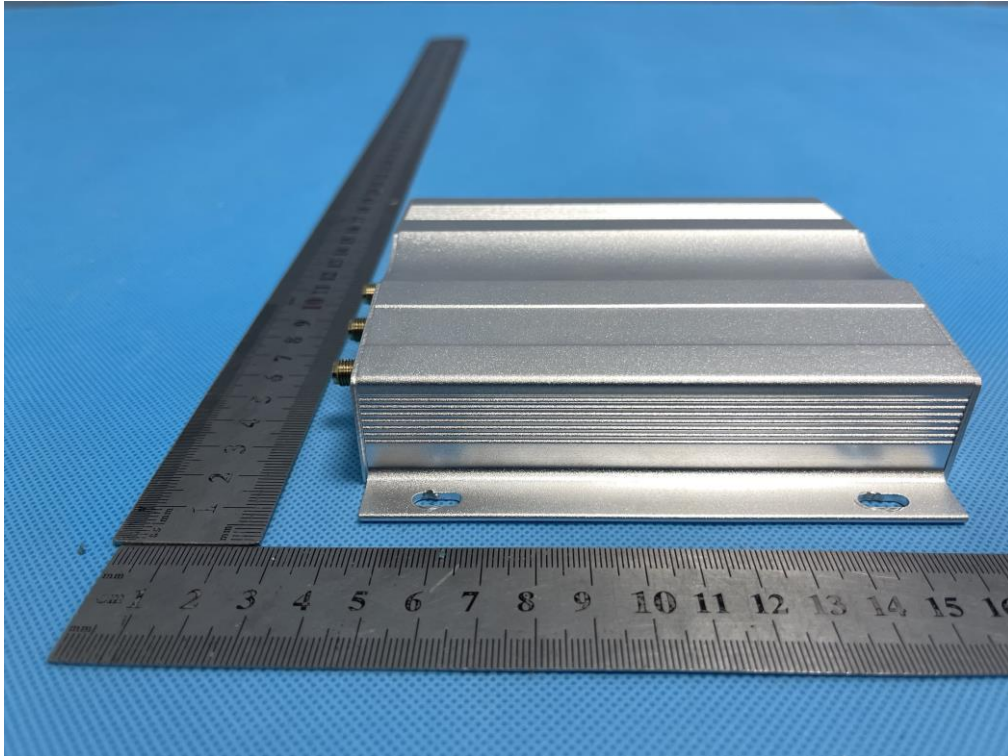


BACK VIEW OF INTERNAL DIGITAL INTEGRATED MODULE BOX

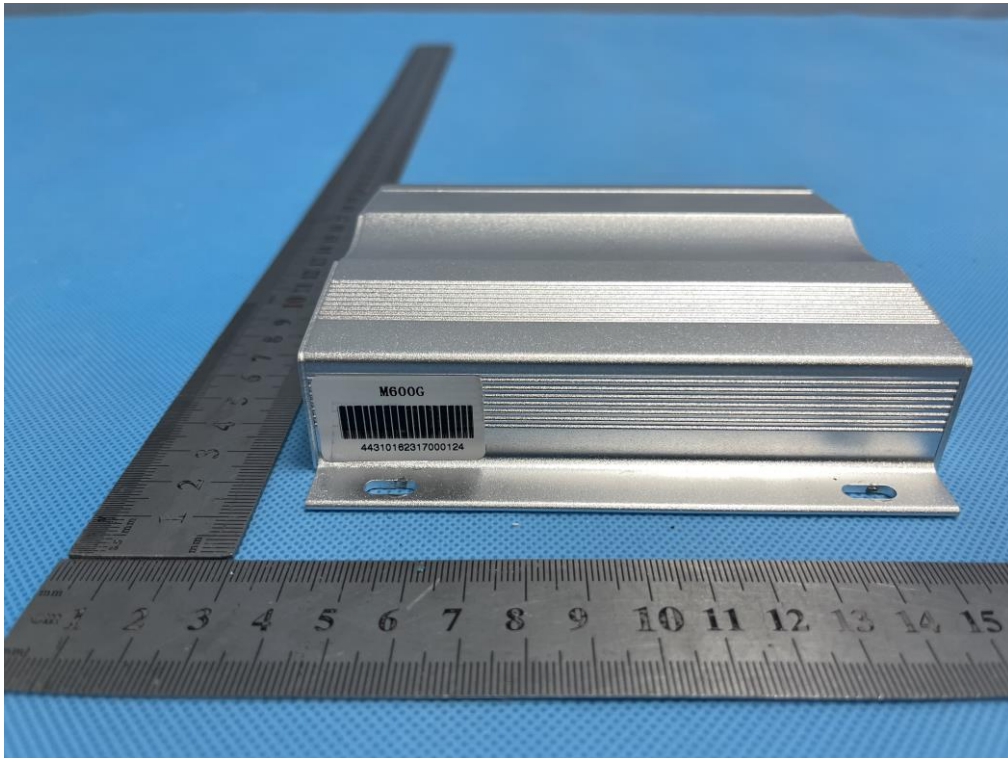

LEFT VIEW OF INTERNAL DIGITAL INTEGRATED MODULE BOX

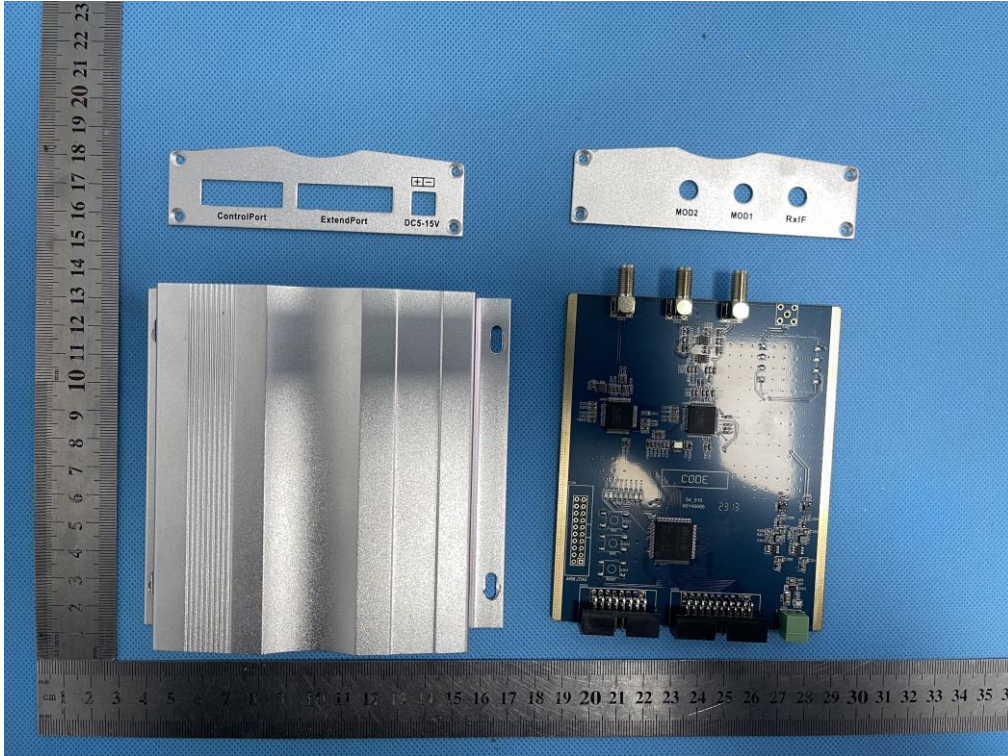


RIGHT VIEW OF INTERNAL DIGITAL INTEGRATED MODULE BOX

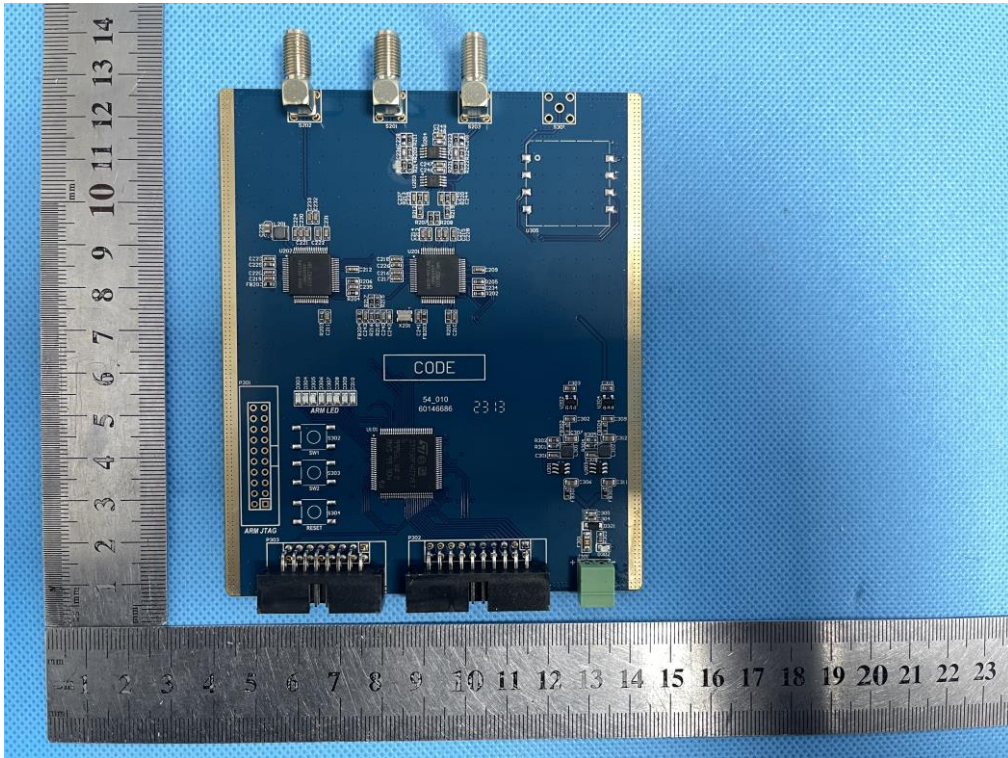

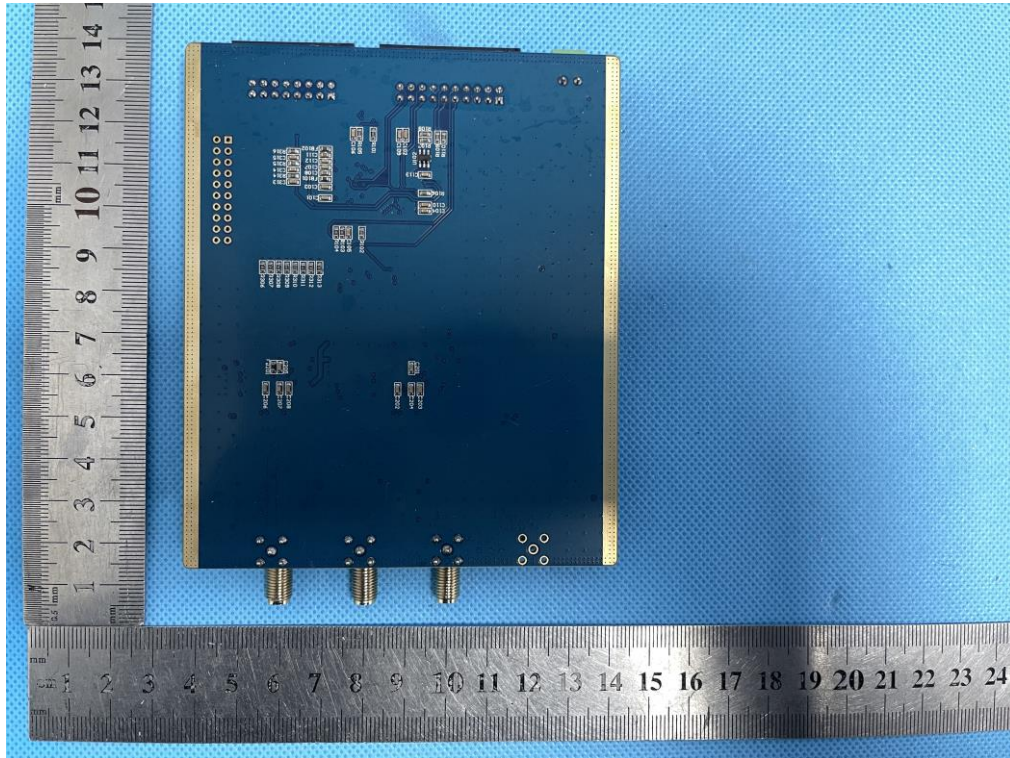


INTERNAL VIEW OF INTERNAL DIGITAL INTEGRATED MODULE BOX (FIGURE 1)

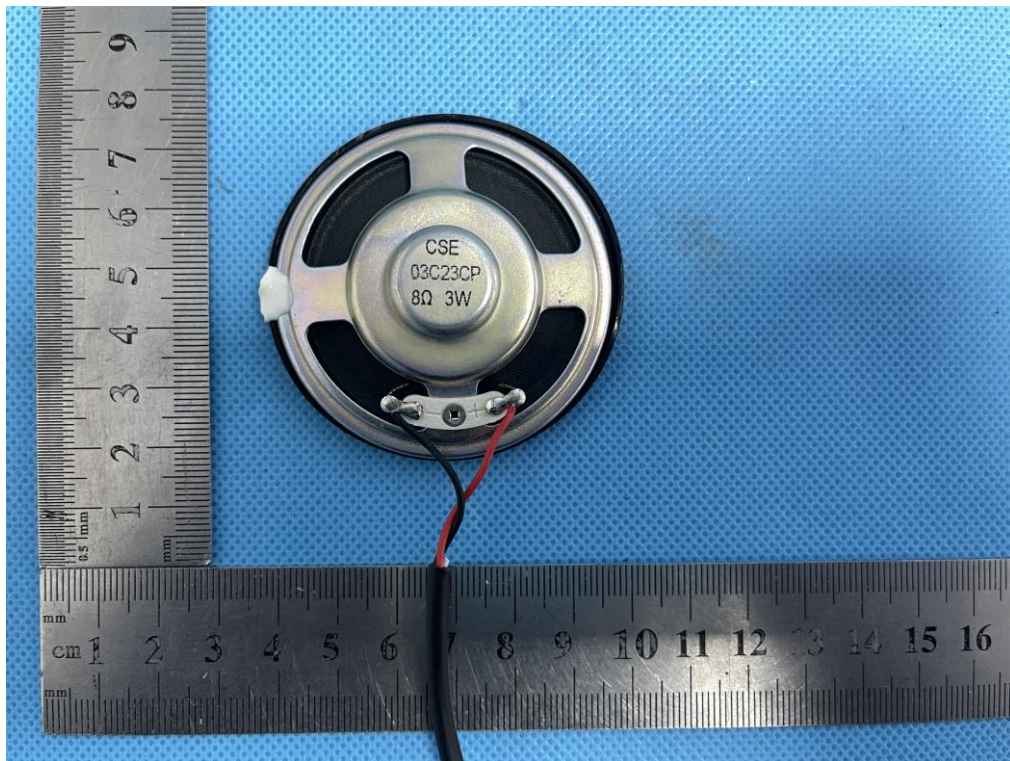

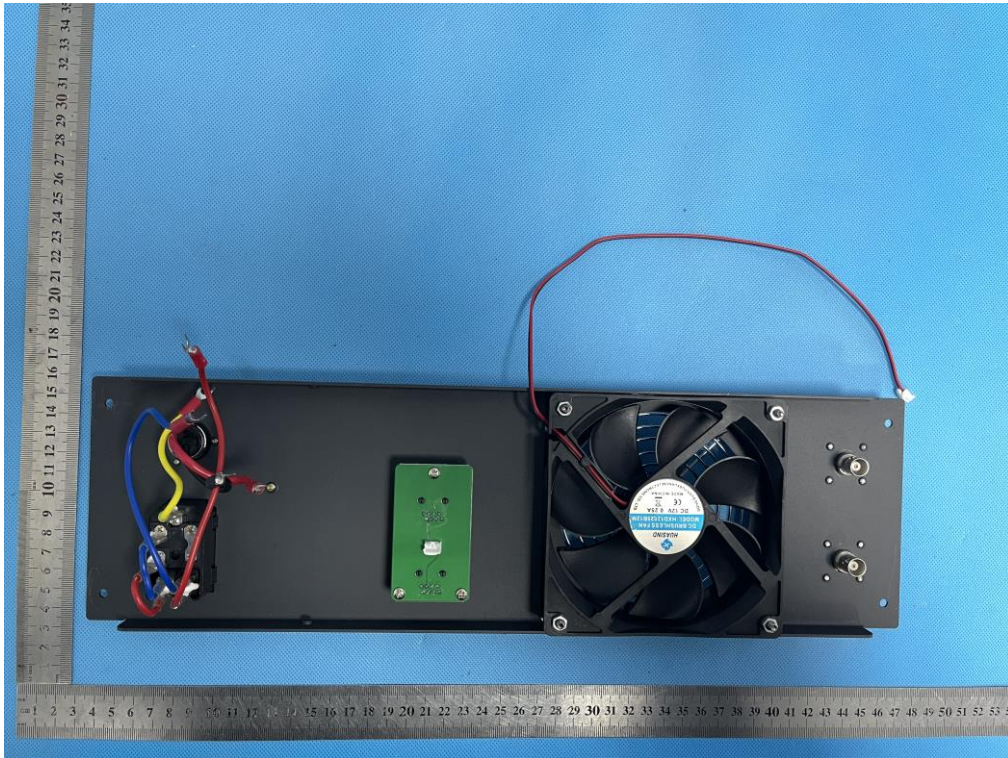

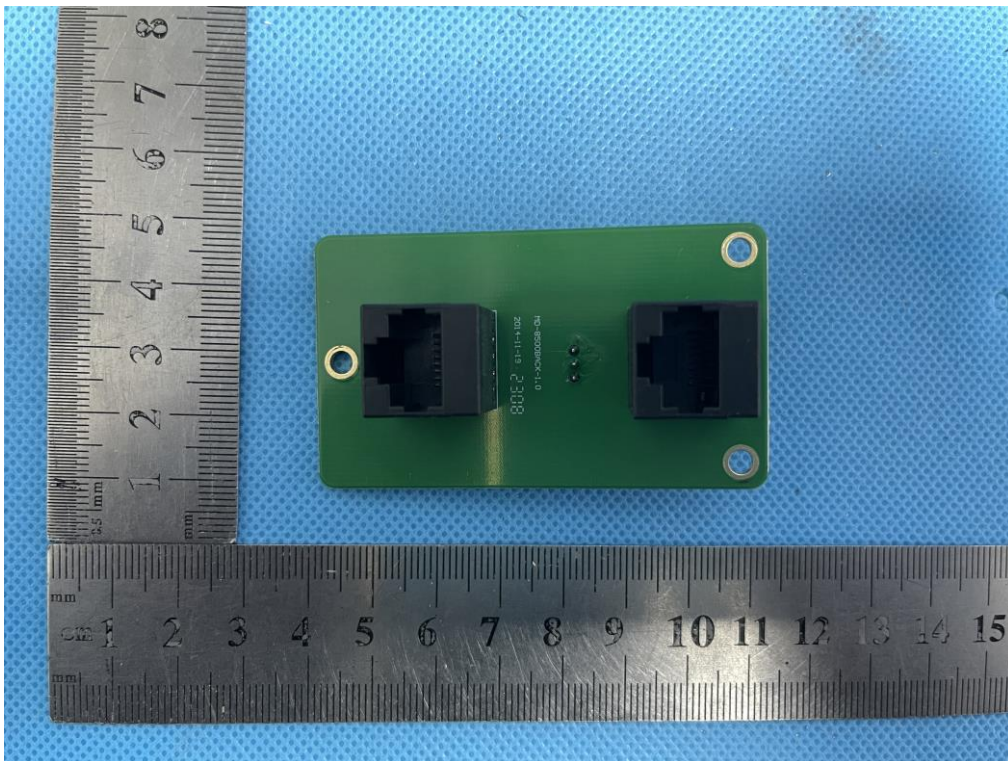

INTERNAL VIEW OF CLOSE-UP OF NETWORK WRITING PORT AND COOLING FAN

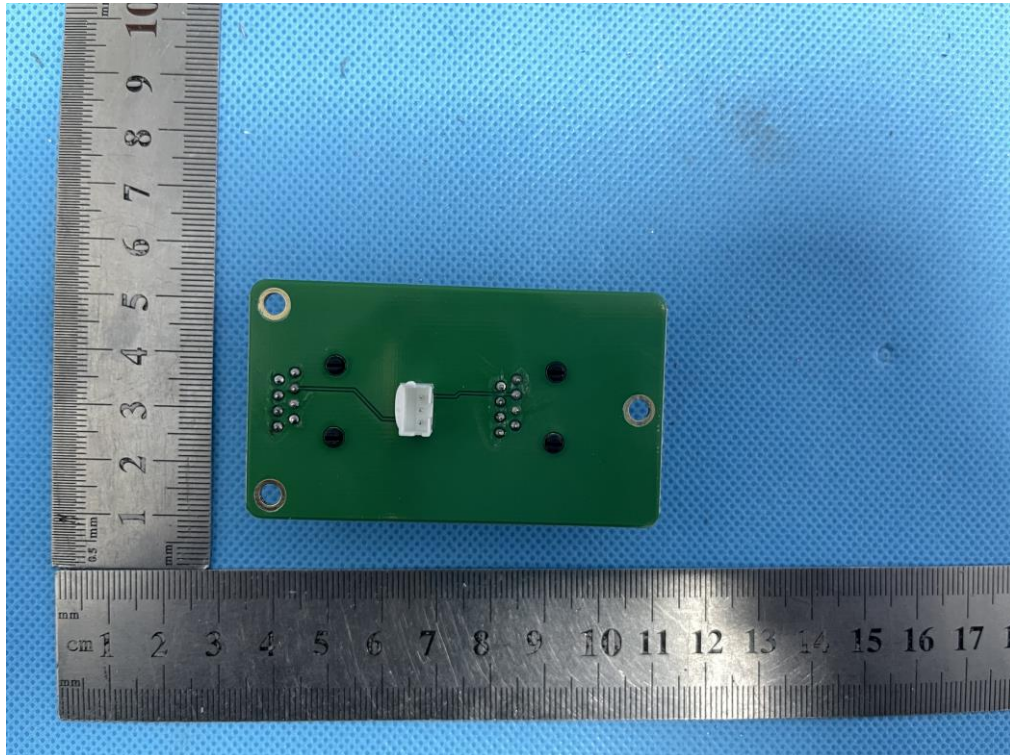

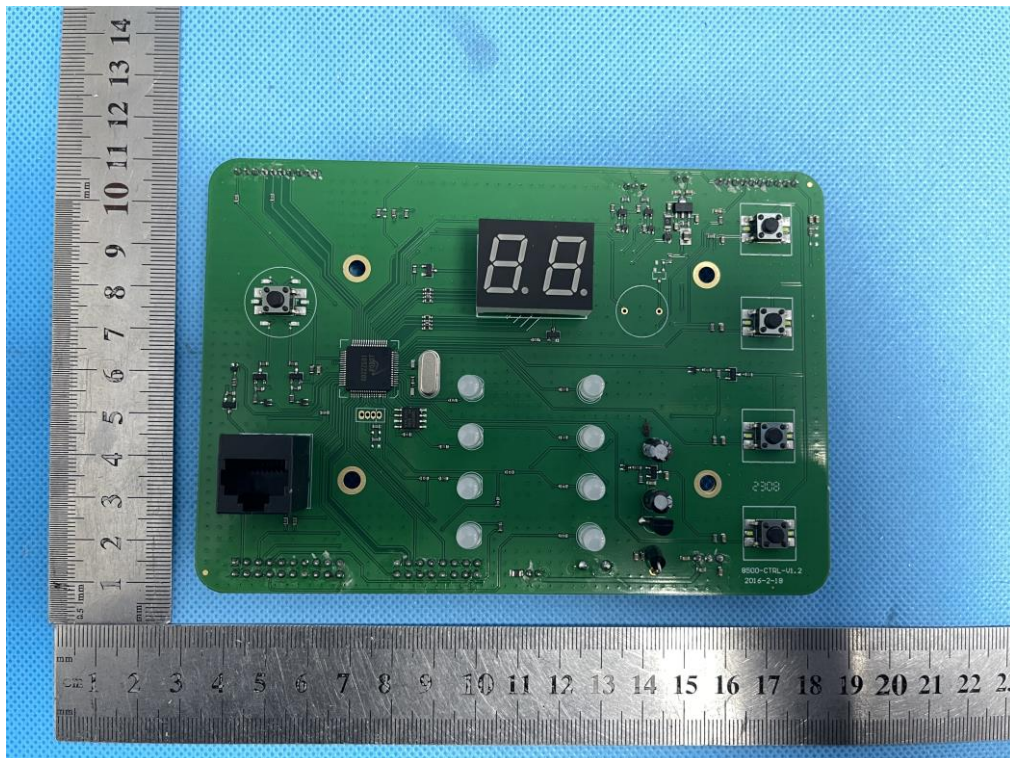

INTERNAL VIEW OF NETWORK WRITING PORT (FIGURE 2)

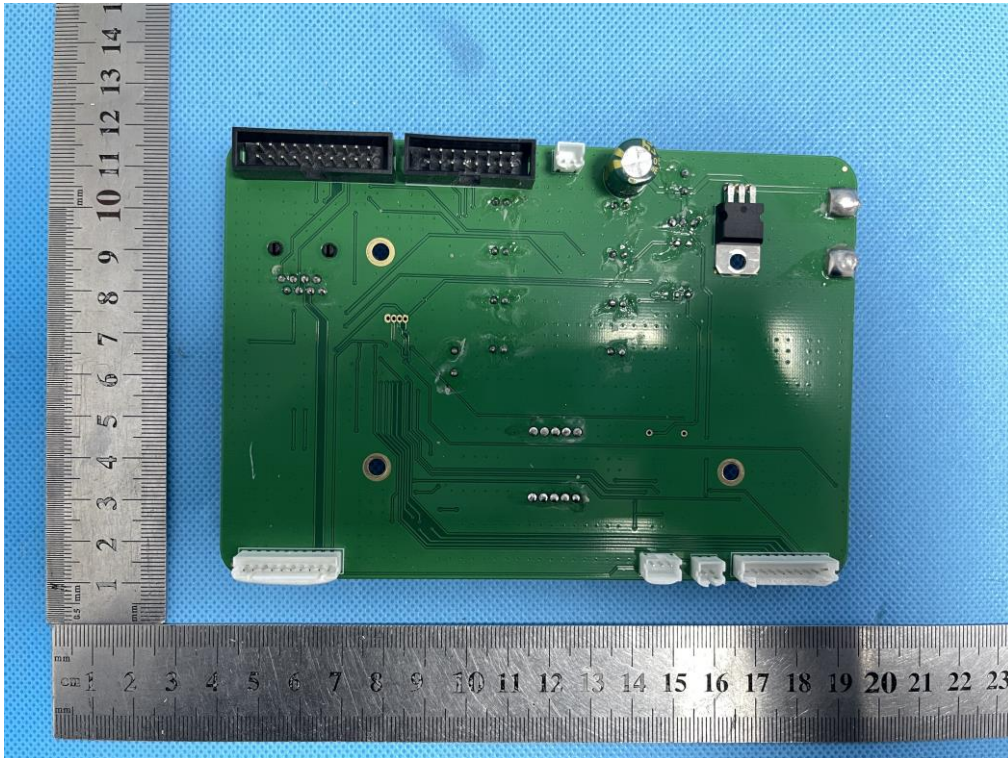


INTERNAL VIEW OF EUT CONTROL PANEL (FIGURE 1)
